1. Review and Recommendation on the Fiscal Year 2016 Audit – Carey Fry and Gene Garrelts, HSMC Orizon:

Gene Garrelts with HSMC Orizon provided a summary of the District's Fiscal Year 2016 audit. Gene mentioned that no audit adjustments were made, which is a testament to how well the District's accounting department operates.

Conley that the FEL Subcommittee recommend to the Board of Directors that the FY2016 Audit Report, prepared by HSMC Orizon, LLC, be accepted and that the General Manager be directed to file an authenticated copy of the audit report with the Nebraska Auditor of Public Accounts and the Nebraska Natural Resources Commission.

2. Review and Recommendation on the West Branch Channel Project, Ashford Hollow (SID 238) Trail Easement Agreement – Martin Cleveland:

Martin Cleveland discussed that Ashford Hollow (SID 238) had approached the District about obtaining an easement on the District's West Branch Project property for the proposed Ashford Hollow Trail. He explained that he had been informed earlier in the day that the agreement would now be with Sarpy County and not with SID 238. Due to right-of-way constraints, the trail would need to be built on District property.

• It was moved by Director J. Conley and seconded by Director F. Conley that the Subcommittee recommend to the Board that the General Manager be authorized to execute the proposed Easement Agreement with Sarpy County for the construction of Ashford Hollow Trail on West Branch Levee/Channel Project right-of-way near 42nd Street, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.

3. Review and Recommendation on Account Over 110% Maintenance, Dams – Attorney Fees (01-03-590-4392) [Executive Session – if needed] - Martin Cleveland:

Martin Cleveland provided a brief summary on the attorney fees spent in FY 2017 related to the litigation involving John Camden and the Papio Creek Watershed Structure W-3. He explained that he anticipates the budget account going over 110% in December and that preparation for the trial in January could result in additional attorney's fees in excess of \$46,000.

Director John Conley made a friendly amendment to the motion to add the language "not to exceed \$100,000" without further action from the Board.

• It was moved by Director F. Conley and seconded by Director Woodle that the Subcommittee recommend to the Board of Directors that Account # 01-03-590-4392 (Maintenance, Dams – Attorney Fees) be allowed to exceed 110% of the Fiscal Year 2017 budgeted amount, not to exceed \$100,000 unless approved by the Board.
