Re: Review and Recommendation of Amendment to WP6 and WP7 Professional Services

Contract with FYRA Engineering

In April 2015, the Board approved the selection of FYRA Engineering for professional services for the planning, permitting, design and construction of West Papillion Regional Basins Number 6 and 7 (WP6 and WP7). In November 2015, the Board approved an amendment to the contract to include Phase 2 of the design. One of those tasks was the development of a Water Sustainability Fund (WSF) application with a fee of \$59,380.00.

The development of the application was a significant effort and was initially denied in early 2016, another application was submitted in July 2016, which was approved for about \$6.7 million. The second application required additional information and scope. The current fee spent to date by FYRA Engineering for the WSF application is \$97,671.25. It was thought that the not to exceed fee for the contract might be able to absorb those costs however, as the second phase is wrapping up, it is necessary to request an amendment for the additional WSF work. The proposed amendment is requesting \$38,291.

The amendment is attached for consideration along with a map of the projects.

Management recommends that the Subcommittee recommend to the Board that the General Manager be authorized to execute the proposed Amendment 2 to the Professional Services Agreement between the District and FYRA Engineering for final design services for the WP6 and WP7 projects, in an amount of \$38,291, bringing the total maximum not to exceed contract amount to \$1,521,855, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.




Figure 1. WP-6&7 Location Map
