1. Review and Recommendation on Resolutions to be considered at the 2017 NARD Annual Conference, John Winkler:

The General Manager briefed the Subcommittee on the resolutions being voted on at the 2017 NARD Annual Conference.

NARD Resolution 2017-1: Natural Disaster Assistance Funding Through NEMA. Submitted by Little Blue NRD. Recommendation that the Nebraska Association of Resource Districts seek changes in the "State of Nebraska's Guidelines for Public Officials" regarding public disaster declarations that provide that Improvement Project Areas which have been established by Natural Resources Districts for the public good, and for which no public tax money is being invested for the construction, operation, maintenance and management of such project, shall be eligible for

reimbursement of a portion of the repair costs from NEMA when such projects are damaged by natural disasters and meet all other eligibility requirements.
