

In April 2016, you indicated you were interested in the Papio-Missouri River Natural Resources District's ("NRD") buyout program of houses in the floodplain. The NRD and the Village of Arlington applied for grant funding from The Federal Emergency Management Agency (FEMA). FEMA has approved the NRD's grant application. This program is a totally voluntary program based on a willing seller and willing buyer basis; no properties will be condemned or acquired through eminent domain.

The NRD is writing to notify you that a public hearing will be held on October 12, 2017 at 7 pm at the NRD's office located at 8901 South 154th Street in Omaha, Nebraska. The purpose of this hearing is to inform the public that the NRD may be purchasing real property.

At the hearing, the NRD shall explain the nature of the project and the right of each owner of property to be represented by an attorney and to negotiate and accept or reject the purchase offer.

For purposes of the Arlington Buyout Project (hereinafter referred to as the "Project"), the NRD proposes to acquire certain real estate in Section 12 Township 17 North Range 11 East of the 6th P.M., Washington County, Nebraska, which you may own or in which you may have an interest (such real estate hereinafter being referred to collectively as "the Property").






Exhibit 4
