MANAGERS REPORT:

Lance Olerich gave the Manager's report. Lance and Bill have been performing regular maintenance for the month.

On January 22nd, during the snow storm, the electicity went out at the Booster Pump Station and Standpipe. A Power Generator was rented and used for one day. Cold weather during the last month caused the water in the Standpipe to freeze. The Standpipe was slowly drained while more water was pumped into the Standpipe to keep the water moving.

There was discussion on Dakota City's plans to raise their customer's water rates in the near future.

Olsson's Associates is doing a model of the water system for future projects/line extensions.
