A. INFORMATION/EDUCATION HIGHLIGHTS:

- 1. We welcomed back Kaylyn Kelley from maternity leave in October. She and Austen presented to more than 500 students at area schools and a variety of events such as Conservation Days, STEAM night, and "Monster Masquerade" at the Omaha Children's Museum.
- 2. We will soon have a new Papio NRD branded educational video about dams why we build them and why they are important. Stay tuned.

B. PERSONNEL/MISCELLANEOUS ITEMS:

- 1. <u>Blueprint Nebraska</u>: On May 11, leaders in Nebraska business, agriculture, government and higher education launched "Blueprint Nebraska," a citizen-led, statewide economic development initiative. The effort seeks to establish a comprehensive and pro-active plan to stimulate the state's economic growth, competitiveness, and prosperity while building on its many strengths. I have been appointed to the Energy and Natural Resources Industry Committee for Blueprint Nebraska. It is a committee that will try to capture energy and natural resources issues for the Blueprint Nebraska effort.
- 2. Nebraska Preparedness Partnership: In addition, I have been appointed to the Nebraska Preparedness Partnership (NPP) steering committee. NPP is a coalition of the state's business and government leaders who share a commitment to strengthen the capacity of the state to prepare for, respond to, and recover from disasters through public-private collaboration. Created in 2014 by Nebraska businesses and representatives from key state agencies, the Partnership empowers businesses to integrate business resources, expertise, and plans with those of government during all stages of disaster management.
- 3. <u>APWA Awards:</u> Congratulations to Zach Nelson and the Papio NRD for being selected as award recipients by the American Public Works Association. Yesterday, Zach received the Young Leader of the Year Award and the Papio NRD received a project award for Flanagan Lake under the category of "Environmental, over \$2.5 million."
- 4. The District received a thank you note from the Leadership Washington County Class for Terry and his team's informative presentation about the Papio NRD and for allowing the group to "borrow" Justin as coordinator each month.

Meeting Minutes October 25, 2018 - 10:00 AM - Board Room Natural Resource Center, 8901 S 154th Street, Omaha, NE

Purpose

A meeting of the Partnership was held on the above date in order to discuss topics stated in the attached agenda. The meeting began at 10:05 am.

1. Introductions

An agenda and handouts were distributed. Marlin Petermann facilitated introductions.

2. MS4 Stormwater Management Plan Update

- Lori Laster reviewed the Year 1 requirements in the Stormwater Management Plan (SWMP). The SWMP for small MS4 communities was approved on June 29, 2018 so these items must be completed by then.
- The NRD and the City of Omaha will work to draft templates for use by all communities for most of the elements.
- Most of the items are currently being implemented although there have not been formal plans or standard operating procedures adopted.
- A new permit requirement is to inspect certified post-construction stormwater BMPs. Each community will need to determine how these inspections will be completed in their jurisdiction.
- Subcommittee meetings will be scheduled to review the document templates in detail.

3. PCWP Interlocal Agreement

- · Lori Laster gave an update on the progress of updating the Watershed Management Plan. HDR received the population projection and land use data from MAPA this week and is beginning to analyze that data. They will have a report on that analysis at the next meeting.
- The NRD received a letter co-signed by John Kottmann (La Vista), Jeff Thompson (Papillion), and Pat Dowse (Sarpy County) stating a request to consider delaying the adoption of a new interlocal agreement, including updated to the stormwater policies and watershed fees. Due to the USACE Section 22 Stream Stabilization Study not being completed for two years, they felt that policies could be shaped better by that study. There was also concern that there is insufficient time to educated stakeholders and elected officials about the new policies that may be adopted.

















- Marlin Petermann stated that some sort of amendment to the existing interlocal agreement would be necessary to address extending the collection of watershed fees, the implementation plan, and the new stormwater management plan.
- The group discussed other pros and cons of delaying adoption of a full new interlocal agreement.
- The updated language for the stream setback policy will be circulated prior to the next
 meeting to determine if the changes to the policies will be significant enough to delay
 adoption of a new interlocal agreement or if the current agreement should be amended to
 include two more years.

8. Next Meeting Date

The next Partnership Meeting will be held November 29, 2018.

9. Adjourn
