SUBJECT: Review and Recommendation of Bids Received for Platte River Landing

Site Restoration

DATE: July 2, 2019

On July 2nd, bids were opened for the construction of the Platte River Landing Site Restoration project. A copy of the bid tabulation is attached along with the recommendation letter from Big Muddy Workshop.

The Platte River Landing Site Restoration project is located off Highway 64 along the Platte River in Douglas County (see attached map). The project consists of cleanup work to restore the park to its condition prior to the March 2019 flooding. The main tasks are to haul sand and debris, replace trees, trail and park features that were lost during the flood.

One (1) bid was received for \$284,604.22. The engineers estimate for the construction was \$325,506. Valley Corporation provided the low bid. The District has a work history with the contractor and can verify that they are able to construct the project according to specifications. The work is anticipated to begin as soon as possible after Board approval with substantial completion by September 2019.


Staff recommends that the Subcommittee recommend to the Board that the General Manager be authorized to execute a contract with Valley Corporation for the construction of the Platte River Landing Site Restoration for the bid amount of \$284,604.22, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.

Bids were received and opened earlier today, July 2, 2019, for the Platte River Landing Site Restoration project. Although four contractors obtained bid documents, only a single bid was submitted. This bid was provided by Valley Corporation with a Total Lump Sum Bid of \$284,604.22.
