A. <u>INFORMATION/EDUCATION HIGHLIGHTS</u>:

1. World O! Water was another success this year with more than 1,600 people attending – despite competition with a Husker game and threat of rain. It's wonderful to see so many people, especially kids, come to learn about water and why it's so important.

B. PERSONNEL/MISCELLANEOUS ITEMS:

- 1. FEMA recently approved the District's Hazard Mitigation Plan in the amount of \$150,000. Having an approved and updated HMP in place is a requirement of FEMA for communities, counties, school districts, and other groups to be eligible for pre- and post-disaster mitigation grants. These federal grants allow for up to a 75% cost share for a wide variety of projects listed in the plan.
- 2. The Nebraska Recreation and Parks Association awarded the Papio NRD with its 2019 Benefits are Endless Award for contributing to the continued success of the Great Park Pursuit. The I&E Department has hosted numerous park post locations and provided over \$30,000 of funds for the free program that offers interactive activity throughout Nebraska parks.
- **3.** Wally Juhlin, Water Supply Operator/Maintenance Technician, resigned from his position on September 19th. The District is currently in the process of filling the position.

This email serves a courtesy notification that The U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA) has granted approval for the Pre-Disaster Mitigation Competitive (PDMC) application submitted by the Papio-Missouri River Natural Resources District for the Papio-Missouri River Natural Resources District Hazard Mitigation Plan project. FEMA has released funds to the state in the amount of \$150,000.00.

Please note, that the mitigation plan update must be adopted by the jurisdiction and approved by FEMA within the award POP. The HMA Guidance states that:

Planning activities funded under HMA are designed to develop State, tribal, and local mitigation plans that meet the planning requirements outlined in 44 CFR Part 201. A mitigation planning subaward must result in a mitigation plan adopted by the jurisdictions(s) and approved by FEMA or it must result in a planning-related activity (eligible under HMGP only) approved by FEMA (e.g., incorporating new data into the risk assessment or updating the mitigation strategy to reflect current disaster recovery goals) consistent with the requirements in 44 CFR Parts 201 and 206.

A few other details regarding this award are provided below; however, please refer to the agreement articles and other award documents provided in eGrants for full details and requirements.

Period of Performance Start and End Date:

The period of performance shall be October 1, 2018 – June 19, 2022. All costs must be incurred during the period of performance, including eligible pre-award costs.

Amount Awarded:

Funds approved under this award may not be used for other purposes. If costs exceed the amount of funding that has been approved by FEMA, then the Recipient or Subrecipient shall pay the costs that are in excess of the approved budget.

Programmatic Changes & General Terms and Conditions:

The Recipient and Subrecipient must comply with all applicable laws and regulations. The Recipient and Subrecipients are bound by Title 44 of the Code of Federal Regulations (CFR) and the February 27, 2015, Unified Hazard Mitigation Assistance Guidance.

The Recipient must also comply with regulations found in Title 2 Code of Federal Regulations (CFR) Part 200, <u>Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards</u> "Super Circular" [which supersedes 44 CFR Part 13, 2 CFR Part 215, and Office of Management and Budget (OMB) Circulars A-21, A-50, A-87, A-89, A-102, A-110, A-122, and A-133 as of December 26, 2014], Title 2 CFR Part 170, Reporting Subaward and Executive Compensation – Appendix A to Part 170 – Award Term (see ARTICLE VII. TERMS AND CONDITIONS), and the Hazard Mitigation Assistance Guidance to implement this Award Agreement.

A change to the approved SOW requires prior approval from FEMA. The National Environmental Policy Act (NEPA) stipulates that additions or amendments to a PDM award statement of work (SOW) shall be reviewed by all state and federal agencies participating in the NEPA process. NEPA sign-off for all SOW additions or amendments is essential before the revised SOW can be approved by FEMA or implemented by the PDM Subrecipient.

Reports:

Quarterly progress reports for PDMC projects are required. Please include this PDMC project in your future eGrants quarterly reports.

Closeout:

Per 2 CFR Part 200, when the appropriate grant award performance period expires, the Recipient shall submit the following documents within 90 days: (1) a final Financial Report; (2) final Program Performance Report; (3) an inventory of equipment purchased under each grant's funds; (4) an inventory of Federally-owned property; and (5) other required documents specified by program regulation.



Meeting Minutes September 29, 2019 – 10:00 AM – Board Room Natural Resource Center, 8901 S 154th Street, Omaha, NE

The meeting began at 10:01 am.

1. Introductions

 An agenda and handouts were distributed. Marlin Petermann (P-MRNRD) facilitated introductions.

2. February 2020 Sediment and Erosion Control Seminar - Notice of Vote

- Lori Laster explained that the annual Sediment and Erosion Control Seminar is used to meet
 MS4 permit requirements for education and outreach. This seminar has been well attended
 by both design professionals and contractors. The City of Omaha has previously used
 stormwater grant funds to cover the costs of the venue and refreshments. Those funds are
 no longer available and additional funding must be secured.
- Last year's seminar cost was near \$15,000. The planning committee is researching options for a lower-cost venue. The anticipated cost of this year's seminar is around \$6,000.
- Because the MS4 communities are able to use this seminar to comply with the adopted stormwater management plan, the Partnership Fund could be used to cover some of the cost.
- The Partnership Fund balance is approximately \$60,000.
- At the October 24, 2019 meeting the Partnership members will vote on contributing \$2,000 towards the cost of the seminar.

3. MS4 Annual Report

- Lori Laster explained that the MS4 permit for the small communities was effective July 1, 2018. The annual reports to NDEE are based on calendar year. Because the permit year and the reporting year do not align, the annual report sent in April 2019 stated that several permit year 1 activities had not been completed as of the end of calendar year 2018.
- Andy Szatko stated that Omaha is developing the templates for the standard operating
 procedures for the items that required them. Once complete, the templates will be shared
 with all members.

4. Other Items of Interest

















Amanda Grint reviewed a meeting with USACE and local floodplain managers. The P-MRNRD is working with USACE on a study of flood risk in the Papillion Creek Watershed. As part of the study, public meetings were held and the public was invited to submit comments. USACE must address any comments submitted. The meeting was to determine what local floodplain regulations are in place and how they are enforced. USACE will be providing an update at the Partnership meeting in October.

5. Next Meeting Date

The next Partnership Meeting will be held October 24, 2019.
