## **RESOLUTION & VOTING PROCEDURES**

- 1. Each NARD member district that is in good standing shall be able to submit resolutions for consideration by the Association membership on policy issues pertinent to the mission and goals of the Association. A majority of the 23 districts shall constitute a quorum.
- 2. Each NARD member district that is in good standing shall have five votes providing a total of 115 votes for all 23 members.
- 3. The voting delegate for the member district, or the alternate in the case of the delegate's absence, shall be the only individual to make the motion on behalf of their respective district. Any district representative may speak on the merits of a motion or issue during the discussion period once recognized by the chair.
- 4. We encourage more information on the issues. However, a non-voting participant may only speak on an issue and/or provide additional information at the request of a voting delegate of a district in good standing or at the request of the chair.
- 5. A copy of all resolutions submitted to the NARD Office prior to the Annual Meeting is included in the Resolutions Packet. Resolutions received by the deadline require a majority of all the membership votes, not the quorum, (58 or great of 115 votes) to be approved.
- 6. After resolutions submitted by the deadline have been voted on, additional resolutions may be submitted for consideration at the Annual Conference for discussion provided that:
  - a) The member district is responsible for providing enough copies so members may read the resolution before discussion begins.
  - b) If 2/3 of all the membership votes, not the quorum, approve the Motion to place the resolution before the body, the resolution shall be added to the agenda for consideration (example: 2/3rds of 115 = 77). If 2/3 vote is secured, a second vote is required and must follow the majority provisions in #5 to be approved
- To help avoid any distractions during the Business Session, all cell phones must be silenced during the session. Anyone whose cell phone rings during the Business Session will be fined \$5 for each occurrence and proceeds will be contributed to the NARD Foundation Account. Contributions to the NARD Foundation are tax deductible.

# NARD Resolution 2020-1

#### Extreme Weather Event or Climate Change Action Plan Submitted by the Lower Platte South NRD

WHEREAS, the Nebraska Legislature considered LB283 in the One Hundred Sixth Legislature which provided for a state action plan to address changes in climate, and the bill ran out of the allotted time for consideration; and

WHEREAS, the Executive Board of the Nebraska Legislature advanced LB283 from the committee on a 6-2-1 vote and proposed a committee amendment (AM2481) setting forth Legislative Findings as follows:

(1) Pests, drought, floods, high winds, and other extreme weather events present serious, diverse, and ongoing issues for Nebraska. Many sectors and resources are impacted by such extreme weather, including agriculture, water, health care, energy generation and usage, ecosystems, forestry, rural and urban communities, transportation, and commerce and industry. Nebraska's life-giving water and soil resources continue to be subject to new stressors and risks;

(2) Opportunities exist for the people of Nebraska to respond appropriately to these risks, including economic opportunities through development of renewable energy from our abundant wind and solar resources, biofuels, and nuclear power, through reduction of pollutants, through efforts to reduce the use of fossil fuels, through strengthened private property rights by having public input on infrastructure and reduced eminent domain use, and through development of new technologies, new agricultural crops and harvesting methods, and new products that match Nebraska's vibrant and changing needs and resources;

(3) The report Understanding and Assessing Climate Change: Implications for Nebraska, University of Nebraska-Lincoln, 2014, provides a fundamental basis for understanding the impacts of extreme weather events or climate change for our state;

(4) The 2015 Nebraska Rural Poll found that sixty-one percent of rural Nebraskans agree or strongly agree that the state should develop a plan to address the impacts of extreme weather events or climate change;

(5) Appropriate planning is needed to develop strategies to mitigate and adapt to the impacts of extreme weather events or climate change on the health and well-being of Nebraskans;

(6) The state must invest in research and data gathering, planning, education, and coordination of efforts related to mitigation of and adaptation to the impacts of extreme weather events or climate change; and

Revised Resolution Deadline Version – August 21, 2020 Memo (7) An effective plan to meet the challenges of extreme weather events or climate change will enable the state and its communities to take advantage of opportunities resulting from adaptation and mitigation strategies, including attracting new businesses and investment to Nebraska, as well as reducing the potential negative impacts of extreme weather events or climate change; and

WHEREAS, these findings reference a report Understanding and Assessing Climate Change: Implications for Nebraska, which further details very significant implications for Nebraska's (1) water resources, (2) energy supply and use, (3) agriculture, (4) forestry, (5) human health, (6) ecosystems, (7) urban systems, infrastructure, and vulnerability, (8) rural communities, and (9) insurance industry;

NOW THEREFORE, BE IT RESOLVED, that the Nebraska Association of Resources Districts supports legislation for the development of an evidence-based, data-driven, strategic action plan to provide methods for adapting to and mitigating the impacts of extreme weather events or climate change.

BE IT FURTHER RESOLVED that NARD will work with the Unicameral and other interested parties in developing the amount of funding required, the source of funding, and the entity that would develop the action plan.
