SUBJECT: Big Papio Levee Culverts Project Phase 2

Amendment No. 2 to Professional Services Agreement with FYRA Engineering, LLC

DATE: February 4, 2021

In September 2017, a professional services contract was approved with FYRA Engineering, LLC for the Big Papio Levee Culverts Project Phase 2 which included preliminary and final design, US Army Corps of Engineers [USACE] Sections 404 and 408 permitting, bidding assistance and construction contract services for rehabilitation of 16 aging culverts of the referenced project for a not-to-exceed amount of \$360,085.

In October 2020, Professional Services Agreement Amendment No. 1 was signed, and it consisted of an Agreement scope change to allow for the addition of design services for culvert BP-L30 and additional design and construction observation services related to the changes in 13 of the culverts and site conditions (such as the Spring 2019 flood) since commencement of design. Many of the culverts had deteriorated since the commencement of the design and required additional design effort. Amendment No. 1 added \$34,693 to the original agreement total of \$360,085, resulting in a revised not-to-exceed amount of \$394,778.

The proposed Agreement Amendment No. 2, which is attached, consists of an Agreement scope change to allow for additional coordination with City of Omaha, additional survey work and redesign of culverts BP-L15A and B, because of incorrect City of Omaha sanitary sewer as-builts and poor subgrade conditions. The sanitary sewer is in close proximity above the culverts at the site. Amendment No. 2 is estimated to cost \$19,554.75 and results in the revised total not-to-exceed amount to \$414,332.75. The project is nearing completion and should be done in spring 2021, weather permitting.

Management recommends that the Programs, Projects and Operations Subcommittee recommend to the Board of Directors that the General Manager be authorized to execute the proposed Amendment No. 2 to Professional Services Agreement with FYRA Engineering, LLC in the amount of \$19,554.75 for the Big Papio Levee Culverts Project Phase 2, bringing the total not-to-exceed amount to \$414,332.75, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.


