1. <u>Review and Recommendation of Professional Services Contract Agreement with Ehrhart</u> <u>Griffin & Associates for the Beltline Trail Project – Eric Williams:</u>

Natural Resources Planner Eric Williams and Daniel Dolezal, Ehrhart Griffin & Associated reviewed the proposed agreement for professional services necessary to plan, design, and administer construction for the

Beltline Trail Project that runs from approximately Hamilton Street at Military Avenue to the Metro Transit station north of John A. Creighton Boulevard at Sprague Street for a maximum fee of \$282,155. Eric indicated that the project would construct a multi-use trail along a former railroad corridor, with access points to provide connection to existing locations in the adjacent community, and consideration of future connections. Eric and Daniel addressed Directors questions.
