1. Review and Recommendation on Storm Sewer Easements to North Shore 2 at Portal Recreation Area – Amanda Grint:

Project Manager Amanda Grint briefed the Directors on a request for three permanent storm sewer easements by SID 341 near the District's completed Portal Recreation Area. Amanda stated that any disturbance, such as fence or seeding, will be restored by the SID as stated in the easement documents. Amanda answered Director's questions.

• It was moved by Director Bradley and seconded by Director Begley that the Subcommittee recommend to the Board that the General Manager be authorized to execute the proposed Permanent Storm Sewer and Drainage Easements at Portal Recreation Area to the North

Shore 2 SID 341, Sarpy County, Nebraska, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.

2. Review and Recommendation on Elk/Pigeon Creek Drainage Project - Land Rights (01-04-4430-360) Account over 110% – Justin Novak:

Project Manager Justin Novak reviewed the Elk/Pigeon Creek Drainage Project-Land Rights Account (01-04-4430-360). He stated that the District had approved two purchase agreements for land rights in May 2021 that were budgeted for and expected to close in FY 2021. Justin told the Directors that the title company ran into delays and the land purchases were not completed until July 2021 causing the District to be 202% over the budgeted amount in FY 22. Justin answered Directors questions.

• It was moved by Director Bradley and seconded by Director Davidson that the Subcommittee recommend to the Board that Account (01-04-4430-360) Elk/Pigeon Creek Drainage Project-Land Rights be allowed to exceed 110% of the budgeted amount up to a maximum of \$151,938.21.
