Winter is a perfect time to plan for Spring tree planting, windbreak renovations, or general tree maintenance on your property. There are programs for cost-assistance through the Papio-Missouri River Natural Resources District and the Nebraska Forest Service!

Nebraska Forest Service Wildland Urban Interface Program (WUI)

The WUI program provides cost-share funding to landowners to create fuel breaks, fire breaks, remove hazardous fuels, reduce fire fuel loads, and reduce the overall risk of wildfire burning in woodlands. Hazardous fuel is any debris, deadfall, or overstocked trees that may be in your forest or around your home. Overstocked Eastern Red Cedar is the primary hazardous fuel in the Eastern part of Nebraska.

Removing hazardous fuels means to reduce the amount of vegetation which has built up to dangerous levels or change the arrangement of these fuels in the environment. This will reduce the probability of a catastrophic fire while maintaining, or restoring, a healthy and resilient forest and protecting communities.

Tools that are used to carry out the mechanical treatment of hazardous fuels range from hand tools such as chainsaws and rakes, to large machines such as bulldozers and woodchippers. Trees can be cut/piled/burned; chipped/mulched; or removed off-site for utilization of lumber, shavings, posts, etc. Cost-share can cover up to 75% for qualifying project work. Conservation Tree Program Order Forms Available!

Through the Conservation Tree Program, landowners purchase bare-root tree or shrub seedlings from the NRD in bundles of 25 per species. Bundles cost \$24 each which makes the price of each tree less than a dollar after tax!

"Celebrate Trees" Grant Application Period Open



A previous Celebrate Trees recipient. Applicants should plan to perform mulching, staking and watering to ensure a successful planting.

Applications are currently being accepted for the 2022 Celebrate Trees Grant Program! This grant encourages and assists communities with tree planting projects in public areas such as: parks, cemeteries, schools, etc. Each contract is awarded up to \$2,500 with a maximum of \$250/tree.

Applicants are funded using a ranking system that places higher emphasis on the replacement of diseased/damaged trees.
