1. <u>Amendments to the Papio NRD's 2023 Pay Program Administration Manual – John Winkler,</u> <u>Jean Tait and Ashley Thomalla, SilverStone Group LLC:</u>

Administrative Coordinator Jean Tait and Ashley Thomalla, SilverStone Group, briefed the Subcommittee on the recommended amendments to the Pay Program Administration Manual for 2023.
