## 1. <u>Account over 110%, Vehicle/Equipment – Repairs/Maintenance (#01-01-4052) – Martin</u> <u>Cleveland:</u>

Project Manager Martin Cleveland explained that Account #01-01-4052, Vehicle/Equipment - Repairs/Maintenance is used for maintenance and repairs of all District vehicles (26), construction trucks (3), construction and maintenance equipment (33 self-propelled items), and numerous other items including trailers, generators, welders, sprayers, pull mowers, etc. Martin stated that during FY 24, the Anticipated Account Status with April payments would be \$242,000, which is 110% over the budgeted amount of \$220,000 for Account #01-01-4052. Bill Warren, O&M Superintendent, reported on the increased cost of repair parts, labor, and several large cost unanticipated repairs to dump trucks, tractors, and vehicles. Martin, Bill, and John Winkler answered Directors questions.

• It was moved by Director Bradley and seconded by Director Conley that the Subcommittee recommend to the Board that the Subcommittee recommend to the Board that Account #01-01-4052 – Vehicle/Equipment -Repairs/Maintenance be allowed to exceed 110% of the budgeted amount up to a maximum of \$290,000.00.
