The Project consists of furnishing labor, materials, and performing all necessary work to construct a Main Dam consisting of approximately 110,000 cubic yards of embankment, 2,900 tons of rock riprap, an inlet riser structure, 180 lineal feet of 48-inch diameter RCCP, and an impact stilling basin structure, and a Constructed Wetlands berm consisting of approximately 11,000 cubic yards of embankment, rock rip rap weirs, and associated seeding.
