1. <u>Contract with Houston Engineering for Big Papio and Tributaries Culverts Rehabilitation Project</u> – Martin Cleveland:

Martin Cleveland reviewed the scope of work submitted by Houston to provide services necessary to design, permit, acquire temporary right-of-way to replace/rehabilitate twenty-four Little Papio Channel Culverts to meet U.S. Army Corps of Engineers requirements. The Chair inquired to the cities' share of the Professional Services Agreement and there was further discussion on the known costs for the project. Martin and Lindy Rogers, Houston Engineering addressed all questions.

• It was moved by Director McCormick and seconded by Director Conley that the Subcommittee recommend to the Board that the General Manager be authorized to execute a professional services agreement for design, permitting, right-of-way, and construction services between the Papio NRD and Houston Engineering, Inc. for the Big Papio and Tributaries Culverts Rehabilitation Project, for a not to exceed fee of \$880,769, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.
