Sealed Bids for the construction of the Pigeon Jones Creek Dam 11 Decommissioning in Dakota County, Nebraska will be received by Papio-Missouri River Natural Resources District (P-MRNRD) at the office of the Papio NRD, located at 8901 South 154th Street, Omaha, NE 68138 until 10:00 A.M. local time on Wednesday, September 25, 2024, at which time the Bids received will be publicly opened and read.

Project consists of decommissioning of a dam SW of Hubbard Nebraska. Quantities include 3,277 yd³ of excavation and earth fill, 189 feet of 96-inch CMP pipe, 303 tons of riprap, and 920 yd² of seeding. Quantities are provided for information only to describe scope of work and Contractor is responsible for verification of all quantities.
