RE: Sorensen to Girard Trail

Construction Change Order 1 with Navarro Lawn & Landscape, Inc.

The District executed a construction contract with Navarro Lawn & Landscape (NL&L) in January 2025 for work on the trail including a retaining wall, and stormwater improvements. Construction work began in January and updates to the plans are needed based on information from the site after preliminary tree clearing and site preparation was completed.

Additional trees have been identified that are large enough to be independently counted and removed according to the bid documents. Clearing of the site now allows direct access from Girard Street along the trail corridor to the maintenance and facilities buildings on the Alegent hospital campus, and separation of the trail from the hospital is needed to maintain safety and security for members of the public and hospital staff. A pile of debris was uncovered when brush was cleared and this material needs to be removed from the site to complete trail construction.

The project was bid and awarded based on a retaining wall along the south side of the trail, on the uphill side, with excavation into the existing slope. During construction meetings with FHU as the consultant, EGA as the subconsultant for construction administration, Thiele Geotech as the subconsultant for geotechnical services, NL&L as the contractor, and Linhart as the retaining wall subcontractor, it has been determined that retaining wall should be on the north side of the trail, downhill, with the trial on top of a fill section. This will provide a more stable base for the retaining wall and subgrade for the trail, and will address drainage from the new wall design.


The updated wall location will have additional fill material below the base of the wall sloping toward the bottom of the existing grade where a future trail extension is planned. Early stability of the slope below the wall will be critical to reduce risk of erosion, and an update to use hydroseeding along the base of the wall was agreed to be appropriate to protect the retaining wall and trail. A small update to the stormwater management on top of the new wall location is also included in the plan updates. Per discussion with the City of Omaha, an anti-graffiti coating for the wall with a 5-year warranty is also recommended.

Adjacent failed stormwater infrastructure is causing challenges on the site. This infrastructure is not on the trail corridor and was not accessible prior to site clearing at the start of construction. A small update to plans and quantities will be completed to address drainage on site both during construction and for ongoing operations of the trail after construction is completed.


The total amount covered under Change Order 1 is \$243,317.30 bringing the updated construction contract total to \$1,162,840.

• Management recommends that the Subcommittee recommend to the Board of Directors that the General Manager be authorized to execute the proposed Change Order No. 1 to the construction contract between the District and Navarro Lawn & Landscape for the Sorensen to Girard Trail Project for the maximum amount of \$243,317.30 bringing the total contract amount to \$1,162,840, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.


