

Keep Omaha Beautiful Program Highlights







Thanks to support from the Papio-Missouri River Natural Resources
District, Keep Omaha Beautiful was able to continue successfully implementing Tree Canopy Improvement plantings, stream cleanups, water pollution prevention education, and trail cleanups.

Tree Canopy Improvement Program



The Papio-Missouri River NRD allocated \$15,000 that was used for multiple tree plantings throughout July 2024 to June 2025. These funds played a crucial role in procuring trees and ensuring their care through watering contracts under the new *Trees for Tomorrow* program, which launched in the fall of 2024 at a community event where more than 100 volunteers planted 75 trees at Ta-Ha-Zouka Park. Planting sites encompassed 12 parks, 2 trails, and 2 boulevards.

Stream Cleanup Program



The Papio-Missouri River NRD allocated \$10,000 toward organizing volunteer efforts aimed at conducting cleanups in streams and adjacent areas in order to prevent litter pollution from entering our waterways. Volunteers were also tasked with installing "no dumping" decals and distributing educational door hangers to households across the city. In total, volunteers provided 5,858 service hours, equivalent to a \$132,400+ benefit to our community. NRD funding was essential in organizing these volunteers, purchasing supplies and educational materials, and covering staff time.



Trail Cleanup Program



The Papio-Missouri River NRD provided \$5,000 of funding for trail cleanups. These funds were used to recruit, coordinate, and train volunteers to complete cleanups along trails throughout Omaha. Volunteers provided more than 1,780 hours, equivalent to a \$37,400+ benefit to the Omaha community. NRD funding also helped to purchase supplies and support staff time to scout trails and manage the program.

- a. Ben Dietsch and Dave Rus joined the SSWP meeting to help in discussion on the below options for hydrologic, hydraulic, and geomorphologic studies in the SSWP. Slides attached with the presented options. The SSWP group discussed options and preferences. Primary areas of interest are in low-cost citizen science options such as the Chronolog timelapse photography and in getting baseline long-term data collection options set up such as stream gages. The Partnership can build off of this in the future with other more sophisticated options and detailed studies. Next immediate step is to get preliminary cost information.

- 4. Hydrologic & Hydraulic Models Discussion
 - a. Discussion on finalization of H&H data from Watershed Planning effort. Data is available but is coarse and intended for planning effort. The Partnership discussed the pros and cons of more detailed modeling efforts. Next level of development would likely be a BLE project in the SSWP; will look into available grants and options for federal partnerships for this process.

Current Activities and Future Work Plan

- Partnership Led Projects
 - Oakleaf Stabilization
 - Interviewing Benesch, Embris Group, HDR Engineering, and JEO Consulting Group at 4 pm tonight at the Papio NRD

 - FY26 budget includes design and construction funding
 - Springfield Stabilization

Study Opportunities in the SSWP

- Ongoing conversation with USGS on opportunities to collect data and conduct studies within the SSWP

Citizen Science

Chronolog

 Provides bracket and instruction sign for public to capture and upload landscape photos to create timelapses; could be used to capture stream geomorphology over time


CrowdHydrology

 Staff gage is installed and can be read by the public. Public can report on staff gage readings by texting the stage value to a phone number. Stages are tracked and reported on website.

Flow Photo Explorer

USGS application to estimate stream flow based on time-lapse photos.
 Can be a more cost-effective approach to monitor hydrology in smaller tributaries









Streamgages

- Will be useful for calibrating future flood models and detecting change
- A paired watershed approach for making comparisons




Channel erosion risk

 Combine geotechnical stability models with LiDARderived stream cross-section data to estimate channel erosion risk

Hydrologic and Hydraulic Data

- Papio NRD has been receiving more requests for best available H&H data in Southern Sarpy as new development occurs
- Available H&H data includes effective Springfield Creek and Buffalo Creek models (HEC-2 files) and the H&H developed for the SSWP WMP
