2. Review and Recommendation on Bids for Dam Site 15A Surplus Property – Lori Laster

Lori Laster briefed the Subcommittee on the two bids received on July 5, 2016 for 10.857 acres of surplus property at Papio Dam Site 15A. She noted that the highest bid was \$30,000 per acre vs. the District purchased price of \$20,000 per acre.

Conley that the General Manager be authorized to execute a purchase agreement with the Boyer Young Real Estate Company for the amount of \$325,710 for 10.857 acres of surplus property at the Papio Dam Site 15A project, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.
