SUBJECT: Review and Recommendation on Blair Office Building Storm Repair

**DATE:** August 11, 2014

On June 3, 2014 the Papio-Missouri River NRD Blair field office building sustained hail damage during a series of thunderstorms. The District's insurance carrier, Glatfelter Claims Management Inc. has acknowledged that the standing seam metal roof, gutters, cedar siding, as well a number of windows and doors need to be replaced. Glatfelter Claims Management Inc. received a bid from Fauss Construction, to complete all necessary repairs for \$198,155.27 (see attached proposal). Fauss Construction served as the general contractor when the building was originally built in 2011 and has performed miscellaneous repairs at the office since then. The District's deductible for this claim is \$5,000.

Staff recommends that the subcommittee recommends to the Board that the General Manager be authorized to award a contract to Fauss Construction for storm damage repairs to the Blair field office in the amount of \$198,155.27, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.
