WATERUSE REPORT/DELINQUENT ACCOUNTS:

Lance Olerich gave the water use report.

The water use report for water used during the month of October was 87.8%.

The water use report for water used during the month of November was 95.6%.

All customers on the November 12th, & December 10th, shut-off lists made payment or arrangements to make payment.

There were 26 customers on the January 13th, shut-off list.

CONSIDERATION OF NEW HOOK-UPS AND TRANSFERS:

There were no applications for a water line Hook-up.

There was three Transfers: #02 William-Katherine Shelly to Ryan Bousquet, #629 Gene Robertson to Patricia Robertson, and #363& #359 Lonny &Sallie Book to Christopher & Kasey Krueger.

<u>Motion #3</u> A motion was made by Harold Moes and seconded by Duane Rohde to recommend to the District to accept the above three Transfers. Roll Call vote, all yes. Motion carried. 7-0.

MANAGERS REPORT:

Lance Olerich gave the Manager's report. Lance and Bill have been performing regular maintenance for the last couple of months.

Zach was not present at the Advisory Board meeting, he sent reports for the January meeting. There was a pay period that included the last week of December and first week of January. That's why no salaries show up on the Revenue/Expense report with January checks.

The six year average for water used in November is 4,570,000 gallons. This November customers only used 3,512,000 gallons, which shows that customers are using less water overall on average.

Zach and Lance attended a meeting with the Village of Homer, JEO and USDA on January 7th, 2015. They presented additional options to increase capacity and improve DCRW redundancy.

Sales are right on 50% anticipated for the year. Office supplies are at 85% of budgeted because this includes fees for online billpay, which more customers are using it than expected. This is saving staff time and a little with postage. Overall things continue to look good since revenues are on track to balance expenses.
