WATERUSE REPORT/DELINQUENT ACCOUNTS:

Lance Olerich gave the water use report. The water use report for March water was 95.4% with the monthly average for the year 99.1%.

There is 38 customer's on the June 13th, shut-off list.

The water use report for April water was 90.3% with the monthly average for the year 96.9%.

On the April 10th, shut-off list all 33 customer's and on the May 8th, shut-off list all 30 customers made payment or arrangements to make payment.

Dick Sklenar presented and discussed with the Advisory Board a graph showing water sold since 1993.

MANAGERS REPORT:

Lance Olerich gave the Manager's report. Regular maintenance has been done for the month. Spring flushing has been completed. Bill has been out mowing valve boxes.

All five routes of meters have been read. While reading meters a leak was found at 517 Eagle Drive and was repaired. Lance and Bill helped a few customers with water leaks.

The water quality report has been sent out to customers. New rate sheets were sent to customers.

Inspection has been completed on the inside and outside of the two water towers, they are both in good shape.

Went to Blair and a representative from Badger meters gave us some information about their meters.

Dick Sklenar discussed AMR meters with the Advisory Board.
