### 1. <u>Review and Recommendation on Director's Expense Claim Reimbursements, John Winkler:</u>

General Manager Winkler updated the Executive Subcommittee on Director Scott Japp's Director Expense Claim forms from July 2012 and April 2013. Both forms claimed reimbursement for legal fees and the April 2013 form claimed copying charges of \$50 without a receipt. The General Manager is asking for a payment decision from the Executive Subcommittee per District's Director Policy Manual 14-3 Paragraph F, "...Any Director's expense item that is disputed by the General Manager (or Assistant General Manager) shall be referred to the Executive Subcommittee, which shall indicate in writing its decision on payment/non-payment of the item." Director Japp stated State Statute authorized him to expense the claims as it was in connection with his duties as a Director; and that he was not able to get needed documents from staff or Legal Counsel. The General Manager stated that all documents were mailed to Director Japp within a reasonable time frame. Director Tesar asked the General Manager how much money the District has spent in connection with Director Japp's requests. The General Manager stated that since January of 2013 to date, the District has spent \$50,000 to \$60,000.

# • It was moved by Director John Conley and seconded by Director Tesar to ratify the General Manager's action to deny the payment of the copying and legal fees from Director Japp's April 2013 expense claim and legal fees from his July 2012 expense claim.

There was a motion by Director Tesar and seconded by Director John Conley to approve the Resolution.
