#### 1. Review and Recommendation on West Papio Trail License Agreement – Eric Williams:

Eric Williams reviewed the ability of the District to enter into a License Agreement with Quest Properties for the use of former rail corridor property now owned by the District and protected under the National

Trails Act. Quest Properties, LLC representatives and Jennifer Woodward, attorney with Laughlin, Peterson and Lang, discussed the cost of the improvements and their installation of the required trail section along this property.

• It was moved by Director F. Conley and seconded by Director Leahy that the Subcommittee recommends to the Board of Directors that the General Manager be authorized to execute the License Agreement with Quest Properties, LLC for use of District right of way along Harry Andersen Avenue at Q Street, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.

# 2. Review and Recommendation on Daniell Trail Amended and Restated Interlocal Agreement Eric Williams:

Eric Williams provided an overview of the existing cost share agreement through the Trails Assistance Program with Sarpy County and the need to increase the District's cost share based on recent bids received for construction of the project.

Conley and seconded by Director Leahy that the Subcommittee recommends to the Board of Directors that the General Manager be authorized to execute the proposed Amended and Restated Interlocal Cooperation Agreement for construction of the Daniell Trail, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.

## 3. Review and Recommendation on Big Papio Levee Culverts Project – Martin Cleveland and Mike Sotak, FYRA Engineering:

Martin Cleveland and Mike Sotak recapped the history of initial rebid for the project and concluded that the project should be rebid with an extended contract time of 1 year.

• It was moved by Director Tesar and seconded by Director F. Conley that the Subcommittee recommends to the Board of Directors that the General Manager be authorized to reject all of the February 24, 2016 bids for the construction of the Big Papio Levee Culverts Project and rebid the project.

4. Review and Recommendation on Little Papio Creek Channel Stabilization Project (W. Center Road and 68th Street) Change Order No. 1 and Contract Amendment No. 1 – Martin Cleveland:

Martin Cleveland discussed the need to extend the length of this channel bank stabilization project to repair an additional slough area. This change in the project limits necessitates additional construction costs and engineering costs.

• It was moved by Director Tesar and seconded by Director F. Conley that the Subcommittee recommends to the Board of Directors that the General Manager be authorized to execute proposed Change Order No. 1 in the amount of \$45,926 (\$55,396 - \$9,470) to the contract with Bayshore Contractors LLC, bringing the total construction contract amount to \$219,706; and also execute proposed Amendment No. 1 in the amount of \$12,730 to the contract with HDR Engineering Inc., bringing the total professional services contract not-to-exceed amount to \$147,484, all for the Little Papillion Creek Channel Stabilization Project located near 68th and West Center Road.
