RE: FY 2015 Equipment Requirements

Attached is a chart of equipment items identified for purchase/replacement in FY 2015. The process to identify and prioritize equipment items most needed by the District was determined by a staff Equipment Committee comprised of Bill Brush, Martin Cleveland, Zach Nelson, Terry Schumacher, Bill Warren, and me. Each department within the NRD identified their equipment requirements; the equipment committee reviewed each item and made recommendations to the General Manager for purchase. The GM then reviewed the Committee's recommendations and made further changes to the request list.

The FY 2014 total equipment budget was \$273,398. The FY 2015 equipment budget request is \$282,198.

Management recommends that the Subcommittee recommend to the Board of Directors to approve the FY 2015 Equipment Requirements subject to the FY 2015 Budget as listed in this memo.

RE: Sole-Source Request "Rhino" 15 ft. Batwing Mower

I am requesting a new Rhino 15 foot Batwing mower sole-source. Staff and management believe it is in the best interest of the District to purchase the sole-source brand of Rhino for the following reasons:

- 1. This mower will be going to our Walthill Field Office for maintenance on mowing the 46-PL-566 structure, levees, and off-line storage areas.
- 2. The District currently owns four Rhino 15 foot Batwing mowers. These mowers have performed outstandingly in the conditions that they mow in. We have had Rhino mowers since 1975.
- 3. All components of said equipment are "Rhino" parts, which is essential for sound operation and performance.
- 4. The Rhino equipment seem to perform best with the terrain in which the equipment is used. They operate both most efficiently and safely in our field conditions.
- 5. The District has used John Deere and Woods mowers in the past and incurred excessive maintenance and repairs.
- 6. Case-IH Dealers and John Deere Dealers both allows for competitive bidding as is required.

I recommend for the purchase of a sole-source Rhino mower for Walthill maintenance mowing due to efficiency and safety issues.

RE: Sole-Source Request "Bobcat" Tool Cat 5600 Series

I am requesting replacement of our John Deere 870 tractor and loader (4AA09) with 1,281 hours and 2009 John Deere Gator (6CT22) with 750 hours with a sole-source item. Staff and management believe it is in the best interest of the District to purchase the sole-source brand of "Bobcat" Tool Cat for the following reasons:

- 1. The District currently owns three John Deere Gators for Chalco Hills, the five outside parks and Mopac Trail.
- 2. The Bobcat Tool Cat 5600 series is a year-round utility machine. This machine uses the same attachments that our Bobcat T590 track skid loader uses. It has a dump box for hauling, is 4-wheel drive, and attachments available are a snow blower, broom, bucket, pallet fork, post hole digger, seeder, rake, stump grinder, tree shear, snow blade and grapple bucket.
- 3. There are numerous Bobcat dealers in Nebraska which allows for competitive bidding as is required.

I recommend for the purchase of a sole-source Bobcat Tool Cat 5600 series utility machine for our parks and trails.
