SUBJECT: Application for Road Structure Cost Sharing Assistance – Burt County

DATE: March 22, 2012 FROM: Dick Sklenar

An application has been received from the Burt County Highway Department (attached) for financial assistance under the District's Road Structure Program to replace an existing bridge. The replacement amounts installing a double 16' X 16' concrete culvert, which is also intended to remove five feet of grade from the existing channel. The location (see attached map) is about 2 miles southwest of Decatur, on Elm Creek.

The District's program guidelines provide a level of financial assistance amounting to 75% of the total eligible construction cost not to exceed \$150,000 per project. Cost sharing by the District shall not include those costs incurred by the County for guard rails, roadway surfacing, traffic signals or signs, relocation of utilities, purchase of land rights, engineering, inspection, administrative costs, and work performed by County personnel. Benefits of a road structure includes heavier weight limits, improved safety, erosion control, habitat enhancement, and improved water quality downstream of the site.

The total estimated cost of this project is expected to be about \$300,000 to \$400,000. The request for financial assistance is \$150,000 (maximum allowable). The County expects to initiate construction of the project this fall.

Management recommends that the Subcommittee recommend to the Board of Directors that the Burt County Highway Department application for financial assistance on a road structure project located on Elm Creek, about 2 miles southwest of Decatur, Nebraska, be approved for financial assistance, not to exceed \$150,000 subject to the Fiscal Year 2013 budget.

Dear Mr. Winkler,

I am writing to request funding for construction and technical assistance preparing the design and completing a U.S. Corps of Engineers 404 permit from the Papio-Missouri NRD for a Road Structure project Burt County would like to do in section 16, township 23N, range 10E of the sixth pm. The project is located on Elm Creek.

Replacement of the existing 20' X 150' single welded steel truss bridge is required due to structural deficiencies and problems with stream degradation. This bridge is posted –Type 3, 4 Tons-Type3S2, 5 Tons-Type 3-3, 8 tons. If the bridge load-rating goes below 3 tons Burt County will have to be close the bridge. This road is the only good access to farm ground across the creek.

The proposed improvement project is a box culvert with drop inlet or multi plate steel culvert with 5 foot raise at inlet to help with stream degradation. This project would cost over \$300,000, so any help Burt County could get from the NRD would greatly be appreciated.

No engineering has been done on this project.
