SUBJECT: General Legal Expenses – over 110% of budget

DATE: January 5, 2015

The budget account 01-01-000-4392 is the District General and Administrative Legal Fee's budget. It covers all legal fees not associated with a specific project and general in nature to the operation of the District.

As of 12/31/14 the total expenditure from this budget is \$52,741.00 of a budgeted amount of \$45,000 which is 117% of the budget.

Please refer to the attached spreadsheet which illustrates the expenditures in this budget category. Several items of note which, when combined, consumed a considerable amount of legal resources (i.e. Board of Equalization issue, ongoing lawsuits, policy reviews etc.) In addition, since the District had no prior billing experience with another firm besides Mr. Paul Peters, it was somewhat difficult to anticipate what this fiscal year's legal fees would be.

The District, in conjunction with Husch Blackwell, will be conducting its mutually agreed upon six (6) month review of District wide legal billings and fees paid to determine where resources are being expended and strategies to initiate savings.

If account 01-01-000-4392 should exceed \$90,000 prior to the end of the 2015 fiscal year, management will bring it back to the FEL Subcommittee for further approval.

Management recommends that the Subcommittee recommend to the Board that Account 01-01-000-4392 – General and Administrative Legal Fees be allowed to exceed 110% of the budgeted amount of \$45,000.
