NRCS Farm and Ranchland Protection Program (FRPP) Grant Application for

Glacier Creek/Allwine Prairie west parcel

The University of Nebraska-Omaha (UNO) and the NRD have been working together for a number of years to acquire additional property adjacent to the Allwine Prairie at 144th and State Streets. To date the District has helped to fund the purchase of 86 acres east of Allwine Prairie, which is planned to the be a District wetland and stream mitigation bank, and the 76 acres north of Allwine Prairie (Hayes Overlook). These purchases provide a unique ecosystem in an urban area and also protect a viewshed which allows an undisturbed view of the prairie.

One of the remaining parcels that UNO hopes to acquire for the expansion of the prairie is the 227.84 acres to the north and west of the existing prairie. This property is currently owned by NS-The Heritage, LLC and has been preliminary platted as single and multi-family residential. UNO has applied for Nebraska Environmental Trust Fund dollars to put toward the land purchase. To help fund this acquisition, UNO would like the District to pursue the NRCS Farm and Ranch Protection Program (FRPP) grant funding. Through the FRPP the District could receive federal funds in an amount up to one half the appraised value to administer an easement over the property, preserving the 227 acres as farm and ranchland. The FRPP application, if successful, could fund \$1,861,000 of the acquisition costs.

Staff recommends that the Subcommittee recommend to the Board that the General Manager be authorized to apply for NRCS Farm and Ranch Protection Program funding for the 227 acres north and west of Allwine Prairie as part of the Allwine Prairie/Glacier Creek Expansion Project.
