NOTICE OF PUBLIC HEARING

Please take notice that on May 8, 2014, at 7:00 p.m. the Board of Directors of the Papio-Missouri River Natural Resources District will hold a public hearing on Western Sarpy Clear Creek Flood Reduction Project ("the Project") in Sarpy County, Nebraska, and on the acquisition by the District of permanent easements for the Project. Such hearing will be held at the principal offices of the District at 8901 South 154th Street, Omaha, Nebraska 68138-3621.

At the hearing, the District shall explain the nature and necessity for the Project, the reasons for selecting the particular location, and the right of each owner of property to be represented by an attorney and to negotiate and accept or reject the offer of damages which will be sustained by the proposed acquisition, and the right to require that such damages be determined pursuant to the procedures for acquisition by eminent domain. The District shall hear and consider any objections from any person.

NOTICE

The Papio-Missouri River Natural Resources District (hereinafter referred to as "the District") proposes to acquire permanent easements (hereinafter referred to collectively as "the Easements") in, on, over and across certain tract(s) of real estate in Sarpy County, Nebraska (hereinafter referred to collectively as "the Property"), in the SW ¼ of Section 5, T13N, R10E, Sarpy County, Nebraska, as surveyed, plated and recorded in Sarpy County, Nebraska, as depicted in existing site plan and incorporated herein by reference, which you own or in which you may have a right or interest.

1. The property proposed to be acquired and the compensation to be given for the property:

The compensation to be offered for the Property will be the damages as appraised by licensed real estate appraisers, generally consisting of the fair market value of the interest in or portion of the property acquired.

2. The authority for the acquisition:

The District's authority for the proposed acquisitions is contained in Nebraska Revised Statutes, Sections 2-3229, et.seq.

3. The nature of and necessity and purpose for which the land shall be used:

The permanent easements proposed to be acquired will be used for the Western Sarpy Clear Creek Flood Reduction Project and Associated Conservation Measures.

4. The right, title or interest in the property to be acquired:

The District proposes to acquire permanent easements to certain lands required for the Project.


- 5. <u>The amount of property needed:</u> The before mentioned parcels are incorporated herein by reference, are required for the aforesaid levee improvement project.




