

Since 2009 the District has been in search of property to acquire South of Q Street and west of 245th Street along the Elkhorn River to construct another River Access site to serve the recreational needs of the public and the emergency access needs of local first responders.

For a number of years the District attempted to negotiate with the owner of property on 245th and Q to purchase property along the Elkhorn River to construct such a facility (see attached aerial view). However, those negotiations ultimately failed.

In 2014 the District, through various strategic partnerships, worked with representatives of Mr. Frank Krejci, the new owner of this property, to determine the Districts interest in accepting a donation of a 18.01 acre portion of his entire ownership along the Elkhorn River that is not useable for development purposes and only marginally useful for agricultural purposes (legal description of the parcel is attached) in order to construct a river access site.

Management recommends that the Subcommittee recommend to the Board of Directors that the Board approve the donation of 18.01 acres of land from Mr. Frank Krejci to the Papio Missouri River NRD per the attached legal description and the terms and conditions of the Warranty Deed per changes deemed necessary by the General Manager and District Legal Counsel.
