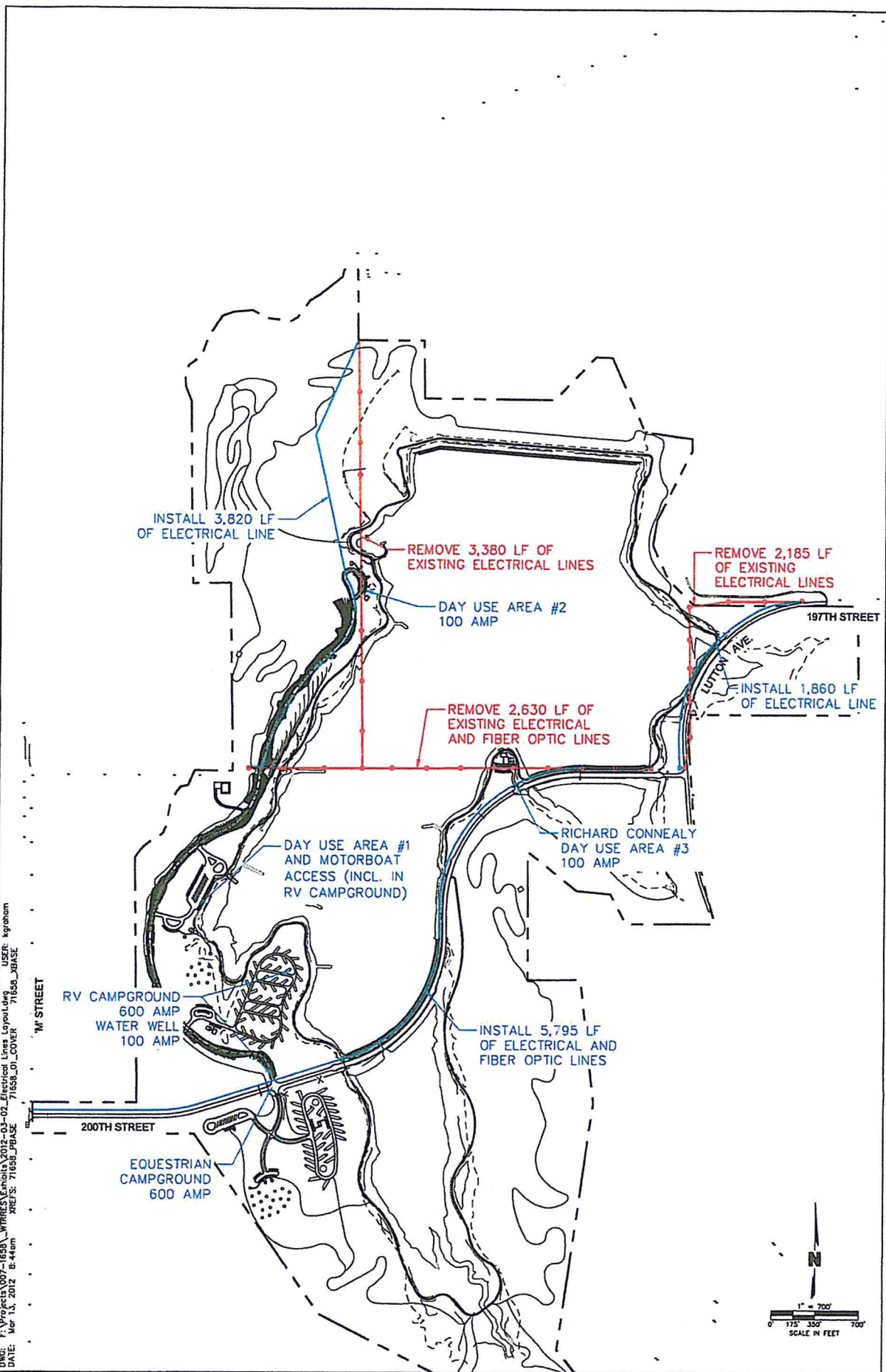
SUBJECT: Review and Recommendation of NeNPPD agreement for
Pigeon/Jones Creek Dam Site 15 Watershed Project

DATE: April 30, 2012

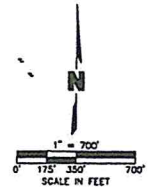
The construction of the Pigeon/Jones Creek Dam Site 15 Watershed Project will require the relocation of some of the power lines located in the project area. Future power needs of the recreation area have been identified as part of the work needed to be done by the Northeast Nebraska Public Power District. The work will need to be done in phases as the work is completed on the dam and 200th street. Attached is a map that identifies the work that needs to be completed by NeNPPD.

NeNPPD is estimating that the work for the total project will cost approximately \$150,000.00. Phase 1 of the work that needs to be completed is approximately 3800 LF of line that needs to be relocated north of 200th street. Part of the current overhead line in this area is located in the emergency spillway area of the dam and will be part of the initial dam construction area. Attached is an agreement for Phase 1 of the power line relocation project with NeNPPD.

Management recommends that the Subcommittee recommend to the Board that the General Manager be authorized to execute contracts with Northeast Nebraska Public Power District for the relocation and installation of the power lines for the Pigeon/Jones Creek Dam Site 15 Watershed Project in the not to exceed amount of \$150,000.00 subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.
