The Papio-Missouri River Natural Resources District (PMRNRD) is requesting proposals for professional engineering services necessary to plan, permit, design and construct a flood control structure in the Papillion Creek watershed near 168<sup>th</sup> and Fort Street in Omaha, Douglas County, Nebraska (see attached map).

A previous report titled "Dam Site 15A Revised Conceptual Design Evaluation" completed in May 2007 by HDR Engineering, Inc. is available electronically by request. This report provides conceptual design elements as well as preliminary hydrology and hydraulics for the DS 15A project. Also included in the report is a conceptual Master Plan prepared by BCDM. The scope of work for this project will include a transportation/utilities plan, a recreation plan, and a community-based watershed management plan.



August 2 <b>3</b> , 2009	Ad-Hoc Subcommittee Meeting to interview selected firms. Subcommittee will rank each firm by preference.
October 6, 2009	Ad-Hoc Subcommittee Meeting negotiate contract with first choice firm.
October 8, 2009	District Board of Directors adopts Subcommittee Recommendation on entering into contract with selected engineering firm.
