#### **MONTHLY UPDATE**

#### February 2010

A Partnership meeting was held on February 25<sup>th</sup>. Meeting minutes and other materials are updated regularly on the Partnership's website: www.papiopartnership.org.

#### Ordinance Updates

Partnership members are in the process of updating their community's floodplain and stormwater ordinances. All communities affected by the new West Papillion Creek flood maps must update their floodplain ordinance by May 3, 2010 which is the effective date of the new maps. To date, Boys Town and Papillion have adopted the revised floodplain ordinances. All other communities have started the process with their planning commissions. Boys Town, Gretna, La Vista, Omaha, and Papillion have all adopted the new Post Construction Stormwater ordinances. Bellevue and Ralston are in the process of presenting to planning commission and city council. Sarpy County has been enforcing the changes. They will present administrative changes to zoning regulations to the planning commission on March 17, 2010.

#### **CBI Systems Software**

The City of Omaha has been working with CBI Systems, Inc. to obtain pricing for their MS4 software. This software would allow for all PCWP members to access one shared database for tracking their NPDES stormwater permit requirements such as stormwater monitoring and public outreach. This software not only helps with reporting but also keeps all data in a central location if needed for an EPA audit. The Executive Committee voted to request that the NRD Board disburse funds for the purchase of the software. This will be presented at the NRD's March board meeting.

#### **Douglas County Monitoring Data**

Kent Holm from Douglas County Environmental Services had requested that the Partnership consider an agreement to be reimbursed for sharing monitoring data that is done collectively



by the City of Omaha for the Partnership. Holm took the draft agreement to the Douglas County Board where they voted against the agreement.

#### **EPA Wetland Program Grants and NRI**

Mandy Whitsett, Eliodora Chamberlain, and Pete Davis from EPA Region 7 gave a short presentation on EPA grant programs. The Wetland Program Development Grants (WPDG) can be used for research, investigations, experiments, training, demonstrations, surveys or studies to reduce, prevent, or eliminate water pollution. Region 7 receives approximately \$1.1 million annually to award within the region. Typical project awards are between \$100,000 and \$500,000 and a 25% non-federal match is required.

#### **Natural Resources Inventory**

Ted Hartsig and Paul Woodward from Olsson Associates presented a project completed in Kansas City utilizing EPA grant funds. The Kansas City project is a Natural Resources Inventory (NRI). An NRI takes existing data from different agencies and organizations and compiles the data into one database that can then be used by entities to determine how best to layout new development in order to protect natural resources. Data collected would include land use, soil type, topography, vegetation, and water resources. The NRI would also help to identify areas that would be sensitive to new development. The NRI would also identify areas that are in need of stabilization, therefore creating priority projects throughout the watershed. Planning departments would be able to incorporate the results from the NRI into master plans.

Recreational Trails -- The Natural Resources Committee accepted testimony on three bills this week dealing with the use of eminent domain for recreational trails.

Most of the testimony was geared toward **LB 1010**, introduced by Senator Dave Pankonin. The bill would establish some additional criteria for NRDs if eminent domain had to be used to acquire land for a recreational trail. If negotiations failed to acquire property willingly and the district would pursue acquisition through eminent domain, the NRD would be required to hold public hearings and be required to operate as a court or tribunal, in that the board would receive evidence, hear testimony and create a record.

Senator Pankonin mentioned that several discussions have taken place on the bill between the NRDs, several senators, landowners and other interested parties, which has resulted in several suggested changes that the parties could agree to. These include reducing the supermajority vote to two/thirds of the Board of Directors, would clarify the eight components to be considered by the Board before making their decision to implement a trail project, would address the standard of "good faith" in the process of obtaining negotiated right-of-way agreements, would set objective criteria for which the Board would have to find clear and convincing evidence before voting to proceed in their decision to exercise eminent domain, and would add liability protection language for property owners adjoining a recreation trail.

Senator Pankonin also noted that an amendment was not available prior to the hearing, but would be developed early next week.

Glenn Johnson, Lower Platte South NRD Manager, presented testimony in support of the bill on behalf of his district and the NARD, with changes suggested by Senator Pankonin. Also testifying in support of the bill was John Winkler, Papio-Missouri River NRD; Stan Staab, Lower Elkhorn NRD; Nebraska Farm Bureau Federation, Nebraska Trails Council and several individuals from Cass County. The Nebraska Sierra Club testified in a neutral capacity.

The committee also accepted testimony on **LB 1019**, introduced by Senator Ken Haar. This bill also sets up a procedure for mediation if a dispute occurs on developing a trail when eminent domain may be used. Senator Haar mentioned that he had been working with Senator Pankonin to address the concerns with LB 1010 and mentioned that he would keep working toward an agreement on LB 1010.

The third bill, **LB 1011** introduced by Senator Pankonin would eliminate the ability of NRDs to use eminent domain for recreational trails. Senator Pankonin mentioned that this bill was only a back-up if nothing could be worked out on the procedures offered under either LB 1010 or 1019.

The committee took no action on the bills after the hearing.

NRD Recreational Facilities — The Judiciary Committee accepted testimony on LB 795 this week which would allow a NRD encompassing or including any portion of a city of the metropolitan class to employ or otherwise secure the services of certified law enforcement personnel or security services to patrol and protect district-owned recreation areas and to assist law enforcement officers in enforcing district recreation areas.

Senator Brenda Council, the sponsor of the bill, offered an amendment at the hearing to expand the authority to all NRDs. John Winkler, Papio-Missouri River NRD Manager, testified in support of the bill and the amendment on behalf of PMRNRD and the NARD. The PMRNRD would like to contract with county sheriff offices and/or local city police to patrol recreational facilities for a set number of hours per month to provide protection for individuals using the facilities and also address vandalism problems.

The bill was also supported by Mike Onnen, Little Blue NRD Manager, and Bob Hilske Nemaha NRD Manager. There were no opponents to the bill. The Judiciary Committee took no action on the bill after the hearing. However, a couple of committee members want to assure the language only allows NRDs to contract with qualified law enforcement personnel. The NARD is willing to work with the committee to provide those assurances.

Water Resources Cash Fund – The Natural Resources Committee accepted testimony on LB 993 which would add "enhancing stream flows or groundwater recharge" to the uses of the Water Resources Cash Fund. The bill was brought to the committee by the bill sponsor, Senator Tom Carlson, when it was discovered that a proposed water lease by Tri-Basin NRD to increase stream flow in the Platte River would not qualify under the program.

John Thorburn, Manager of the Tri-Basin NRD, presented testimony on behalf of his district and the NARD in support of the bill. The committee took no action on the bill.

State Control of Groundwater -- The Natural Resources Committee accepted testimony on two bills this week to extend more control to the state on groundwater use. The first bill, LB 1054 would apply a revised version of the correlative rights doctrine for groundwater use. It would only allow the co-equal right of each landowner over a common aquifer to extract his, her, or its share of water from the aquifer without (a) unreasonably harming other landowners over the common aquifer through lowering of the water table, (b) directly and substantially affecting a watercourse, or (c) reducing artesian pressure. If the Department of Natural Resources determined that the standard should apply to a basin for compact or agreements, the allocations for use would be reduced. The bill was supported by the Lower Republican NRD and Frenchman Cambridge Irrigation District. Senator Carlson, the sponsor of both bills, asked that the committee not advance the bills.

Lyndon Vogt, Manager for the Upper Niobrara-White NRD, presented testimony in opposition to the bill on behalf of his district and the NARD noting that the correlative rights already apply and that local NRDs should maintain the authority to make the management decisions to regulate groundwater. The bill

was also opposed by the Upper Republican NRD, North Platte NRD, Nebraska Farm Bureau Federation, Nebraska Rural Electric Association, Nebraska Cattlemen, and many individuals from across the state.

The second bill, **LB 1056**, proposes required metering and allocations when depletions of groundwater occur. The Department of Natural Resources would be required to measure aquifer and groundwater changes across each river basin each year and report such measurement to the Legislature on December 31, 2010, and on December 31 of each year thereafter. Change would be determined based upon a comparison to saturation thickness of the aquifer in the base year of 1963. The bill would mandate metering and allocations determined by the department. If depletions go to 30 percent, the department would require that groundwater use be shut off in the area.

The bill was supported by the Lower Republican NRD and Frenchman Cambridge Irrigation District.

Lyndon Vogt, Manager for the Upper Niobrara-White NRD, presented testimony in opposition to the bill on behalf of his district and the NARD. Vogt pointed out that each NRD has in place an approved Ground Water Management Plan reviewed and approved by the state which is continually maintained and updated. Groundwater decline trigger-levels are set by the districts to initiate regulation.

Other opponents that presented oral testimony against the bill included Upper Big Blue NRD, Upper Republican NRD, Lower Elkhorn NRD, several individual NRD board members, and individual irrigators from all across the state. Letters in opposition came from several organizations and individuals, including but not limited to, the Nebraska Cattlemen, Nebraska Farm Bureau Federation, and the North Platte NRD.

Several other organizations and individuals had planned on testifying against both bills, but decided not to after Senator Carlson announced at the hearing that he requested the committee not advance the bills.

**Priority Bills** – State senators have until next Friday, February 19<sup>th</sup> to declare a priority bill from the session. Further, each Committee gets to select two priority bills for the session. Finally, the Speaker also gets to select 25 priority bills for the session. If a bill does not receive priority status, it is very unlikely that it will be debated further this year. Related to natural resources, Senator Dubas has selected **LB 689** as her priority bill. The bill eliminates the funding mechanism for the water resources cash fund. Papio NRD Board Approves Bonds to Protect Property -- Much needed flood control measures for the Papio Creek Watershed and elsewhere, to protect the lives and property of district residents, will be pursued through the NRD's first-ever use of bonding. The option to fund projects through bonding was granted to the NRD by the Nebraska Legislature in 2009. The NRD Board voted on February 11<sup>th</sup> to issue \$13.3 million in Flood Protection and Water Quality Enhancement Bonds to fund several proposed flood control projects and programs within the six-county Papio-Missouri River NRD area.

"This was a historic vote. These funds will allow the district to accelerate its efforts to protect lives and property from potentially devastating flood events", said NRD Manager John Winkler. "Time may be running out to get these projects built before our metro area encounters heavy rainfall and runoff that has recently caused considerable damage to other nearby urban areas," he said.

Several projects identified to receive bond funding include levee improvements, flood control reservoirs and structures, floodway purchase program, and water quality protection project. "We plan to pay for

these bonds without raising our tax levy. In fact, our levy decreased this year," said Winkler. The NRD has been working for years with area cities, villages and counties to develop flood control and water quality measures to protect residents. Engineering studies of the Papillion Creek Watershed have shown that our floodplains are growing due to decades of urbanization.

Papio-Missouri River NRD Residential Cost-share -- Twenty-four homes on Thompson Creek may be purchased by the City of LaVista through a Federal Emergency Management Agency grant and local cost-share funding by the PMRNRD. By purchasing homes and property the district will protect the lives and property of residents in the area from flooding and severe creek bank erosion that has threatened homes, road crossings and other public infrastructure along this creek since the early 1970s. The NRD's cost-share amount of \$340,155 was approved by the board at their meeting February 11<sup>th</sup>. The funds will match the amount by the City of LaVista, which then fulfills the match requirement on Hazard Mitigation Grant Program funding. The total cost of the project is \$2,721,240.

All land purchases by the City will be voluntary. Once the properties are purchased, the City of La Vista will demolish the structures and maintain the lots as open space to allow for ease of maintenance of Thompson Creek.

The Papio-Missouri NRD Board also approved cost-sharing with the City of Valley for assistance on improving the North Spruce Street Drainage-way. The project with help protect the lives and property of Valley residents. The Papio-Missouri NRD will cost share \$186,480 with the City to complete the \$310,800 project.

RE: February 19 NARD Update

**Priority Bills** – State senators had until noon Friday, February 19<sup>th</sup> to declare a priority bill from the session. Further, each Committee gets to select two priority bills for the session. Finally, the Speaker also gets to select 25 priority bills for the session. If a bill does not receive priority status, it is very unlikely that it will be debated further this year.

The following bills related to Natural Resources were declared priorities for the session:

- O LB 689 -- Change Water Resources Cash Fund, Ethanol Production Incentive Cash Fund, and ethanol excise tax provisions. Langemeier. The bill eliminates the 3/5ths cent/bushel check-off on corn and 3/5ths cent/hundredweight check-off on grain sorghum that was to go to the Water Resources Cash Fund starting in October 1, 2012. The bill also redirects the funds remaining in the Ethanol Production Incentive Cash Fund when the program ends December 31, 2012, splitting it equally with the commodity boards and the general fund. The funds were to go into the Water Resources Cash fund. Senator Dubas Priority Bill.
- LB 764 -- Allows NRDs to develop IMPs in areas that are not Fully or Over-Appropriated. Fischer. (NARD Bill) The bill allows a natural resources district encompassing a river basin, sub-basin, or reach that has not been designated as fully or over-appropriated to, jointly with the department, develop an integrated management plan for such river basin, sub-basin, or reach located within the district. The district would be required to notify the department on or before October 1 of its intention to develop an integrated management plan which shall be developed and adopted according to sections 46-715 to 46-717 and subsections (1) and (2) f section 46-718. Senator Fischer Priority Bill.
- LB 862 Change provisions relating to issuance and repayment of river-flow enhancement bonds. Christensen. The bill changes the definition of which NRDs can use the occupation tax on irrigated acres to pay for water programs. The bill also allows the proceeds to pay for the cost of a project with or without issuing bonds. The bill allows a district to confine such occupation tax to irrigation activity in any of the river basins in such district. Finally, the bill allows for a reduction of the tax on irrigated lands if there is no surface or ground water available to irrigate such lands, either on a temporary or permanent basis. Natural Resources Committee Priority Bill.
- LB1010 Provide procedures and limitations on the use of eminent domain by natural resources districts for recreational trails. Pankonin. The bill outlines procedures for the use of

eminent domain by a natural resources district to take private real property for a recreational trail or a connecting trail. Senator Pankonin Priority Bill.

O LB 1057 -- Creates the Republican River Basin Water Sustainability Task Force. Carlson. The bill creates the Republican River Basin Water Sustainability Task Force to ensure sustainable water use within the basin, maintain compliance with the interstate compacts to which the basin is subject, and avoid water-short years. The task force would be required to present a preliminary report to the Governor and the Legislature on or before May 15, 2011, and a final report before May 15, 2012. Senator Carlson Priority Bill.

Cass County, NRD agree to work together on MoPac Trail -- Cass County and Lower Platte South Natural Resources District signed a memorandum of understanding to work together evaluating potential corridors for the segment officially known as the MoPac East/Lied Platte River Bridge connection. Under the agreement, the NRD will take care of the technical aspects of the trail segment project and Cass County will lead public involvement, including holding public meetings for concerned residents. The goal of the agreement is to find an acceptable corridor for making the connection to finish a recreational trail between Lincoln and Omaha.

#### Hearings this Week

Bank lien exemption -- The Natural Resources Committee accepted testimony on LB 785, which would provide an exemption from the lien search for transfers of four certified irrigated acres or less. The bill is sponsored by Senator Tom Carlson of Holdrege. The title search requirement was added to state law last year as a way to protect lien-holders from having property devalued as a result of a certified irrigated land transfer. Those involved in drafting the legislation recognized at the time that there was some minimum threshold that should be exempt from the lien search requirements. However, the parties were not able to come to an agreement at the time as to what that threshold would be, so the original legislation was silent on that point.

John Thorburn, Manager of the Tri-Basin NRD, provided testimony in support of the bill on behalf of the NARD and his district. John relayed to the committee that there are a couple of other issues that will need to be addressed either this year or in future years, which include how to protect lien-holders from having property devalued when surface water rights are transferred, and whether people who buy and sell irrigation rights should report the price of those transactions.

Milt Moravek, Assistant Manager of the Central Platte NRD, also testified in support of the bill and the suggested exemption for irrigated efficiency. Moravek suggested that the exemption be expanded to include transfers involving one landowner on a single tract of land where there is no reduction in certified irrigated acres and the transfer involves an improvement to irrigation efficiency.

The bill was also supported by the Nebraska Bankers Association, who cited in their testimony that there should be some small number of acres that should not have a lien search.

The committee took no action on the bill after the hearing.

**Instream flow rights** – A bill introduced by Senator Bill Avery of Lincoln was heard by the Natural Resources Committee this week. The bill, **LB 1025**, would allow the Nebraska Department of Natural Resources to approve an instream flow water right in areas that have been declared fully appropriated as long as there is no increased consumptive use.

Don Blankenau, Blankneau and Wilmoth, LLC, testified on behalf of the NARD in opposition to the bill and also submitted letters from two NRDs that could not attend the hearing (Middle Niobrara and Tri-Basin). Blankenau pointed out that although it is appealing to seek an instream flow right on the Niobrara River, the Nebraska Constitution expressly limits appropriations to "un-appropriated" water. That is, water that has not already been claimed by another user. The declaration of Fully Appropriated for the Niobrara River outlines in law that there is no un-appropriated water available. Thus, LB 1025 thereby acts in direct opposition to the Constitution and would probably not be enforceable.

Blankenau also pointed out that in a fully appropriated system, granting an instream flow appropriation when no other uses can be developed provides no protection to species or recreational purposes. The reason is that an instream flow appropriation simply allows the holder to call for shutting down diversions by those who acquire rights later in time. Because no other water rights can be granted in a fully appropriated system, a junior instream flow right would have no ability to seek the shut down of junior users because none would exist. Simply stated, the instream flow right would have no meaning or value.

Blankenau also pointed out that if a fully appropriated designation was lifted by NDNR, NDNR and NRDs would still need to abide by the provisions of LB 483. That bill, passed last year, restricts the amount of water that can be obtained for a water right to avoid a fully appropriated designation.

These points were also echoed by the Nebraska Farm Bureau Federation also in opposition to the bill. The bill was supported by Sierra Club and several other wildlife organizations.

The committee took no action on the bill after the hearing.

Statewide Water Planning – The Natural Resources Committee accepted testimony on LB 1016 which adopts the Nebraska Statewide Water Planning Commission Act. The bill establishes a commission which consists of seven members appointed by the Governor. The commission shall exercise the powers and perform the duties carried out by the Division of Planning and Assistance of the Department of Natural Resources.

The duties of the commission include, but are not limited to: (1) Developing a statewide plan for the future use of water in the state; (2) maintaining and maximizing the use of water in this state; (3) creating a plan to manage the state's water resources to encourage economic health and prosperity; and (4) make recommendations to the Governor and the Legislature for achieving the goals set forth in the plan developed pursuant to subdivision (1) of this section.

The concept of the bill was supported by the Nebraska State Irrigation Association and Nebraska Water Resources Association.

The bill was opposed by the Nebraska Department of Natural Resources citing that data and models used by the department are for both planning and regulation and noted that separating the agencies would create duplication.

Senator Langemeier also noted that he held hearings this summer on a state water plan and heard repeatedly that there is a state water plan with LB 962, but it lacks funding.

The committee took no action on the bill after the hearing.

NRD property tax levy authority – The Revenue Committee combined two bills dealing with NRD levy authorities into one hearing this week. The bills, LBs 1031 and 1032, are both sponsored by Senator Cap Dierks of Ewing.

LB 1031 eliminates the 2012 sunset date for the NRD three-cent levy in fully and over-appropriated areas and LB 1032 allows NRDs that have been preliminarily determined to be fully appropriated, but later reversed, to have access to the three cent levy to administer and implement ground water management activities and integrated management activities under the Nebraska Groundwater Management and Protection Act.

Kent Miller, Manager of the Twin Platte NRD, testified on behalf of the NARD and his district in support of LB 1031. Miller also provided the committee with a summary of the long-term statutory obligations and needs for the Platte River Recovery Program. These include retiring irrigated acres, river augmentation programs, and providing off-set water for municipal and industrial uses. These programs need to be funded at a proper level to maintain the economic viability of the region.

The bill was also supported by Milt Moravek, Assistant Manager of the Central Platte NRD, and Dennis Schueth, Upper Elkhorn NRD Manager. Letters of support and outlining funding needs came from the North Platte NRD and Tri-Basin NRD.

Dennis Schueth also presented testimony on behalf of the Upper Elkhorn NRD and the NARD in support of LB 1032, which allows NRDs that have been preliminarily determined to be fully appropriated, but later reversed, to have access to the three cent levy to administer and implement ground water management activities, and integrated management activities under the Nebraska Groundwater Management and Protection Act.

Schueth reported that even though the determination has been reversed in his district, the district still has to move forward with studies on groundwater/surface water interaction. This is the same as what happens when the basin is declared fully appropriated. The three cent levy is still needed to do the modeling and studies to help with water management. The Loup, Elkhorn and Lower Platte NRDs are working with DNR and other parties on the Elkhorn Loup Model (ELM). Funding is needed for this study and the districts would like to provide the local funding necessary.

The bill was also supported by Nebraska Farmers Union. There were no opponents to the bill.

The committee took no action after the hearing.

Convention center style funding for water – The Revenue Committee accepted testimony this week on a bill from Senator Mark Christensen to adopt the Agricultural Production and Economic Stability and Assistance Act. The bill, LB 1052, was modeled after the convention center financing in Omaha which allows for a portion of the sales tax generated at the convention center to be retained if certain criteria are met.

The act would assist NRDs with financing the management of water resources and the augmentation of water supplies for the economic stabilization of agricultural production in river basins where state responsibility for interstate compacts, agreements and/or decrees exist. An oversight board would be created to review and approve projects sponsored by a district, joint entity, or joint public agency. If approved by the board, the district, joint entity, or joint public agency would receive state assistance.

The state funding would be used to assist the district, joint entity, or joint agency in financing the project, including repayment of locally issued bonds (LB 701). The state source of funds would come from a refund of a portion of the sales tax collected by retailers doing business within the rapid response area of two and one-half miles on either side of the river, stream or tributary within the eligible district.

There were no testifiers in support, opposition or in a neutral capacity on the bill and Senator Christensen waived closing on the bill. The committee did not take action on the bill after the hearing.

#### Hearings next week

LB852 - Provide for write-in space on official ballots for certain offices. Avery. The bill
eliminates the prohibition of write-in candidates in the primary for directors of NRDs and public
power districts. The bill also eliminates the prohibition of write-in candidates in the general
election for directors of NRDs, public power districts, county weed districts, reclamation districts,
and ESUs.

#### Other Legislative Action

Electric line notice - Senators advanced LB 643 this week to Final Reading after amendments were adopted on General File to change the notice requirement. Originally the bill would have required NRDs to provide 180-day notice to owners of power lines before the district begins altering a road structure or grading or moving earth for a flood control, recreation, or other project if the performance of any work is within ten feet of any electric transmission or electric distribution line, poles, or anchors. If the line, poles, or anchors to be moved are within an area that will require Federal Aviation Administration approval, notice shall be given at least one year prior to the start of any work.

The Natural Resources Committee amendment, **AM1620**, adopted on General File would change the 180 day requirement to 90 days, and removes the language requiring a one-year notice if the equipment to be moved requires Federal Aviation Administration approval.

City noxious weed fund — A bill to allow funds received by cities and counties for noxious weed programs to be deposited in their respective general fund if they do not have a noxious weed fund has reached Final Reading. The bill, LB 731, is sponsored by Senator Utter.

Property tax refund bill indefinitely postponed -- The Revenue Committee killed LB 893, a bill that would have provided a refund mechanism for property taxes, occupation taxes, assessments, and penalties for such taxes declared unconstitutional by any court of competent jurisdiction entered on or after January 1, 2009. The refund could be made without the necessity of filing a claim and would be repaid or refunded to the person paying such tax or assessment. For purposes of this law, a judgment or final order shall mean a judgment or final order of the Supreme Court. The bill was sponsored by Senator Christensen.

RE: February 26 NARD Update

NRD write-in candidates -- The Government Committee accepted testimony on LB 852 this week which allows for write-in space on official ballots for certain offices. The bill eliminates the prohibition of write-in candidates in the primary for directors of NRDs and public power districts. The bill also eliminates the prohibition of write-in candidates in the general election for directors of NRDs, public power districts, county weed districts, reclamation districts, and ESUs.

Under current law, if there are two or less candidates for NRD or public power district directors, the ballot does not have to be printed in the primary election as the candidates would automatically advance to the General Election. It was unclear with the bill under this scenario whether the primary ballot would have to be printed and include a write-in line.

The Nebraska Secretary of State's office testified at the hearing and pointed out that races with two or less candidates for NRD or public power district directors would not have to be on the primary ballot and thus the districts would not have to pay for ballots for additional write-in candidates. Their testimony also pointed out that the ballots could get rather lengthy with the write in spaces for all the lower tier offices.

Bob Hilske, Manager of the Nemaha NRD, testified in a neutral capacity for the Nebraska Association of Resources Districts urging the committee to make sure that the exemption for two or less candidates would apply.

The bill was supported by the Nebraska Association of County Officials and the Papio Valley Preservation Association. The committee advanced the bill to General File without amnendments.

**Hearings end** – This week marked the end of regularly scheduled committee hearings as all bills have now had public hearings. The Legislature will begin all-day debate starting Monday, March 1, which is the 34<sup>th</sup> day of the 60-day legislative session.

#### **General File Action**

Eliminate dedicated water fund source – After almost two days of debate, the legislature advanced LB 689 this week which eliminates dedicated funding sources for the Water Resources Cash Fund.

The bill eliminates the 3/5ths cent/bushel check-off on corn and 3/5ths cent/hundredweight check-off on grain sorghum that was to go to the Water Resources Cash Fund starting on October 1, 2012. The bill also redirects the funds remaining in the Ethanol Production Incentive Cash Fund when the program ends December 31, 2012, splitting it equally with the commodity boards and the general fund. The funds were to go into the Water Resources Cash Fund.

Several state senators argued that the bill should not advance without some back-up plan for funding. Senator Heideman, Chairman of the Appropriations Committee urged caution that large general fund budget deficits are projected in the next few years and that General Fund dollars will be extremely hard to come by. Several urban senators echoed that they do not want general funds used for water programs. Some rural senators also urged caution that the alternative could be worse than the check-off funds.

Senator Dubas' Priority Bill advanced 44-1-4. However, before Select File debate, a meeting including the interested State Senators, ag groups and the NARD will occur to look at alternate funding sources.

Voluntary NRD IMPs -- After brief debate, senators advanced LB 764 which allows a natural resources district encompassing a river basin, sub-basin, or reach that has not been designated as fully or overappropriated to, jointly with the department, develop an integrated management plan for such river basin, sub-basin, or reach located within the district.

The original version of the bill would have required a district to notify the department on or before October 1 of its intention to develop an integrated management plan. The committee amendment strikes the October 1 requirement and leaves it open that a district could notify the department at any time of the year.

Their was some discussion about making sure environmental groups were included as stakeholders for local NRD IMP workgroups, but no amendments were offered as the discussion became how do we list every group, individual or organization in statute without inadvertently omitting someone.

Senator Fischer's Priority Bill advanced 40-0-9.

Contracts with law enforcement – Senator Brad Ashford, Chairman of the Judiciary Committee, has filed an amendment (AM 1976) to LB 817 to allow a natural resources district to contract with law enforcement agencies to patrol district property. The amendment would allow the NRDs to enter into interlocal agreements for the services of certified law enforcement personnel or to contract for the services of private security firms to patrol and protect district-owned recreation areas and to assist law enforcement officers in enforcing sections 2-3292 to 2-32,100 and any rules and regulations adopted and promulgated pursuant to such sections.

The intent of **LB 817** would exempt valid permit holders under the Concealed Handgun Permit Act from also having to obtain a certificate to purchase, lease, rent, or receive transfer of a handgun. The bill is Senator Fulton's Priority Bill for the session.

#### **Final Reading Action**

Electric line notice - Senators gave final approval to LB 643 this week on a 47-0-2 vote. On General File, amendments were adopted to change the notice requirement. Originally the bill would have required NRDs to provide 180-day notice to owners of power lines before the district begins altering a road structure or grading or moving earth for a flood control, recreation, or other project if the performance of any work is within ten feet of any electric transmission or electric distribution line, pole, or anchor. If the line, pole, or anchor to be moved is within an area that will require Federal Aviation Administration approval, notice shall be given at least one year prior to the start of any work.

The Natural Resources Committee amendment, AM 1620, adopted on General File would change the 180-day requirement to 90 days, and removes the language requiring a one-year notice if the equipment to be moved requires Federal Aviation Administration approval.

City noxious weed fund -- A bill to allow funds received by cities and counties for noxious weed programs to be deposited in their respective general fund if they do not have a noxious weed fund was given final approval on a 46-0-3 vote. The bill, LB 731, is sponsored by Senator Utter.

Nebraska litter reduction and recycling – Senator gave final approval on a 46-0-3 vote to LB 798 which extends the termination date for the Nebraska Litter Reduction and Recycling Act from October 30, 2010 to October 10, 2015. Senator Chris Langemeier sponsored the legislation.

Ag land valuation — Senators gave final approval on a 46-0-3 vote to LB 806 which eliminates two references to conditions under which cancellation of special valuation treatment of agricultural land can take place. These conditions are sale to an exempt owner, or sale to a governmental subdivision. These provisions are viewed as obsolete since the repeal of tax recapture provisions. The bill was sponsored by Senator Campbell.

**Private insurance for remedial action** -- A bill to eliminate the private insurance requirement for newly-sited underground petroleum tank owners to cover any remedial action relating to the tank was given final approval on a 45-0-4 vote. The owners of such tanks are currently required to pay for coverage under the Leaking Underground Storage Tank (LUST) Fund. Senator Fischer was the sponsor of **LB 832**.

#### Other Committee Action

Republican River Task Force – The Natural Resources Committee advanced LB 1057 to General File with amendments, which proposes to create the Republican River Basin Water Sustainability Task Force. The adopted committee amendment, AM 1895, replaces much of the bill and maintains the emergency clause. The bill with the committee amendments creates a task force as follows:

- 1. Governor appointments:
  - o Eight from NRDs in the Republican River Basin (Two from each NRD)
  - o Four from irrigation districts in the basin
  - One from each of the following: UNL, Nebraska Game and Parks, Nebraska Department of Agriculture, Nebraska Department of Natural Resources
  - o Two from agriculture-related businesses in the basin
  - One representative each from a school district, city, county, and public power district in the basin.
- 2. The Legislature's Executive Board chairperson is also to appoint three ex-officio, non-voting senators, including two who reside in the basin, and the chairperson of the Natural Resources Committee.
- 3. The task force is to be housed within the Department of Natural Resources for administrative and budgetary purposes, advisory support may be requested from federal and state agencies, and non-state employees are to be reimbursed for expenses.
- 4. The task force is to meet quarterly, may hire a facilitator, and is to convene within 30 days after appointments are completed. The task force is to provide a report to the Governor and Legislature, and is to terminate on June 30, 2012. Also, the intention is stated that expenses are to be paid from funds appropriated from the Water Resources Cash Fund and not exceed \$25,000 per fiscal year.

The bill is Senator Carlson's Priority Bill for the session.

RE: March 5 NARD Update

Anna Baum elected chair of the NRD Managers Committee – Anna Baum, manager of the Upper Loup NRD, was elected chairperson of the NRD Managers Committee this week. Baum is the first female to chair the committee. Coincidently, Mary Ann Wortmann is serving as President of the NARD and the first woman to hold that position. Mike Murphy, the Manager of the Middle Niobrara NRD, was elected vice-chair of the NRD Managers Committee.

#### Committee Action

Occupation Tax – The Natural Resources Committee advanced LB 862 this week to General File with a committee amendment. The bill has not been officially reported out of committee, but will be early next week. The bill makes several changes to the occupation tax on irrigated acres. The bill is sponsored by Senator Mark Christensen and is one of the Natural Resources Committee Priority Bills.

Current law allows districts that contain a river subject to an interstate compact among at least three states and at least one irrigation district within the compact to be able to issue river-flow enhancement bonds. The committee amendment deletes the original bill and replaces that language with the following criteria:

- It has jurisdiction that is part of a river basin for which the district has adopted an integrated management plan (IMP);
- The IMP is in accordance with 46-715;
- The IMP refers to 2-3226.04; and
- The IMP explicitly states the district's intent to utilize qualified projects described in 2-3226.04.

Nebraska Revised Statute 2-3226.04 outlines that the funds shall only be used to pay or refinance the costs of (1) acquisition by purchase or lease of ground water or surface water rights; (2) purchase or lease or the administration and management, pursuant to mutual agreement, of canals and other works, including reservoirs, constructed for irrigation from a river or any of its tributaries; (3) vegetation management, including, but not limited to, the removal of invasive species in or near a river or any of its tributaries; and (4) the augmentation of river flows consistent with the authority granted under Chapter 2, Article 32.

The committee amendment also allows the funds to be used to pay all of or any part of the costs and expenses of one or more qualified projects rather than issuing bonds.

Finally the amendment addresses that for districts that have more than one river basin within its jurisdiction, the occupation tax is to be confined to the geographic area affected by an IMP.

Recreational Trails -- the Natural Resources Committee advanced LB 1010 this week on an 8-0 vote, with Committee Amendment AM 2029 to the floor for debate by the full legislature. The bill establishes a procedure for natural resources districts to use when eminent domain is involved for developing a recreational trail. Several changes to the original bill were made.

Originally the bill called for a 75% board vote in favor of the trail, which is reduced to 67% (2/3rds) by the committee amendment. The amendment also clarifies that private lands included in the bill do not include property under management of the Board of Educational Lands and Funds. The amendment also requires the district to have clear and convincing evidence that the procedures were followed and all of the criteria are met.

The bill is Senator Pankonin's Priority Bill for the session. The bill has not formally been reported out of committee, but will be next week.

Bank lien exemption -- The Natural Resources Committee advanced LB 785 this week, which would provide an exemption from the lien search for transfers of four certified irrigated acres or less. The bill is sponsored by Senator Tom Carlson of Holdrege. The title search requirement was added to state law last year as a way to protect lien-holders from having property devalued as a result of a certified irrigated land transfer. Those involved in drafting the legislation recognized at the time that there was some minimum threshold that should be exempt from the lien search requirements. However, the parties were not able to come to an agreement at the time as to what that threshold would be, so the original legislation was silent on that point.

The committee advanced the bill on a 8-0 vote with an amendment, AM 2090, which adds an exception for a landowner on a single tract of land where there is no reduction or increase in certified acres and the transfer is for irrigation efficiency improvements.

NRD property tax levy authority – The Revenue Committee advanced two bills dealing with NRD levy authorities this week. The bills, LBs 1031 and 1032, are both sponsored by Senator Cap Dierks of Ewing.

The original version of **LB 1031** eliminates the 2012 sunset date for the NRD three-cent levy in fully and over-appropriated areas. The other bill, **LB 1032**, allows NRDs that have been preliminarily determined to be fully appropriated, but later reversed, to have access to the three-cent levy to administer and implement ground water management activities, and integrated management activities under the Nebraska Groundwater Management and Protection Act.

The funds are to be used for water management planning, hydrological studies, retiring water uses, river augmentation programs, and providing off-set water for municipal and industrial uses. These programs need to be funded at a proper level to maintain the economic viability of the local regions.

Even though the determination has been reversed in the Lower Platte Basin, the districts still have to move forward with studies on groundwater/surface water interaction. This is the same as what happens when the basin is declared fully appropriated. The three-cent levy is still needed to do the modeling and studies to help with water management. The Loup, Elkhorn and Lower Platte NRDs are working with DNR and other parties on the Elkhorn Loup Model (ELM). Funding is needed for this study and the districts would like to provide the local funding necessary.

The committee amendments (AM 2040 to LB 1031 and AM 2039 to LB 1032) allow for the authorities in both bills to extend until 2016-17.

NRD director elections – The Natural Resources Committee advanced LB 895 this week on a 8-0 vote without amendments. The bill requires directors appointed to fill vacancies to run for reelection if the appointment occurred before September 1 of the second year of the term. The bill is sponsored by Senator Charlie Janssen.

The Papio Valley Preservation Association (PVPA) requested the bill be introduced so they would have more input on any vacancy that may occur. In their testimony they cited an example of a

vacancy appointment in 2004 by the Papio-Missouri River NRD where not all candidates were considered. The bill does not address the situation described by PVPA of how vacancies are filled.

After the hearing it was discovered that there was not a vacancy appointment in 2004 as claimed by the PVPA. However, there was a vacancy appointment in 2006 that involved six candidates. The PMRNRD allows for all the candidates to come in and make a 20-minute presentation. Prior to the presentation, two of the candidates withdrew from nomination. The remaining four candidates were given consideration before the board voted to select one as the current law outlines. It is assumed the two candidates that withdrew are the ones PVPA claimed were not considered.

NRD write-in candidates -- The Government Committee advanced LB 852 this week which allows for write-in space on official ballots for certain offices. The bill eliminates the prohibition of write-in candidates in the primary for directors of NRDs and public power districts. The bill also eliminates the prohibition of write-in candidates in the general election for directors of NRDs, public power districts, county weed districts, reclamation districts, and ESUs.

Under current law, if there are two or less candidates for NRD or public power district directors, the ballot does not have to be printed in the primary election as the candidates would automatically advance to the General Election. This does not change under the bill.

The Nebraska Secretary of State's office testified at the hearing and pointed out that races with two or less candidates for NRD or public power district directors would not have to be on the primary ballot and thus the districts would not have to pay for ballots for additional write-in candidates. Their testimony also pointed out that the ballots could get rather lengthy with the write in spaces for all the lower tier offices.

The bill was supported by the Nebraska Association of County Officials and the Papio Valley Preservation Association. The committee advanced Senator Avery's bill to General File without amnendments.

#### **General File Action**

Contracts with law enforcement – On General File this week Senator Brad Ashford, Chairman of the Judiciary Committee, filed an amendment (AM 1976) to LB 817 to allow a natural resources district to contract with law enforcement agencies to patrol district property. The amendment was withdrawn after realizing the amendment included an incorrect reference. The amendment is the language from LB 795.

Senators advanced the bill to Select File and a subsequent amendment, AM2096, has been filed which corrects the error and would allow the NRDs to enter into interlocal agreements for the services of certified law enforcement personnel or to contract for the services of private security firms. Senators will debate the amendment when the bill comes up on Select File.

The intent of LB 817 would exempt valid permit holders under the Concealed Handgun Permit Act from also having to obtain a certificate to purchase, lease, rent, or receive transfer of a handgun. The bill is Senator Fulton's Priority Bill for the session.

#### Select File Action

Eliminate dedicated water fund source – The legislature advanced LB 689 to Final Reading this week which eliminates dedicated funding sources for the Water Resources Cash Fund.

The bill eliminates the 3/5ths cent/bushel check-off on corn and 3/5ths cent/hundredweight check-off on grain sorghum that was to go to the Water Resources Cash Fund starting on October 1, 2012. The bill also redirects the funds remaining in the Ethanol Production Incentive Cash Fund when the program ends December 31, 2012, splitting it equally with the commodity boards and the general fund. The funds were to

go into the Water Resources Cash Fund. Several state senators argued that the bill should not advance without some back-up plan for funding.

Three other bills were advanced this week dealing with local funding. The Revenue Committee advanced LBs 1031 & 1032 to allow for local NRDs to continue to raise funds locally through 2017 and the Natural Resources Committee advanced LB 862 to make modifications to the occupation tax on irrigated lands.

Senator Heideman, Chairman of the Appropriations Committee urged caution that large general fund budget deficits are projected in the next few years and that General Fund dollars will be extremely hard to come by. Several urban senators echoed that they do not want general funds used for water programs. Some rural senators also urged caution that the alternative could be worse than the check-off funds.

**Voluntary NRD IMPs** -- After brief debate, senators advanced **LB 764** to Final Reading which allows a natural resources district encompassing a river basin, sub-basin, or reach that has not been designated as fully or over-appropriated to, jointly with the department, develop an integrated management plan for such river basin, sub-basin, or reach located within the district.

The original version of the bill would have required a district to notify the department on or before October 1 of its intention to develop an integrated management plan. The committee amendment strikes the October 1 requirement and leaves it open that a district could notify the department at any time of the year.

There was some discussion about making sure surface water groups were included as stakeholders for local NRD IMP workgroups, but no amendments were offered as the discussion became how the Legislature lists every group, individual or organization in statute without inadvertently omitting someone. On General File similar debate occurred concerning environmental groups, but no amendments were offered.

#### Other Issues

Water quality improvements and off-sets -- Recently, the Nebraska Game and Parks Commission had commented on the NDEQ draft National Pollutant Discharge permits and requested/suggested municipalities and NRDs find off-sets for water quality improvement projects that may result in a depletion of stream flow volume with the emphasis on the Lower Platte River. This portion is not fully appropriated and no requirements for offsets are in state law for these areas. The NGPC is making this request over concerns with stream flows for endangered species including the pallid sturgeon.

Communities targeted on the issue are ones that have to install new sewage treatment facilities rather than discharging. It is the lack of discharge that NGPC is stating causes the negative impact to stream flows.

The Department has been working through these by demonstrating the loss of flow would be negligible and the impact to the river would be de minimus. These comments and evaluations are expected to increase as more small communities work to meet more stringent permit limits.

NRD Groundwater Technician Training and Water Programs Conference — This week the NRD groundwater technician training and NRD Water Programs Conference was held in Kearney, Nebraska. The training was attended by 14 NRD staff and provided initial certification training and continuing education units. The conference was attended by approximately 100 NRD staff and conservation partners. The program included talks on the Platte River, Republican River, Niobrara River, agency updates, Hastings Wellhead Protection Program, Nebraska Rural Water and the well grout study. Application will be made for six CEUs for all classes of water well licenses.

NARD Washington DC Conference -- Representatives of Nebraska's NRDs will be participating in the annual NARD Washington DC Conference next week to discuss natural resources management issues with federal agencies and the Nebraska Delegation. The conference also includes a tour of the water quality concerns of the Chesapeake Bay.

As a follow up to Olsson's Associates request for additional services for the 404 permitting of the Silver Creek Watershed Project, I am providing this letter as a clarification for prior expenditures made under the existing construction observation budget and our use of these funds in the future. Previous contract amendments are summarized and then discussed in more detail below.

#### Work Currently Under Contract

Total Contract Cost:	\$619,264.00
February 2010 Add Services	\$42,180.00
December 2007 Add Services:	\$81,850.00
October 2006 Add Services:	\$78,492.00
Original Contract:	\$416,742.00

The original contract, approved in December 2004, included a budget for construction observation in the amount of \$125,738. Due to some additional construction work provided by Taylor's Excavation as a sub to Olsson's, the total of this budget was expended during the construction of eight of the Silver Creek structures. Therefore, as part of the October 2006 amendment, \$53,500 in additional services was added for the construction observation of Silver Creek Sites 11 and 35. It was assumed in this estimate that Sites 11 and 35 would undergo construction at the same time and both over a 20-week period at an average of \$2,675 a week.

After additional preparation of construction documents, it was realized that this may not be enough for the nuclear density testing necessary during the projected 20 week construction period. In addition, there were necessary repairs on existing Silver Creek sites which required professional construction inspection. These additional considerations were included as part of the December 2007 contract amendment and added \$11,350 to the \$53,500 budget. This made the total construction observation budget \$64,850 for the remaining Silver Creek sites.

Currently, Olsson has invoiced for \$13,605.75 of this construction observation budget, leaving \$51,244.25 remaining. The majority of these charges (~\$8,700) have occurred in the form of project management and administration prior to construction from the period of December 2007 through today. This is primarily due to the fact that the duration of the project has extended well

beyond what was envisioned at the end of 2007 and several revisions have occurred during that period. These changes have required additional survey and modifications to plans that must be made prior to letting a bid for construction. Olsson staff has charged for several revisions over this period to the land rights map required to determine the extent of easements necessary before construction can begin. A breakdown of the cost and some examples of the work completed is attached for your review.

Additionally, almost \$4,900 of the \$13,605.75 was paid to Norm Koester and Lee Applebee as sub-consultants who provided additional construction observation necessary for the repairs needed to some of the existing Silver Creek sites. As the responsible engineer for these structures, Norm Koester was able to direct the repairs without having to prepare expensive plan modifications.

Despite the expenses that have already occurred prior to construction actually starting on Site 11, Olsson Associates is committed to completing the construction observation scope of services already under contract within the budget remaining and without any more amendments for additional fees. To do this, we will reinstate enough dollars (from what was remaining before the last amendment) to bring the remaining \$51,244.25 back up to at least \$55,000. This \$55,000 will only be used to cover time and expenses related to construction administration (including bidding) and construction observation. This is documented in the attached invoice for February.

You will also notice in the attached invoice that we have credited the District \$511.17 for airfare previously billed. This airfare was an expense for 2 trips made by Scott Dicke, an environmental scientist in Olsson's Denver office, for 404 permit meetings with the U.S. Army Corp of Engineers. Prior to some changes in staff, this service could have been provided from our local Omaha or Lincoln office and wouldn't have required travel expenses. For this reason, we have removed these charges.

In summary, we apologize for any inconvenience or confusion caused by our billings. It is my pledge that we will complete this project without any additional fees needed for construction administration or observation.





# Whitted Creek project all done but the planting By Jason Glenn

An innovative project to rehabilitate a badly eroded creek near 25th Street and Capehart Road is almost complete. The Papio-Missouri River Natural Resources District's Whitted Creek Stream Rehabilitation Project was started late last summer and uses a biological engineering hybrid method that stabilized the channel bed and stream banks to prevent additional erosion with well-vegetated bank slopes and a series Of control structures. "What we have left is the plantings," said Marlin Petermann, PMRNRD assistant general manager. "It got a little bit late and we thought it would be

Petermann said alk the main construction on the project, which included reshaping the creek bed and installing large rocks in configurations called cross vanes that divert water flow away from the banks, was finished in November. The project's contractor, Heimes Corporation, has also laid down biodegradable fabric to help stabilize the banks, Petermann said. What remains is the planting of native grasses, shrubs and trees along the banks of the stream to help filter runoff and provide a buffer zone between the water and adjacent land use. The state-of-the-art methods being used on the 3,000- f t section of Whitted Creek are PMRNRD's first foray into a more environmentally friendly approach to creek rehabilitation. "Using this kind of natural channel design, that area was a move toward a more sustainable design in our erosion and flood control projects," Petermann said. Whitted Creek was relocated and straightened in the early 1900s to free up farmland. Though flood control levees were installed in the 1960s and improved in the 1980s, increased urbanization in the area and upstream had led to severe erosion that endangered nearby homes. The project, which cost about \$1.5 million, is being funded by the NRD and by grants from the Nebraska Environmental Trust and Nebraska Department of Environmental Quality. Some Of those funds are from the U.S. Environmental Protection Agency.

### Corps: Dams may need repairs

Repairs may be required on five Lincoln and Omaha-area lake dams the U.S. Army Corps of Engineers has determined may have potential seepage problems.

The corps announced on Tuesday the potential problems exist along the outlet conduits at five Lincoln-area dams. They are located at Branched Oak, Holmes, Olive Creek, Wagon Train, and Stagecoach lakes.

The corps is also reviewing whether the embankment of the dam at Glenn Cunningham Lake in Omaha is damaged.

The potential problems were identified using a new dam-classification system used to screen dams.

There is no evidence to suggest an emergency situation exists, or is about to occur, at any of the dams.

### Shack to aid river research

Collaboration is good. And when the collaboration is between University of Nebraska faculty and employees from other state agencies, the result can be very good.

On the banks of the Elkhorn River, on the western edge of Douglas County, such a collaborative effort is taking shape.

Individuals from the University of Nebraska at Omaha, the University of Nebraska Medical Center and the Papio-Missouri River Natural Resources District are working together to construct the Davis Prairie Data Shack. The Shack, as it is informally called, will be located on a piece of land owned by the University of Nebraska Foundation and leased to UNO.

The Shack will ultimately become a field station from which information on the Elkhorn River will stream back to UNO. The information will not only include data but also video clips produced by professors, university students and local high school students from Omaha and beyond.

The video clips will be developed on a variety of topics ranging from water quality to environmental health to social issues. These video clips will be uploaded to a Web site developed by UNO and available for free to the public as a community service.

Our students and in-state collaborators have worked on the Elkhorn River for the past decade. During those 10 years, we have witnessed some disturbing trends in water quality.

Our team cages local fish throughout the watershed. Within seven days, the females become verifiably less feminine. This observation has been seen repeatedly and has been replicated in laboratory experiments where field waters and sediment from the Elkhorn River have been returned to UNO.

Our collaborative team is confident that the sexual alteration of these female fish is due to chemical contaminants; however, the specific contaminant or chemical mixture has been elusive. Research to date, while compelling, has been thwarted by several confounding factors, including seasonality, drought, flash floods, water temperature and vandalism.

This is where the Shack will come in handy. The Shack will provide our team with a secure location from which to monitor water-quality issues within the Elkhorn River, three seasons per year, for many years to come.

The defeminization of fish has occurred far upstream from Douglas County, and there is no indication that the water at this site is polluted. Nevertheless, the Shack will allow for longterm monitoring of a watershed that may be under stress from both urban and rural activity.

Because information from the Shack will be available online, it is likely to enhance the overall visibility of this collaborative program.

Collaboration is, indeed, a good thing. And the collaborative efforts at work in the lower Elkhorn River will allow Nebraskans to ensure that the good life that all residents share is sustained well into the future.

### Flooding threat speeds up levee work near Ashland

ASHLAND – Crews are working around the clock to build levees along the Platte River near Ashland as weather conditions increase the potential for flooding.

Officials with the U.S. Army Corps of Engineers, Lower Platte North and Papio-Missouri River natural resources districts, Saunders County Public Works Department and the Nebraska Military Department met Jan. 29 to discuss preparations for the threat of flooding from ice jams and thawing snow.

One day later, crews were moving dirt and building levees at four areas – two around Camp Ashland and at Thomas Lakes in Saunders County and one at Beacon View in Sarpy County, said Marlin Petermann, assistant general manager with the Papio-Missouri River Natural Resources District.

Petermann said they are filling in gaps in the Western Sarpy/Clear Creek Levee Project that has been underway since 2005 and runs along both sides of the Platte River from Thomas Lakes south to Highway 6.

These gaps were already scheduled for completion, Petermann said, but the work has been expedited in light of the flooding threat.

"We took the contractor off winter shut down to do work," Petermann said.

TCW Construction Inc. of Lincoln is doing the work, employing crews around the clock to meet a quick deadline. Petermann said the project should be completed by Feb. 15.

"It's a very aggressive schedule," Petermann said.

Of the four areas of the levee that will be completed, the levee being built near the south entrance of Camp Ashland will be installed on a temporary basis, said Capt. Nicholas Breen, who manages operations at Camp Ashland.

"They are taking temporary measures to seal it off," he said.

Breen said the levee will not be permanent because the final studies have not been completed yet on this particular site. When the permanent levee is built, the materials used in the temporary levee will be reused elsewhere in the project, he added.

Breen also said the temporary levee is in place to prevent flooding from the Platte River, but would need to be taken down if flooding from nearby Salt Creek threatens from the other direction.

Funding for the final phase of this \$30 million project will remain as it has since the beginning of the Western Sarpy/Clear Creek project – with the Corps of Engineers footing 65 percent of the bill and the remaining 35 percent spread between the State of Nebraska and the Lower Platte North, Lower Platte South and Papio NRD's.

Petermann said the levee work was sped up because of two weather factors that could bring flooding to the area.

First, the ice is thick on the Platte, between 15 and 18 inches thick, he said.

"It's enough to create potential problems," he added.

That, combined with large snowfall in the north central and northeastern parts of Nebraska that will eventually melt and runoff into the Platte and Elkhorn rivers, are cause for alarm.

"Those two factors indicated a relatively high probability for ice jam flooding this spring," Petermann said.

With the amount of snow that has fallen this winter, Saunders County Public Works Director Steve Mika said it did not surprise him that Corps officials were worried about the amount of water that would be forced into the Platte should the area see a rapid warm-up.

"It sounds like it was an emergency situation," added Mika.

Along with the levee construction, other measures are being taken to prevent flooding.

Last Friday, Gov. Dave Heineman declared a state of emergency due to the potential for ice jam-related flooding along the lower Platte and its tributaries.

The Corps of Engineers is recommending ice dusting along the Platte from Sarpy County to North Bend, with particular attention being paid to the area where the Platte and Elkhorn rivers meet, also the site of the levee project.

Ice dusting will begin Feb. 15, after the sun has reached a better angle in the sky, Petermann said.

"The sun angle is a little bit higher in the sky and will do a better job of melting the dark material that is placed on the ice to get better penetration," he said.

The dust is made up of coal slag and ash from power plants, Petermann said. It is applied with a crop dusting plane.

### Papio-Missouri NRD to vote on share of work near creek

La Vista and the Papio-Missouri River Natural Resources District hope to split the local costs of securing a \$2.1 million federal grant to buy and bulldoze 24 homes along erosion-troubled Thompson Creek.

The grant would pay for 75 percent of the erosion-control project's \$2.7 million costs. The City of La Vista and the NRD would cover the remaining 25 percent, with each providing \$340,155.

The NRD plans to vote on its share of the cost at its 7 p.m. meeting today at the Chalco Hills Recreation Area. La Vista approved its share last week.

Thompson Creek from 72nd Street to the La Vista Falls Golf Course has long been a problem for La Vista and the NRD.

Over the years, the banks along the creek east of 84th Street have collapsed, claiming fences, utility poles and outbuildings.

"I think the district and our communities will see issues with our creeks and streams becoming more prevalent," said John Winkler, general manager of the NRD. "People are paying more attention to that ditch in their backyard ... when their swing set or fence falls into it."

Under the project, no La Vista property owners would be forced to sell or vacate their homes through condemnation, a city official said Wednesday.

"That cannot happen," said Mitch Beaumont, La Vista's community relations coordinator. "The city is committed to working with every one of the residents and homeowners to make sure the process moves forward in a fair and accessible manner." La Vista targeted 24 homes for demolition, which Winkler said is vital for engineers to make longterm fixes to the creek.

The lots on that side of the creek would be maintained as open space for easier maintenance of the creek. The project will repair the existing erosion damage, relocate power lines and allow for future construction to protect the homes that remain.

The entire project should take a little more than two years to complete, officials said.

The city plans to meet with affected property owners this spring, then appraise the homes of those interested in selling.

Officials want to sign purchase agreements by the fall, with demolition to begin in 2011.

The Papio-Missouri River Natural Resources District is hoping to issue \$13.3 million in bonds for projects in its district.

The NRD, which was granted bonding authority through Legislative Bill 160 last year, exercised the right at its Jan. 14 meeting, asking its board to grant a motion to issue the bonds. According to memorandums from the NRD, the bonds will be used for projects in Waterloo, Papillion, Omaha and the greater Douglas and Sarpy county areas.

But controversy has been swirling around the bond request.

 When the NRD asked its board to approve the bonds on Jan. 14, it did not have a complete list of what projects the bonds were going caused the motion to fail in a 5-5 split vote.

"There was so much confusion on what they were voting on and what projects it would be used for," said

Kevin Propst, chairman of government affairs for the Papio Valley Preservation Association. Propst was present at the meeting and was instrumental in getting protections installed on the bill granting the NRD bonding.

Washington County residentand NRD board member Scott Japp voted against the bond.

The Washington County board reacted swiftly to the NRD's request:

In a letter to the NRD board, Washington County Board chairman Harlo Wilcoxwrotethatthecountyfelt the NRD was circumventing the intent of LB 160 by not informing the public and the boards involved what the bonds would be used for....-

LB160 states that a county has the ability to pass a resolution disapproving of to be used for, which is what <u>a bonded project within 90</u> days after the NRD gives notice to issue the bonds.

### NRD board OKs bond issue on second try

Four weeks after coming up dry, the Papio-Missouri River Natural Resources District approved a bond issue for dams and levees in eastern Nebraska.

The NRD board voted 9-2 to issue \$13.3 million in bonds to bolster flood-control efforts in its six-county area.

"This was a historic vote," said John Winkler, district manager.

He said the funds would allow the NRD to accelerate its efforts to protect lives and property from potentially devastating floods, without raising the district's tax levy.

The money would fund a dam in Sarpy County to protect Papillion from West Branch Papillion Creek flooding; a Clear Creek flood-reduction levee; a dam near Hubbard in Dakota County; and the rehabilitation of the Waterloo levee on the Elkhorn River.

Other projects funded in the Thursday vote include creating a water-quality basin to protect Omaha's Zorinsky Lake from further degradation and a program to remove floodway obstructions.

Issuing bonds is a new funding method that the Legislature approved for natural resources districts last year.

The Papio NRD board's first attempt to issue water-enhancement bonds failed in a 5-5 vote in January.

That came after three members of the public said the process for spending the money wasn't transparent. Passage required a two-thirds majority.

The Papio NRD has been working with area cities, villages and counties to develop flood-control and water-quality measures for years, Winkler said.

Growing urbanization has created larger floodplains in the Papillion Creek watershed, threatening more homes and businesses than ever before.

ects in Washington County. the NRD has deprived Washington County of its ability to disapprove of the projects within its exclusive zoning jurisdiction. Because the NRD refuses to specify its need for the \$13.3 million in bonds, Washington County is 'left in the dark' as to its true intent," Wilcox wrote.

The board's letter further stated its disfavor of the bond request and to ask the NRD to specifically state the bonds' purpose.

The Douglas County Board wrote a similar letter to the NRD board.

In reaction to the letters. NRD general manager John Winkler fired back. In a letter dated Feb. 5 sent to all Washington County board members, Winkler said that only the county board of an affected county may pass a resolution stating that it does not approve of the construction of a project greater than 20 surface areas within its exclusive zoning jurisdiction.

He went on to state that affected projects do not reside within Washington County's zoning jurisdiction. A memorandum outlining which projects the \$13.3 million in bonds would be used for was issued Feb. 8.

"Therefore, the Washington County Board is in no way statutorily obligated to be notified or approve or disapprove of the bond issuance by the Papio-Missouri NRD. If and when a project or projects to be funded with bond proceeds does reside within Washington County's exclusive zoning jurisdiction the Washington County Board will be notified as an affected county and the county board and its constituents will be given the statutory opportunity to approve or disapprove of

### Coal ash will fight flooding

For only the fourth time in about three decades, the state will scatter coal ash over the Platte River with hopes of reducing the threat of ice jams and flooding.

Al Berndt, assistant director of the Nebraska Emergency Management Agency, said Tuesday that officials are worried by the unsually deep and widespread snowpack in northeast Nebraska and stubbornly thick ice on the river

A crop duster will drop about 86 tons of ash over about 10 spots along the river on Thursday, Berndt said.

The ash comes from the Nebraska Public Power District coal plant near Hallam.

The hope is that the dark ash will absorb the sun's energy and help "rot" the ice so it breaks up into smaller chunks and washes downstream, Berndt said.

Larger ice chunks can jam together like a dam and send floodwaters washing over levees.

Success is not guaranteed. But there are no other preventive steps officials can take.

An alternative, something not espoused by state or federal officials, would be to dynamite the ice. A last resort undertaken only after an ice jam occurs, dynamiting is a decision left to local authorities.

Among the sites that are a priority for dusting, Berndt said, are locations downstream of the confluence of the Platte and Elkhorn rivers.

Berndt said officials want to help make sure the Platte is open and able to accommodate water flowing into it from the Elkhorn and its tributaries. Those rivers are not being dusted because the airplane cannot safely maneuver above their sinuous channels.

The Platte is one among many rivers at risk for flooding. Officials across the Plains and Midwest are monitoring rivers and snowpack.

For now, the Platte is the only river in Nebraska and Iowa targeted for dusting, said Paul Johnston, spokesman for the U.S. Army Corps of Engineers. Federal approval is require to dust a river.

Marlin Petermann, assistant general manager of the Papio-Missouri River Natural Resources District, said ice on the Platte is averaging about 16.7 inches thick. That's in the range that can pose problems, he said.

The cost of the dusting is expected to be less than \$100,000 Berndt said. Petermann, who has spent much of his 35-year career watching the river, said it's money well spent.

"Boy, anything we can do to help prevent flooding and save millions of dollars and potentially lives, it's a small investment."

### Cass County, NRD agree to work together on MoPac Trail

Cass County and Lower Platte South Natural Resources District officials took a big step to resolve an impasse over a key segment that would help finish a recreational trail between Lincoln and Omaha.

Both agreed this week to sign a memorandum of understanding to work together evaluating potential corridors for the segment officially known as the MoPac East/Lied Platte River Bridge connection.

The goal is to "find an acceptable corridor for making the connection" by July, said NRD general manager Glenn Johnson.

Until now, the NRD has been discussing the segment project with individual members of the Cass County Board. Johnson said the agreement represents a commitment by the entire government body.

The NRD Board approved the agreement Wednesday, a day after the Cass County Board approved it. Several NRD officials were present for the county board's unanimous vote.

"I thought the meeting went very well," said NRD chairman David Potter. "I think they are willing to work with us."

Under the agreement, the NRD will take care of the technical aspects of the trail segment project and Cass County will lead public involvement, including holding public meetings for concerned residents.

In choosing a final route, both have agreed to consider trail user safety, right-of-way requirements, opportunities for economic development, impacts on adjoining properties and trail functionality.

Twenty to 30 landowners opposed a route the NRD chose about a year ago. They especially did not like the use of eminent domain to obtain right-of-way.

Last May, the NRD imposed a moratorium on the project because of growing opposition -- which included proposed legislation to limit the eminent domain powers of the state's 23 natural resources districts.

Now, the next step is to meet with the state Department of Roads to review the findings of a cursory review of a corridor that appears to be agreeable to Cass County and the NRD.

Basically, the corridor would start in Elmwood and continue north on Nebraska 1 to Murdock. The trail would follow 310th Street to Nebraska 66 and into South Bend, where it would connect with the Lied Platte River Bridge.

Johnson said the segment would have to use right-of-ways owned by the roads department, so they would need that agency's approval.

Johnson said the roads department has indicated a "willingness" to consider the route, but a meeting has not yet been scheduled.

### Huge snow 'lakes' watched warily

Are the preparations enough? Now we mostly wait, hoping the thaw doesn't unleash torrents B Y NANCY GAARDER AND ELIZABETH AHLIN Omaha World Herald

About 2,000 sandbags are stockpiled in Spencer, Iowa, in case the Little Sioux River spills over its banks.

Farther south, the town of Red Oak has three flood pumps, purchased in 2008, ready to divert water if the East Nishnabotna River breaks loose.

Near Ashland, Neb., crews have been working day and night to strengthen Platte River levees.

And from the skies over the Platte, a crop-duster Thursday began dropping coal ash on stretches that are prone to ice jams and flooding. The hope is that the dark ash absorbs enough of the sun's energy to create fissures in the ice, allowing it to break apart more easily.

As spring approaches, astonishing amounts of water are locked in the snow covering northeastern Nebraska, northern Iowa, the Dakotas and portions of Minnesota.

"It's been a long, brutal winter, and people need to be prepared for widespread flooding if they live near a major river," said Doug Clemetson, chief of hydrology for the U.S. Army Corps of Engineers in Omaha.

Clemetson said there is a high probability of moderate to major flooding in eastern Nebraska and western Iowa, and northward into Minnesota and the Dakotas. Parts of the Dakotas could see record flooding, he said.

However, Clemetson and others point out that no one really knows yet just what might happen.

A slow snow melt would help immeasurably. A rapid melt, accompanied by early rainstorms, could be disastrous.

To understand the problem, picture a vast shallow lake covering northeastern Nebraska and northwestern Iowa — a basin that's ready to drain at a moment's notice.

The amount of water in the snow varies, but according to readings from last week that were provided by Clemetson, the depth of that lake would average: • 2.6 inches over about 9,500 square miles of the lower Platte River basin in eastern Nebraska, roughly from Columbus to Louisville.

- 4.7 inches over 3,500 square miles of the Little Sioux River basin upstream from Turin in northwestern Iowa.
- 6 inches over 1,000 square miles of the Little Sioux basin upstream of Spencer.

The possibility of flooding weighs heavily on officials in western Iowa cities and counties, but many say there's not much they can do except wait and hope that the protections already in place will be enough.

"We just have to wait and see what Mother Nature has in store for us," said Brad Wright, city administrator for Red Oak, the Montgomery County community that purchased the flood pumps.

In Spencer, where the sandbags are ready, Public Works Director Mark White said the city will be checking its

storm gates and flood pumps.

"I'm pretty confident we'll be OK," White said.

Flood insurance is one of the few protections available to individual property owners.

Experts advise that property owners not take false comfort from the existence of a levee or from being told they're not in a flood plain. Levees only reduce the risk of flooding, and flood plain maps can be inaccurate.

Asked about flood insurance, a Corps of Engineers spokesman offered some blunt advice: "Better hurry," Paul Johnston said. "I'm not trying to be flip, but there is a 30day waiting period" before a new policy takes effect.

Little can be done at this point, outside of coal-ash dusting, to prevent the actual flooding.

The Platte River ice dusting isn't a sure thing. But with an expected cost of less than \$100,000, it's worth a try given the potential for flooding, state officials said.

"There's a high probability of flooding," said Al Berndt, assistant director of the Nebraska Emergency Management Agency, which ordered this week's dusting.

This is the fourth time since 1979 that the Platte has been dusted. The last time was in 2001, and the river didn't flood.

This year's flooding risk is due not only to the snow cover but also to the thickness of the river's ice.

In the past week, the ice on the Platte thickened slightly, according to Rich Tesar, a board member of the Papio-Missouri River Natural Resources District.

The average thickness at Union Dike, north of Valley, was 17.1 inches, he said Thursday. A week ago, it averaged 16.7 inches.

The thicker the ice, the larger the ice chunks will be when the river starts to break up. Big chunks are more likely to jam and block the river's flow.

Officials hope the dusting will weaken the ice and cause it to break into smaller pieces.

Tesar, who has lived along the Platte for about 50 years, doesn't think the river will flood significantly. He said he has toured the river and is confident that all the major levees, dikes and dams will hold.

Signs point to a potential for "some lowland flooding. But we won't, I would bet, have a disaster," he said.

Still, he said, this week's slight thickening of the ice gives him pause.

Cindy Newsham, spokeswoman for the state's Emergency Management Agency, said the Platte River ice thickness varies from 13 inches to 22 inches. That pales in comparison with 1978, when the ice near the Union Dike was 36 to 40 inches deep.

The Union Dike broke in the spring of 1978, putting Valley under water and causing an estimated \$240 million in damage. A 1989 project strengthened the dike.

"The Union Dike has been strengthened many times over, but there are other points along the Platte and

Elkhorn we watch very closely," Tesar said.

Ice dusting can't be done on most rivers.

Parts of both the Elkhorn and Loup are believed to be at as much risk of flooding as the Platte. Neither is being dusted because each is too narrow and winding for a pilot to maneuver safely, according to a Corps of Engineers analysis.

The crop-duster pilot flies about 100 mph at treetop level to better guarantee that the coal ash hits the target. While the material is called ash, it has the texture of grit.

Ten sites are being dusted in what is expected to be a two-day effort. Seventyseven tons of ash will be dropped, Berndt said.

The sites start at the Interstate 80 bridge near Mahoney State Park and end upstream, near North Bend. The 10 sites were selected because they are traditional trouble spots, Newsham said.

Near Camp Ashland, the Corps of Engineers and the Emergency Management Agency determined that there was a high probability of flooding at gaps in the levees along the Platte.

The strengthening work being done there runs along both sides of the river, from Thomas Lakes south to U.S. Highway 6.

Today, the National Weather Service will update its flood forecast for the region.

Jeff Reese, hydrologist with the weather service office in Valley, said he's also concerned by the snow cover numbers he's seeing.

But there have been many years when nature takes care of the problem with no serious consequences to humans, he said.

"You certainly have to be aware of the fact that we have a lot more snow than we are used to. But a lot of the time we've sweated this in the past, then the ice fractures and it flushes itself out," Reese said.

### Fontenelle Hills watershed study continues

A U.S. Army Corps of Engineers study to develop a plan for storm water control in the Fontenelle Hills area should be completed sometime this fall.

Jeff Greenwald, project manager of the watershed stabilization study, said he had met with the sponsors of the project, the City of Bellevue, the Papio-Missouri River Natural Resources Department and Fontenelle Forest, in December.

Greenwald said they discussed how the study would proceed and what some of the approaches could be for mitigating erosive damage from heavy rainfall runoff in the area.

The study focuses on three watersheds in the area – Coffin Springs Hollow, Childs Hollow and Mill Hollow. Greenwald said during the discussion the sponsors suggested any work, such as building detention ponds, might start at Coffin Springs Hollow first. However, the Corps study will have to be completed before any work begins.

Costs for the \$160,000 study are split evenly between the federal government and non-federal entities. The non-federal portion is being funded by a \$50,000 grant from the Nebraska Environmental Trust, and \$10,000 each from the Fontenelle Nature Association, City of Bellevue and the Papio Missouri NRD.

### Flood risk outweighs coal ash concerns

■ Contaminants are well within the strictest standards, state and federal officials say.

Environmental regulators go to great pains to keep coal ash out of rivers.

After all, it often contains lead, selenium, mercury and other pollutants that can harm aquatic life.

So why would Nebraska environmental regulators allow state emergency officials to dust the Platte River with 77 tons of the ash as they did on Thursday?

The Platte is home to endangered species, and its aquifer supplies drinking water to the state's largest cities.

Turns out, according to Nebraska and federal environmental officials, the contaminants in the ash occur at levels far below even the strictest water quality standards.

"The material is pretty benign, so if you weigh what we could be saving in terms of ... damage from a flood, it outweighs environmental concerns — based on the science," said Mike Linder, director of the Nebraska Department of Environmental Quality.

The ash comes from the Nebraska Public Power District coal plant near Hallam, Neb. Samples from the plant were tested four times in the 1990s — 1990, 1993 and twice in 1994 — and OK'd as part of the regulatory process that permits the use of only Hallam ash on the Platte, according to state environmental regulators.

"These are extremely low levels," said Donna Garden, who oversees the section of the department that regulates the discharge of pollutants into waterways.

Six contaminants were found at detectable levels in all four tests, according to Brian Mc-Manus, a department spokesman. But even though 77 tons of ash was used, the total amount of those six contaminants (barium, cadmium, chloride, selenium, nickel and zinc) is probably a couple of ounces, according to the test results.

Garden said the strictest standards were used, including the threshold for what's permissible in a glass of drinking water. That standard was used in screening for cadmium, a carcinogen.

Federal drinking water standards permit 2.3 milligrams of cadmium per kilogram of drinking water. The highest concentration of cadmium in this ash, according to the four tests in 1990, was .01 milligram per kilogram.

For contaminants without specific drinking water standards, Garden said, the department evaluated the contaminants based on the potential effects they might have on aquatic life and people who get in the water.

That did little to allay the concerns of someone like Don Murh, an Omahan who contacted The World-Herald after learning of the river dusting.

"There's been quite a discussion among people who aren't very happy about this," said Murh, an auditor at a local insurance company. "I'm not a scientist. I just have a pretty regular job, but this doesn't sound like something we should be doing, because we already have issues that need to be taken care of."

Murh is dissatisfied with the quality of Omaha's drinking water and concerned about the health risk posed by

lead contamination in soil in eastern Omaha. From his point of view, the ash simply adds to Omahans' environmental burden.

A federal environmental regulator who read through Nebraska's test results said the state has "done its homework."

Glenn Curtis heads the water quality permitting process for the federal Environmental Protection Agency regional office that oversees Nebraska.

Curtis said Friday the state's data indicates that the contaminants in the type of ash being used, called bottom ash, are bound tightly to it and do not dissolve easily in water. Essentially, he said, the contaminants would not be detectable in water.

Furthermore, he said, the data indicate that the ash did not harm the aquatic organisms it was tested on, including protozoa, minnows and water fleas.

"(Nebraska) has run the tests, and this looks fairly benign," he said.

Coal ash is of serious concern to some environmentalists. Among those who have offered testimony to federal regulators is Dennis Lemly, a research professor of biology at Wake Forest University.

Lemly said this use of bottom ash "should be OK."

Bottom ash contains about 10 percent of the toxic materials that fly ash does, he said. Bottom ash is the heavy material that drops to the bottom of a coal furnace while fly ash is the light, fluffy ash that floats upward and can be trapped by pollution equipment.

The state's use of bottom ash, combined with the size of the river and the fact that the ash will enter the Platte gradually as the ice melts "should pose little risk to aquatic life," Lemly said.

The dusting was done at the behest of the Nebraska Emergency Management Agency under an emergency order issued by Gov. Dave Heineman. That means that even if the ash violated state standards, Heineman's order trumps them.

Al Berndt, assistant director of the emergency response agency, said the state is trying to protect, among other areas, well fields for Lincoln and Omaha water, a BNSF railroad bridge, a Nebraska National Guard camp and numerous homes.

In addition to the dusting, government agencies have been working to repair four holes in the levees protecting the area.

The U.S. Army Corps of Engineers has concluded that there is a high probability of moderate to major flooding in northeastern Nebraska.

However, on Friday, an updated flooding forecast issued by the National Weather Service in Valley indicated that the threat may end up no greater than minor to moderate.

This is the fourth time in 30 years that Nebraska has dusted the Platte. Officials hope the dark ash will absorb energy from the sun and promote fissures in the ice. The fissures should make it easier for the ice to break apart in smaller chunks.

Large ice chunks more easily jam together, cause dams that back up river water and send it washing over the banks.

In Iowa, the threat of flooding is more widespread and severe, but that state doesn't dust its rivers, said Kevin Baskins, spokesman for the Iowa Department of Natural Resources.

"Most of our efforts are aimed at keeping coal ash away from water," Baskins said.

That, too, concerns Murh.

"People look at Iowa and say, 'They aren't doing it, why is Nebraska?" Linder, the head of Nebraska's environmental agency, said he understands the skepticism.

"The perception would be that this doesn't seem right," he said. "But having had the opportunity to look at science and the actual impact, then you have a little more objective approach."

## Papio-Missouri River NRD to use bonding authority to bolster flood control efforts

The Papio Missouri River Natural Resources District (NRD) Board voted on February 11th to issue \$13.3 million in Flood Protection and Water Quality Enhancement Bonds to fund several proposed flood control projects and programs within the six-county NRD area.

It will be the NRD's first-ever use of bonding. The option to fund projects through bonding was granted to the NRD by the Nebraska Legislature in 2009.

"This was a historic vote. These funds will allow the district to accelerate its efforts to protect lives and property from potentially devastating flood events, said NRD Manager John Winkler. "Time may be running out to get these projects built before our metro area encounters heavy rainfall and runoff that has recently caused considerable damage to other nearby urban areas, O he said.

Projects identified to receive bond funding include: Valley drainageway work

- A levee improvement to protect the Village of Waterloo from Elkhorn River floods;
- A levee improvement along the Platte River in western Sarpy County; on the many more than a
- · A flood control reservoir (WP-5) in Sarpy County to protect the City of Papillion and other downstream areas from West Branch Papillion Creek flooding;

- A flood control structure in Dakota County that will also offer water-based recreation;
- A floodway purchase program to remove floodway obstructions;
- A water quality basin to protect Omaha's Zorinsky Lake from further degradation.

"We plan to pay for these bonds without raising our tax levy. In fact, our levy decreased this year," said Winkler.

The NRD has been working for years with area cities, villages and counties to develop flood control and water quality measures to meet current needs.

"It's time to put these plans in motion and get these effective controls in place," he said. Engineering studies of the Papillion Creek Watershed have shown that our floodplains are growing due to decades of urbanization."

The NRD Board also approved cost sharing with the City of Valley for assistance on improving the North Spruce Street drainageway. The NRD's cost share will be \$186,480 as the City of Valley completes the \$310,800 project.

### NRD and LaVista to share costs of floodplain buyouts

Twenty-four homes Thompson Creek may be purchased by the City of LaVista through a Federal Emergency Management Agency grant and local cost share funding by the Papio-Missouri River Natural Resources District. The NRD's cost share amount of \$340,155 was approved by the board at their meeting February 11th. The total cost of the project is \$2,721,240.

The City of La Vista proposes to acquire the homes along Thompson Creek, east of 84th Street, so that there will be continuous access to at least one side of Thompson Creek over public property to allow for repair of flood damage and bank erosion,

# Route to connect trails takes shape

Bikers and hikers are getting closer to their dream of an unbroken 50-mile trail between Nebraska's two largest cities.

Last week, officials from Cass County and the Lower Platte South Natural Resources District decided to work together to complete a recreational trail between Omaha and Lincoln.


The question before them: What is the best route to link the MoPac East Trail out of Lincoln with a trail out of Omaha that ends at the Lied Platte River Bridge near South Bend?

The two entities' efforts may already be bearing fruit.

Cass County Board member Jim Peterson said board members have proposed that the connecting route start in Elmwood and continue north on Nebraska Highway 1 to Murdock. The trail would follow 310th Street to Nebraska Highway 66 and into South Bend, where it would connect with the Lied Platte River Bridge.

"We think it will be the safest environment for the trail users," Peterson said. "It would also benefit the lifestyle opportunities of the people who live in the towns along the way."

Glenn Johnson, general manager of the NRD, said a meeting

will be scheduled with the Nebraska Department of Roads to review the route before further steps are taken.

"The advantage to this route would be that we would not have to acquire the right of way," Johnson said.

The disadvantage, he said, would be in not being able to change the grade of the road or its route.

MoPac stands for the abandoned Missouri Pacific railroad line that much of the trail follows. The trail has been in the works since the mid-1980s.

A significant step forward in

the project came last week when the Cass County Board and the NRD both unanimously agreed to sign a memorandum to jointly identify potential routes that could connect the two bike-hike trails.

The Cass County Board agreed to lead the public presentation of the route, and the NRD will oversee technical aspects of the trail.

A goal is to find the best route by July. Even then, completion of the connecting route could take five or six more years, Johnson said.

The NRD began working more closely with the Cass County

Board after encountering serious opposition to its own proposed route last year.

The NRD had proposed using eminent domain to secure a route along 334th Street, a county road. Eminent domain is the power of a government body to seize private property, then compensate the property owner.

Nearly 30 landowners opposed the route. The landowners then succeeded in having a bill introduced in the Legislature to vastly restrict the powers of eminent domain for the state's 23 natural resource districts. The trail route proposal was withdrawn and so was the legislation.

"We have been working since then on an alternative (route) that is more doable," Johnson said. "The County Board thinks it can include additional economic development between the trail and communities along the way that would help gain acceptance."

Peterson said many of the landowners were upset by the threat of eminent domain.

"The talk of eminent domain made for a lot of friction between the NRD and the citizens," Johnson said. "I believe this route proposal is a win-win situation for everyone in eastern Nebraska."

# Valley hosts information meeting on living in the floodplain

"Living in a Floodplain" was the topic of a public meeting recently hosted by the City of Valley.

Mayor Mary Caffey conducted the February 18 meeting, which provided information and an opportunity for residents to ask questions about floodplain issues.

Two city employees, Michael Burns and Shawn Smith, are both certified floodplain managers. They were on hand to answer questions, along with Richard Tesar from the Board of Directors of the Papio-Missouri River Natural Resources District, Amanda Grint from the NRD, and Eric Plautz from Douglas County Emergency Management. Chris Ott from First Nebraska Bank and insurance agent Linda McDermitt from Fricke and Associates also fielded questions.

A small number of residents attended, who had several questions about possible flooding this year, due to the heavy snow and ice, and about flood insurance and other sesses.

Tesar talked about the status of the Platte River, which was recently dusted with coal slag b the Corre of Engineers and NEMA to help

open the channel and prevent ice jams as the thick ice melts. He noted that the river from Blondo to Pacific Street has jammed three times in the

last few years.
"It was a very critical area, we felt," Tesar said, adding that the Platte and Lower Platte NRDs shared in the cost.


Since many people remember a significant flood in Valley in 1978, Tesar explained that the ice on the river in 1978 was 36-44 inches deep. The ice this winter was averaging 17 inches deep in February. He also pointed out that the 1964 dike was rehabilitated in the late 1980s.

"The dike has been broadened and in place is six feet higher," Tesar said. "We have maintained it, people patrol it every week. Nothing gets by them."

The NRD director also noted that they are prepared for dynamiting ice jams if necessary, but it can only be done by companies licensed to do that, ever since 9/11. No local companies are licensed for that, but Tesar said they have a contractor in Arksansas on alert and a helicopter in Cedar Rapids that can be on the
