<u>Approval of the Lower Platte Basin Coalition Interlocal Cooperative Agreement and Approval of the Lower Platte Basin Coalition II Interlocal Cooperation Agreement:</u> Gerry Bowen discussed the existing cooperative agreement, the purpose of the dissolution and the proposed new agreement, all relating to a cooperative agreement pertaining to Lower Platte Basin. The new agreement will address the new goals of the affected NRD's. The initial financial contribution will be \$5,000 from each member of the coalition.

Contract Amendment with Tetra Tech for Phase II of the Missouri River Levee System Units R-613 and R-616 Certification: Marlin Petermann and Mike Sotak, Tetra Tech, briefed the Subcommittee on the Phase 1 (Investigative Phase) of the existing professional services contract with Tetra Tech for the certification of the Missouri River Levee System Units R-613 and R-616, which has been completed and the proposed Phase 2 contract components. The proposed Phase 2 contract with Tetra Tech will include assessment of the feasibility of modification of the alignment for a portion of the Levee at the confluence of the Platte and Missouri Rivers to improve hydraulic capacity and provide habitat restoration opportunities. The Phase 2 services are estimated to cost \$696,376 and the Phase 1 work was for an amount to not exceed \$330,878. The total to not exceed for both phases is \$1,027,254.

• It was moved by Director Fred Conley and seconded by Director Klug that the Subcommittee recommend to the Board that the General Manager be authorized to execute the professional services contract amendment with Tetra Tech, Inc. for Phase II of the Missouri River Levee System Units R-613 and R-616 Certification Project, bringing the total not to exceed maximum amount of the contract to \$1,027,254, subject to changes deemed necessary by the General Manager and approval as to form by District Legal Counsel.
