#### MANAGERS REPORT:

Dick Sklenar gave the Manager's report in Lance's absence. Regular maintenance has been done for the month. He stated that overhaul of the point-of-delivery vault from Dakota City will begin in earnest this month. The first phase will be to install a by-pass for the vault, followed by replacing the contents in the following phase.

Dick also mentioned that Rural Water staff members were currently repairing repairing a water line break on 'E' Avenue. Stan Jans was called in for his backhoe, and a large pump was also acquired to help with the repair. A contractor, hired by Nebraska Public Power District, caused the break. There were 26 meters that were replaced for the month due to high usage or age. An additional water leak was repaired at Scout Camp and for Ed Matney at 466 Northshore Drive. All Rural Water employees took time to spend at the NRD/NRCS booth at the Dakota County Fair.

The NRD Dinner will be on September 8<sup>th</sup>, at Vince Kramper's residence prior to the NRD Board meeting at the Dakota County Service Center.
