## **Programs / Projects / Activities**

- Water Quality Open: Final planning for the Water Quality Open was at the top of my list when I returned from the wilderness. Registration was nearly full when I returned and within two days was completely full. The event on September 2<sup>nd</sup> was a great outing even through the wind, wet course and sprinkles for part of the day. But the sun did come out and the golfers seemed to enjoy themselves as did those that providing demonstrations on the course. Special thanks to all of those that helped with the event, those that presented—including Dave Miesbach from NDEQ who discussed "Microsystin Migration in Groundwater" as the keynote presentation that morning—the staff of Quarry Oaks, and NEBCO for their continued sponsorship. - LPRCA Summit: Plans for the LPRCA Summit continued to progress. The Summit is planned for Thursday, October 21<sup>st</sup> at Mahoney State Park. Environmental Suitability Assessment: HDR and I continued to make plans for the public outreach seminar as part of the launch and stakeholder involvement portion of the Environmental Suitability Assessment. The Seminar will begin at 3:30 p.m. on Tuesday, September 14<sup>th</sup> at P-MRNRD. I will provide a presentation on the ESA and LSA at 5:00 p.m. Before and after the presentation, computers will be set up so participants can view the ESA viewer. Also LPRCA partners including the Corps of Engineers, NGPC, Nebraska Land Trust, USGS, and UNL Water Center will also be providing information.

Also, we continue to work on new brochures and project information sheets for the LPRCA.

- Cumulative Impact Study: USGS completed the sediment sampling portion of Phase III of the CIS. The Corps of Engineers' is now working to have the sediment samples analyzed. Results should be available this winter.
- River Obstruction Removal: Olsson Associates submitted the preconstruction notice to the Corps of Engineers at the end of July to begin the permitting process. At the end of August, Don Day (Olsson Associates), Deanna Pulse (Olsson Associates), Carey Grell (NGPC), John Snowdon (Corps of Engineers), Bob Harms (USFWS) and I met on site at Two Rivers State Recreation Area. The meeting was in response to both questions from the Corps regarding the construction plans and permitting process as well as concerns expressed by USFWS on constructing a causeway to remove the pilings. USFWS is asking that a temporary bridge be constructed to conduct the removal out of concerns for threatened and endangered species. Following the meeting Don Day is working on different estimates for costs of the removal process.
