## Lake Dredging Program, Acct. #01-05-192-4195:

Gerry Bowen state that the Douglas County SID #439 Lake Dredging project that was approved by the Board of Directors in June 2010 was not completed in FY2011 as originally anticipated. However, the SID failed to notify the District that the funds would be needed in FY2012, therefore, no funds were budgeted for this project. The SID is now requesting funds in the amount of \$30,600, which is less than the approved amount of \$42,000.

It was moved by Director Thompson and seconded by Director John Conley that the Subcommittee recommend to the Board that Management recommends that the account be allowed to exceed the budgeted amount by over 110% for this program, and approve funding for this project.
