Review and Recommendation on Legislative Representative Contract Renewal with Husch Blackwell Sanders:

General Manager, John Winkler, briefed the subcommittee on the staff recommended contract with Husch Blackwell Sanders, LLP for intergovernmental and professional lobbying services. He said that he is very pleased with the service provided and that the firm performed extremely well during the term of the last contract.

There was general discussion concerning the firm's abilities and the benefits to the NRD gained through the firm's work. Husch Blackwell Sanders representatives Steve Grasz, Ronald Sedlacek and Tim Gay addressed questions from subcommittee members.

It was moved by Director Erickson and seconded by Director Conley that the subcommittee recommend to the Board of Directors that the General Manager be authorized to execute the proposed contract with Husch Blackwell Sanders, LLP, for the provision of intergovernmental and professional lobbying services per the terms and conditions outlined in the attached agreement.

The subcommittee continued discussion on the contract provision detailing an option for expanded services to represent the NRD during a potential ballot initiative regarding bonding authority.
