Dear Mr. Winkler:

Please accept this letter as a proposal for legal services in response to the Request for Proposal-Legal Services issued on or about January 22, 2014 ("RFP) by the Papio-Missouri Natural Resources District (the "District").

Croker, Huck, Kasher, DeWitt, Anderson & Gonderinger, L.L.C. ("Croker Huck" or the "Firm") has a long history of providing high quality legal services in the areas of real estate and municipal law. Croker Huck is known for its pioneering work in creating and developing sanitary and improvements districts ("SIDs") which have been the driving force in real estate development in the Omaha area. Although Croker Huck has expanded its areas of practice over the years to include other areas of the law as indicated in the enclosed summary, a primary area of practice focuses on real estate and real estate development. We believe Croker Huck's vast experience in real estate development makes it the logical choice as the District's legal counsel.

Enclosed is a summary of information requested by the District's RFP. Although all attorneys in the Firm will be available to assist in representing the interests of the District, the following attorneys will be primarily involved in providing such representation:

Martin's litigation and transactional experience will be helpful in his leadership of the Croker Huck team that will represent the interests of the District.

ROBERT KIRBY: Robert will be called upon to assist the District with any employment or personnel related issues, policies and litigation. He has a substantial amount of experience in the employment law area. Robert's expertise includes hiring and firing matters, drafting of policy statements/employee handbooks and defending employee claims of all types including discrimination suits based on race, color, religion, sex, national origin, age, or disability.

DAVID SKALKA and SCOTT JOCHIM: David and Scott are experienced trial attorneys and will have primary responsibility for litigation matters for the District including eminent domain and inverse condemnation proceedings. Both have a substantial amount of litigation experience including eminent domain and condemnation proceedings. David has been involved in three (3) eminent domain cases in his career and numerous other cases where the valuation of real property was an issue. Scott also has substantial litigation experience involving issues centering on the valuation of real property. As a result, David and Scott are quite familiar with real estate appraisals and presenting or defending appraisal testimony in a litigation setting. David and Scott will provide ample support for the District's litigation matters.

ELIZABETH SEVCIK and STEVEN RANUM: Elizabeth and Steve are the Firm's associate attorneys and will assist the other attorneys in representing the District in their respective areas. Elizabeth and Steve have experience in both litigation and transactional areas, and both are excellent at legal research and writing. Since their hourly rates will be lower than the other attorneys responsible for representing the District, we will utilize their respective talents as much as possible in order to keep the District's legal expenses as low as possible while providing the high quality legal services deserved by the District.

We believe that Croker Huck has a team of attorneys that can meet all of the District's needs at a reasonable cost. All of the foregoing attorneys are well-respected in the Omaha legal community and will bring the highest legal, ethical and moral standards to the table in their representation of the District.

The Firm's standard hourly rates are set forth in the enclosed summary. We propose to provide the legal services required by the District at the discounted hourly rates of \$225 for members, \$175 for associate attorneys and \$100 for paralegals. We further purpose that the agreement for legal services between the Firm and the District provide for a two (2) year initial term with automatic renewals for successive one (1) year terms unless either party terminates the agreement by providing written notice of termination at least sixty (60) days prior to the end of

the initial term or any renewal term. The agreement will also provide that hourly rates can be adjusted only upon written agreement of both parties. In addition to professional fees, we will charge for costs advanced or incurred on behalf of the District. Itemized invoices for legal fees and costs advanced or incurred will be submitted on a monthly basis and full payment will be due within thirty (30) days of the date of the invoice. The parties will execute an agreement containing the foregoing and other standard terms and conditions.

Although the forgoing proposal provides for services to be rendered under an hourly fee arrangement, we are willing to explore any other alternative fee arrangement that will be beneficial to both parties.

Thank you for your consideration of the foregoing proposal. We look forward to meeting with you and the Ad Hoc Subcommittee to further discuss our proposal. If you have any questions, please do not hesitate to contact us.
