Emergency Watershed Protection Program

The Emergency Watershed Protection (EWP) program helps protect lives and property threatened by natural disasters. It is administrated by the USDA Natural Resources Conservation Service (NRCS), which provides technical and financial assistance to project sponsors with up to 75 percent of the funds

needed to restore the natural function of the watershed. Owners, managers, and users of public, private, or tribal lands are eligible for EWP assistance. Each EWP project, with the exception of floodplain easements, requires a sponsor who applies for assistance.

EWP Sponsors

EWP recovery assistance is made available to sponsoring local organizations (sponsors). The only exception is the acquisition of flood plain easements, in which an individual landowner may request assistance. Some of the more common eligible EWP sponsors are Natural Resources Districts, County and Township boards, Indian tribes and tribal organizations, and state agencies.

Typical Recovery Measures

To be eligible for EWP assistance, a measure must reduce threats to life or property, retard runoff to prevent flooding and/or soil erosion, restore hydraulic capacity, or remove debris deposited by the disaster that might pose a health or safety hazard.

Measures must be defensible--economically, socially, environmentally, and technically. Measures must conform to rules and regulations published by NRCS for complying with Executive Orders 1990 (protection of wetlands) and 11988 (flood plain management).


Following are some of the more common measures:

- Conservation practice repair
- Critical area treatment
- Debris and sediment removal
- Dike and levee repair
- Erosion control
- Flood control structure repair
- Flood plain easements
- Land stabilization
- Road and bridge protection
- Streambank stabilization

Ethanol Plants in Nebraska

NRCS Water Quality Specialist Renee Hancock researched the status of ethanol plants in Nebraska. There are currently 24 ethanol production plants in Nebraska, with a combined production capacity of over 2 billion gallons of ethanol each year and requiring 769 million bushels of grain in the process. These ethanol plants represent more than \$5 billion in capital investment in the state and provide direct employment for some 1,200 Nebraskans. Nebraska ranks second nationally in ethanol production and is the largest ethanol producer west of the Missouri River. Geographic position, abundant ethanol supply and reliable, competitive rail transportation give Nebraska a strategic advantage in serving ethanol markets in the western U.S.
