## from the Coordinator...

## **River Obstructions Project**

Work has begun on reviewing previous information and reports on lower Platte River obstructions including bridge pilings. A couple of years ago, some work was done with the help pf the Nebraska Airboaters Association to identify and map obstructions in the river. Last year, the LPRCA did a reconnaissance canoe trip down the river to GPS the locations and take photos of each obstruction. River obstructions can be problematic for a variety of reason including: hazards to boaters, they can catch debris and divert channel flow resulting in flooding and/or bank erosion, and degradation of the natural and scenic qualities of the area. I hope to have a preliminary report this spring to present to the Alliance and its members along with recommendations and potential funding sources for removal. The LPNNRD along with the UP Railroad removed approximately 18 cement bridge pilings from an old railroad bridge back in 1997 and 1998. Dynamite was used and the process was recorded on video. It is quite an undertaking. The majority of obstructions we are looking at currently are wood, metal, and a few cement obstructions.

GIS Mapping I just began working with the LPNNRD and LPSNRD to develop several GIS maps of the corridor region including an overall base map of the area. The base map will include the corridor boundary, counties, major roads, communities in the corridor, NRDs, and topography. Other maps will show water and wastewater systems, soils, geology, current projects, floodplains, and a variety of other parameters of interest. If you have an idea for an informational map that would help describe the corridor and its resources, please let me know.

Lower Platte Weed Management Area (LPWMA) The LPWMA just finished putting together a U.S. Fish & Wildlife Foundation "Pulling Together Initiative" or PTI grant to get some additional summer help and the necessary biological and chemical supplies for noxious weed control in the 10 corridor counties. The grant is a one-year grant renewable for up to three years. Each county took an inventory of needed chemicals, biological control, equipment, and summer help. This information was then submitted as a part of the grant to show the need for noxious weed control in the counties. Recall, that earlier this year the LPWMA submitted a grant to the Nebraska Environmental Trust Fund (NETF) for equipment, specifically ATVs and sprayers for 8 of the 10 corridor counties.

Lower Platte River Watershed Nature Center On Wednesday, November 12th there was a meeting at the UNL Ag Research Development Center (ARDC) site near Ithica to bring together potential partners and stakeholders for the development of a nature center showcasing the lower Platte River Watershed. We were able to gauge interest in the nature center and to explain in greater detail what the project is all about. There was a small showing at the meeting, but the major stakeholders were in attendance and all showed overwhelming support for the project. The project will entail the development of a series of trails and interpretive panels along the trails highlighting the many natural features of the ARDC area. There will also be opportunities for hands-on learning and nature hikes through woodlands, wetlands, pastures, fields and feedlots highlighting the benefits of wetlands for stormwater and field runoff, native and planted woodlands and grasslands, wildlife management, and BMPs for agricultural practices. The group decided to have quarterly meetings with a smaller group made up of UNL, the NPS, and the LPRCA to serve as the steering committee. As various components of the project were initiated, then the appropriate stakeholder would be brought in to assist. The LPNNRD, the district where this project lies, has already discussed this project and shown support for the concept.

Water Quality/Resources Meetings I just met again with the UNL Cooperative Extension to discuss the details regarding our upcoming Water Quality/Resources public meetings. As I mentioned previously, these meetings will be similar to the Water Wellness meetings held a couple of years ago, except we want to add background information on water resources and drinking water treatment components. We have roughed out an agenda and assigned the folks who will cover each component at the meetings. We will offer a variety of tools for assessment of groundwater quality, septic system placement and maintenance, and water well issues including the Farm\*A\*Syst manual, Water Wellness booklets, Fact Sheets, NebGuides, and a variety others as are determined appropriate. The focus is to provide corridor residents with the proper information and tools to prevent, assess, and treat water quality issues. The meetings will be held from April through July and will be comprised of a series of approximately 8 meetings at specific locations throughout the corridor during both the evening and daytime, possibly some Saturdays. We anticipate a two-hour meeting for each location. If you have any suggestions for a meeting venue, please let me know. I hope to distribute draft agendas and a description of the program in the near future.

Ice Jam Cooperative Agreement Meeting

The annual ice agreement stakeholder meeting will be held on Wednesday,
December 17th starting at 9:30 a.m. at the PMRNRD in Omaha. This is the kick-off meeting for the group to get things started
and discuss roles and responsibilities for all stakeholders. NEMA and DNR head up the meeting which will cover general issues
regarding ice jams in addition to presentations on issues such as new and current technologies for relieving ice jams.

NDEQ State Revolving Funds Meetings Last week, the LPNNRD hosted a meeting presented by NDEQ to discuss the Drinking Water State Revolving Fund (DWSRF) and the Clean Water State Revolving Fund (CWSRF) as well as Sources water protection issues. The DWSRF is a revolving fund established to assist communities and districts in upgrading their drinking water systems through low interest loans and grants. Similarly, the CWSRF addresses wastewater systems for communities and districts also using loans and grants (or loan forgiveness). This is very pertinent to the Lower Platte River Corridor since there are two counties considering a regional water/wastewater system. Other topics discussed including source water protection projects and grants as well as the Nebraska Environmental Partnership (NEP) program which offers assistance to communities for planning and community assessment funding.

The Papio-Missouri River Natural Resources District 2004 election will be for odd-numbered subdistricts (Subdistricts #1, #3, #5, #7, #9 and #11). Individuals running for election will have to run in the May 11, 2004, primary to narrow the field of candidates to two for each subdistrict for the November 2, 2004, general election.


Individuals wishing to file for office can pick up the candidate filing forms at their respective County Election Commissioner's Office or County Clerk's Office. Please note the Douglas County Election Commissioner's Office has moved to 225 N. 115<sup>th</sup> Street (south of Dodge between Davenport and Burt Streets). As noted above, the deadline for incumbent candidates to file is February 15, 2004; and, for non-office holders, the deadline is March 1, 2004. Completed forms must be received by the Secretary of State's Office by 5:00 p.m. of the applicable day. There is no filing fee for NRD Director.

P-MRNRD Directors are nominated and elected by subdistrict. A copy of the P-MRNRD subdistrict map is attached to this memo. Directors receive \$70 perdiem (maximum \$2,800 per calendar year) plus expenses for mileage, lodging and meals while conducting NRD business.

The term of office for present P-MRNRD Directors who were elected in 2000 will expire on December 31, 2004. The following is a list of current P-MRNRD Directors and the subdistricts they represent pursuant to subdistrict boundaries.


