RE-BIDDING OF MO-PAC EQUESTRIAN TRAIL: Gerry Bowen reviewed the revisions to the Mopac Equestrian Trail Project. The revised cost estimate is \$41,369.00. Vicky Fraser stated that she was very pleased with the staff's effort to reduce costs. Clearing of the trees will be done by the District along the trail route.

TERN AND PLOVER PARTNERSHIP FUNDING: Gerry Bowen stated that there was no statute prohibiting the District's financial contribution to the Tern and Plover Conservation Partnership. Renae Held indicated that this program has shown increased productivity of the bird population. There was further discussion regarding funding sources of the 2007 program activities.

PLATTE RIVER INSTREAM FLOW MEMORANDUM OF UNDERSTANDING: The District has been approached by the Game & Parks Commission to join them along with a group of governmental entities a review and study of instream flow rights for fish in the Platte River. Kirk Nelson, NE Game and Parks, also spoke on the issue.

PAPIO CREEK WATERSHED AGREEMENT #8 FOR PAPIO CREEK WATERSHED

P.L. 566 STRUCTURE W-3: Martin Cleveland stated that Site W-3 was the fifth site of five dams to be considered for dam rehabilitation. Chuck Leinen indicated that it was necessary to rehab the dam in order to comply with the Nebraska Dam Safety Requirements. The federal government would pay for 65% of the construction costs. The District would pay 35%. Right of way must be acquired by the District and its cost would be applied towards the District share of the costs. Martin Cleveland also spoke of other options that were investigated but dismissed. John Camden, property owner affected by the site, opposed the additional right-of-way needs for the high hazard dam project. Mary Camden also spoke on the issue. Martin Cleveland reminded Directors that this was only a draft of the plan for rehabilitation, which still needed final approval from the Natural Resources Conservation Service.

➤ It was moved by Director Fred Conley and seconded by Director Kolowski that the Subcommittee recommends to the Board of Directors that the General Manager be authorized to execute the proposed Papillion Creek Watershed Supplemental Agreement #8 with the Natural Resources Conservation Service for rehabilitation of P.L. 566 Grade Stabilization Structure W-3, subject to changes deemed necessary by the General Manager and approved as to form by the District's Legal Counsel.

WATERLOO REQUEST FOR ADDITIONAL FUNDING ON WATERLOO TRAIL

PHASES 2 & 3: Gerry Bowen reported that the Village of Waterloo is requesting additional financial support from the District in the amount of \$7,016.00 to help pay for a portion of trail that is not eligible for funding from the Nebraska Game & Parks Commission. There was discussion.

PAPIO CREEK BANK STABILIZATION PROJECT BIDS: Martin Cleveland spoke on the need to stabilize the banks along the creek at 3 locations with rip-rap rock. The locations are along the Papio Creek Project system. The contract is to be completed in 50 working days.

➤ It was moved by Director Kolowski and seconded by Director Fred Conley that the Subcommittee recommends to the Board of Directors that the General Manager be authorized to execute a contract for rock rip-rap bank stabilization work at 3 sites on the Papillion Creek system with Midwest Dumpers, Inc., for their total base bid of \$199,820.00

The District is required to approve a project agreement with the Game and Parks Commission to receive the grant.
