LB 20

Section 1. Section 2-3290.01 Revised Statutes Cumulative
Supplement, 2006, is amended to read:

- (1) A district shall permit public use of those portions of a water project located on lands owned by the district and on land over which the district has a lease or an easement permitting use thereof for public recreational purposes. All recreational users of such portions of a water project shall abide by the applicable rules and regulations adopted and promulgated by the board.
- recreational use at designated access points at any water project.

 Recreational users, whether public or private, shall abide by all applicable rules and regulations for use of the water project adopted and promulgated by the district or the political subdivision in which the water project is located. Public recreational users may only access the water project through such designated access points.

 Nothing in this subsection shall require public access when the portion of the project cost paid by the natural resources district with public funds does not exceed twenty five percent of the total cost of the project.
 - (3) For purposes of this section water project means a project with cooperators or others, as authorized in section 2-3235, that results in construction of a reservoir or other body of water having a permanent pool suitable for recreational purposes greater than one hundred fifty surface acres, the construction of which commenced after July 14, 2006. Water project shall not mean soil conservation projects, wetlands projects, or other district projects with cooperators or others that do not have a recreational purpose.

Sec. 2. Section 18-1755 Revised Statutes Cumulative
Supplement, 2006, is amended to read:

A city of the metropolitan, primary, first, or second class or village acquiring an interest in real property by purchase or eminent domain shall do so only after the governing body has authorized the acquisition by action taken in a public meeting after notice and public hearing. The city or village shall provide to the public a right of access for recreational use to the real property acquired for public recreational purposes. Such access shall be at designated access points and shall be equal to meet or exceed the right of access for recreational use held by adjacent landowners. The right of access granted to the public for recreational use shall meet or exceed such right held by a private landowner adjacent to the real property.

Dear Marlin:

As the 109th Congress adjourns, I want to give you an update on the status of the Fiscal Year 2007 (FY07) appropriations bills. Unfortunately, Congress was unable to finalize most of the bills this year; thus, the status of most funding requests is unknown at this time.

Only two of the FY07 spending bills – Defense and Homeland Security – have been approved by Congress and signed into law. Congress has now approved a Continuing Resolution to fund other government operations through February 15, 2007. As a result, we will renew consideration of the remaining appropriations bills when the 110th Congress convenes in January. Unfortunately, this means that many funding requests are essentially in limbo for the time being.

It remains to be seen exactly how Congress will handle individual appropriations requests when we convene in January. Please know that my commitment to representing Nebraska's priorities – as articulated to me by you and other community leaders – remains the same. I hope we will move quickly to enact spending measures for FY07, so that we may then turn our focus to setting a budget and establishing priorities for FY08.

I will continue to keep you informed of any progress in upcoming weeks. Please do not hesitate to contact me or my staff if you have any questions or need additional information.

Subject: December 2006 Accomplishments and January 2007 Anticipated Actions

Failure by the Congress to pass the FY'07 appropriations for the three major projects and the Water Resources Development Act of 2006 for the Lower Platte Watershed Restoration Project and amendments to the WRDA 2000 authorizations was unexpected. Legislative action on these bills and the Corps of Engineers allocation of the FY'07 appropriations will likely continue at least through March 2007.

December 2006 Accomplishments

During December 2006, the firm:

- 1. Conferred with Congressional Appropriations committee staff and reported on the new majority's plans for completing the FY'07 appropriations cycle for the three major projects and others and the administrative process and the LPR NRD strategy for obtaining FY'07 funds from the Corps of Engineers.
- 2. Conferred with the Corps of Engineers on their actions to allocate construction general account founds.
- 3. Conferred with Congressional appropriations staff and other Washington sources and reported on prospects and schedule for completing the Water Resources Development Act of 2007 including amendments to the WRDA 2000 authorizations for the three major construction projects.
- 4. Monitored the Corps and Administration development of the President's 2008 budget request and prepared a draft letter for the governor to send to the White House.
- 5. Conferred and reported on possible sources of Department of Agriculture funding for the LPR NRD monitoring and watershed management program and prospects and issues for the 2007 Farm bill.

The firm received payment for November services in an amount less than

services performed or billed as reflected in the November statement. It is the firm's understanding that fees paid and received for services by the end of November is the amount budgeted for the current NRD fiscal year.

January 2007: Planned, Potential and Anticipated Actions

- 1. <u>FY'08 Energy and Water Development Appropriations</u>
 - Monitor and review Administration's FY '08 budget process to support additional funding for the 3 major projects.
 - Prepare draft and final request letters and forms for the FY'08 appropriations requests for the three major projects and others.
 - Further develop strategy for expanded funding in the FY'08 appropriations and arrange for Washington meetings in February 2008.
- 2. <u>FY'07 Energy and Water Development Appropriations</u>
 - Continue support to delegation for project amounts that were included in the FY'07 Senate appropriations committee bill.
 - Remain in close contact with Corps of Engineers Headquarters on its process for allocating Construction General funds from the Congressional Joint Resolution and Explanatory Statement and report to delegation on opportunities to strengthen the projects funding levels.
- 3. Water Resources Development Act'07
 - Maintain contacts with Congressional and other Washington contacts on status outlook and opportunities in WRDA'07.
 - Continue to monitor conference progress and further confirm inclusion of all Lower Platte River NRD amendments in conference report.
 - Provide information to delegation and respond to information needs.
 - Maintain contact with Congressional, USACE and other contacts on enactment of WRDA'07.
- 4. <u>Identify and report on other federal funding</u> sources for watershed management including NRCS funding and opportunities in the 2007 Farm Bill.
- 5. <u>Prepare reports</u> to the LPRNRDs.
- 6. <u>Monitor and report other federal legislative and administrative developments</u> that would support the LPRNRDs and watershed restoration.

Two-thousand seven will provide several opportunities for the Lower Platte River NRDs, some delayed from 2006. This report summarizes status of these and suggested strategies. The most significant change behind these opportunities is Senator Nelson's new majority membership on the Senate Appropriations Committee. This development will place even greater importance on the Senate for achieving legislative objectives.

1. <u>Joint Resolution for FY'07 Appropriations</u>

We will need to monitor legislative action and support the delegation for completion of the FY'07 appropriations cycle and work closely with the Corps to assure funding at least at the FY'06 funding levels for construction of the three major projects. Antelope Creek may be in line for a bump over the 2006 level reflecting the Administration's request for \$7.5 million in the FY'07 budget. The Corps, the Army and OMB will all have a role and we will rely on direct contacts and delegation contacts with USACE. Corps Headquarters has not yet begun to develop a funding process for the FY'07 money. Funding for the smaller flood control projects and for the Papio's flood plain management funding through the Corps Flood Plain Management Services program can remain part of our objectives.

2. FY'08 Energy and Water Development Appropriations

The FY'08 cycle should begin early to aid the delegation in developing their requests for the three principal projects and any smaller ones you all may want. I suggest

an early update briefing for the delegation in Washington prior to the NARD conference in March.

3. Water Resources Development Act of 2007

As I have been reporting, Congressman James Oberstar the new chair of the House Transportation and Infrastructure Committee intends to move WRDA '07 early in the session to completion. I have learned that the Senate Environment and Public Works Committee is planning to do the same. Word on the street today is that Chairwoman Barbara Boxer wants to markup a bill by March 31, 2007. I anticipate that both houses will try to begin where this past year's conference negotiations left off, though the exact procedure is not known. The Upper Mississippi lock and dam project and New Orleans levees remain driving forces behind WRDA'07

The Lower Platte Watershed Restoration Project was included in the draft conference report because Ben Nelson requested it and Chuck Hagel supported it. This combination should continue to have a major influence on WRDA'07 for enactment of the restoration authority as well as the amendments to the 2000 authorizations for the three major projects.

4. NRCS and 2007 Farm Bill

When I delivered the NRD letter to Merlyn Carlson (Deputy Under Secretary for Conservation) he said that we should contact, Lawrence Clark, the Deputy Chief of the NRCS to pursue the items in the letter including funding from the conservation innovation grant program. I anticipate that Clark is also working on the Administration's conservation recommendations for the 2007 Farm bill which will be part of hearings and the beginnings of legislation development during the coming year. I will followup with an initial contact with Clark and report back to you.

Two Farm Bill issues of developing interests are: (1) implementation of nutrient management plans particularly in the Mississippi drainage; and (2) herbicide/pesticide management. The Environmental Protection Agency recently interpreted the Clean Water Act ("CWA") and the Federal Insecticide, Fungicide and Rodenticide Act to exclude the spraying of such chemicals as a point discharge under the CWA which would make them subject to the NPDES permit program. In so doing, the Agency placed emphasis on best application management in accordance with manufacturer instructions to control pollution from these chemicals.

5. Clean Water Act Review

The new majority in both houses of Congress has expressed interest in reauthorizing the Clean Water Act ("CWA") state revolving fund ("SRF") loan program and considering other changes to the CWA. Incoming chairman of the House Transportation and Infrastructure Committee, James Oberstar (D-MN) has expressed interest in reauthorizing the SRF and then turning attention to the proposed Clean Water Trust Fund Act introduced in the 109th Congress as H.R. 4560. This bill also reauthorized the SRF loan program and would

have established a new program of construction grants, both funded by dedicated revenue.

Both the House and Senate committees are likely to consider new provisions to strengthen the watershed approach under the CWA. New funding authorizations will also be focused on watershed restoration much like the existing Chesapeake Bay, Great Lakes and National Estuary programs.

Senator Barbara Boxer, the new chair of the Senate Environment and Public Works ("EPW") Committee has chosen Eric Olsson of the Natural Resources Defense Counsel as Deputy Staff Director for clean water and drinking issues and the committee's general counsel. She has also chosen Ken Kopocis (Omaha Central HS), the principle minority clerk on the House Water Resources and Environment Subcommittee of Transportation and Infrastructure, as Deputy Director for of EPW for infrastructure. I have previously met with Olsson on the Clean Water Trust Fund proposal and Kopocis has staffed this issue in the last Congress for the Democratic members of the committee.

I have talked previously with Glenn about an early 2007 trip to Washington before the NARD meeting in order to maximize time with the delegation members and staff on appropriations and WRDA legislation. I suggest late February preceded by completion of forms for appropriation requests.

We respectfully request inclusion of three, ongoing water resource projects in your fiscal year 2008 budget for the U.S. Army Corps of Engineers. Together these projects are emblematic of your policies to protect vital infrastructure and communities from flood risk and to encourage a net gain in wetlands resources:

The Western Sarpv-Clear Creek Flood Damage Reduction Project will protect critical drinking water facilities for Lincoln and Omaha that together serve up to 50% of Nebraska's population, other community and national infrastructure, homes and farmland. This project also ties into a flood control levee already built with Military Construction funds to protect the Nebraska National Guard Camp serving Guard units in several states: without completion of Clear Creek levee segment, the guard camp levee remains ineffective. This project has been ready for construction completion for several years.

The Sand Creek Environmental Restoration Project will add to the nation's wetlands resources and specifically for migratory birds that use the North American Central Flyway. It will further improve water quality in the Lower Platte River drinking water basin and provide flood damage reduction to the City of Wahoo and the U.S. 77 Expressway that has been flooded twice in the past year.

The Antelope Creek Flood Damage Reduction Project, the flood control element of the Antelope Valley water resource, transportation and community improvement project is preparing to make major strides with the amount requested by the Administration in the 2007 budget and included in the House and Senate appropriations bills. A similar amount will further advance the remaining benefits, remaining costs ratio calculated for the last budget cycle.

These three projects, authorized in the Water Resources Development Act of 2000, represent water resource priorities for Nebraska in the coming budget and are supported by the Administration's policy review process. Enclosed is additional information. Thank you for your kind consideration of our requests.

Session Begins -- The Nebraska Legislature convened its 90-day work session on January 3, 2007 and is tentatively scheduled to end on May 31st. Days off for Holidays (H) and Recess (R) are as follows: Jan 15 (H); Feb 9 (R), 16 (R) and 19 (H); March 2 (R), 16 (R), 23 (R), and 26 (R); April 6 (R), 9 (R), 20 (R), 27 (H) and 30 (R); May 11 (R), 14 (R), 25 (R) and 28 (H). These are dates your senator(s) should be back in the district if you wish to schedule meetings with him or her.

Unicameral New Web Site – The Nebraska Unicameral has a new website address which is www.nebraskalegislature.gov.

New Bills — Introduction of legislative bills occurs in the first ten working days of the session. This is the beginning of a new session so there are no carry over bills from last year. The following are a few new bills of interest for the NRDs introduced in the first few days. Note, no bills were introduced on the first day. For more information on introduced legislation, visit the Nebraska Unicameral web-site at www.nebraskalegislature.gov.

- LB 7 Open Meetings Act, Priester. Adds to the definition of new business to include any item not on the agenda of a meeting which is not of an emergency nature. The bill also outlines that if a citizen speaks on an item of new business, members of such body may engage in discussion with the citizen but shall not take any action on such business that requires a vote of the body at that meeting. Finally, the bill prohibits a public body from requiring members of the public to identify themselves as a condition for admission to the meeting or require that members of the public be placed on the agenda prior to such meeting in order to speak to the body regarding items on the agenda or any new business.
- LB 17, Prohibit NRD Dual Office Holding, Mines. Adds NRD office holders to the list of high elective offices that would be prohibited from filing as a candidate for another high elective office. Current law defines higher elective office as a member of the Legislature, county, city, or school district.
- LB 20 NRD Projects and Public Access, Mines. Requires public recreation access to NRD water project properties and private lands under NRD easements if NRD contributions are 5 percent of the cost of the project. Current law, adopted in 2006, requires public access if the NRD cost is 20 percent of the total cost.

Bleed Appointed DNR Director – Governor Dave Heineman appointed Ann Saloman Bleed as permanent director of the Nebraska Department of Natural Resources noting her 18 years with the department as state hydrologist, deputy director and, most recently, interim director since August 2005. Bleed is from New York, N.Y., has a Master's degree in ecology/zoology from Penn State and Ph.D. focused on ecology from the University of Wisconsin. Bleed holds a second master's in industrial engineering and systems management from the University of Nebraska-Lincoln

Owners question estimates

Washington Countians say dam study property value estimates too low


The study group charged by the Papio-Missouri River Natural Resources District with an in-depth analysis of the costs and benefits of constructing two large dams in Washington County presented some of its findings at anopenforum Tuesday, Dec. 5,

at Bennington High School.
This second of three public forums associated with the study focused on the estimated costs of several alternatives to damsites 1 and 3C. About 250 people attended.

HDR Engineering Inc. of Omaha has been assigned to conduct the analyses. While the engineers' estimates showed constructing the two dams in one form or another would be cheaper than most of the alternatives, those in attendance -many of whom would be directly impacted or displaced by the construction of the two dams-were skeptical of the study's validity especially concerning the value of their farmland that would need to be purchased by the NRD to build the dams.

Using U.S. Army Corps of Engineers methodology, HDR has estimated the expected annual flood damages, over a 100-year period, in the Papio Creek watershed, at \$7.4 million with existing land use conditions. That number is anticipated to go up to \$12.7 million as development in the watershed continues, said John Engel, Sites 1 and 3C project manager for HDR.

The study also found that if a 100-year flood event occurred today, 3,403 acres and 758 structures would be flooded, including 432 single family homes, 117 multi-family homes and 263 commer-

cial or industrial structures. Under maximum build-out conditions in the future, up to 3,572 acres and 851 structures would be flooded.

The numbers were figured by taking the estimated damage caused by various degrees of flooding and multiplying it by the probability of a flood of that magnitude actually occurring.

Buying all the land in the floodplain was the most expensive option presented at an estimated cost of \$457 million. Second was constructing levy and channel improvements downstream at an estimated cost of \$189.7 million.

The flood control benefit of the full implementation of conservation measures, such as terraces, buffer strips, tile outlets and no-till planting was minimal since 75 percent of the watershed already uses such measures, Engel said.

The study also looked at the costs associated with building multiple, smaller detention

The HDR study looked at several different scenarios for damsites 1 and 3C.

If both were constructed as wet-reservoirs with a permanent pool of water, the estimated cost would be around \$88 million with annualmaintenancearound \$1.6 million, Engelsaid. This plan would affect 4,815 acres and 70 structures.

The second option is to construct site 3C as a dry dam. This option was esti-

mated to cost around \$47.4 million with annual maintenancearound \$1.5 million. This plan would affect 2,065 acres and 35 structures.

The third option was for damsite 3C as a wet damand 1 as a water quality detention structure. This option was estimated at \$75 million with \$1.5 million in annual maintenance costs. Around 3,920 acres and 66 structures would be affected.

While all of these dam scenarios would provide the same level of flood control, constructing 1 and 3C would provide recreation in the county and help drive growth, Engel said. A dry dam would provide natural resources-based recreation, such as trails and nature observation sites, while a wet dam with public ownership and a 200-foot water quality buffer around the reservoir would provide water-based

Gretna says yes to plan for dams

The City of Gretna has signed on to a controversial proposal to build up to 29 dams to control storm water runoff and flooding in the Omaha metropolitan area.

The Gretna City Council voted unanimously this week to participate in a plan that includes construction of the dams and new policies for handling storm runoff.

"We hoped everybody in the area would adopt these policies," said Paul Woodward, project manager for the Papio-Missouri River Natural Resources District.

The district board also has endorsed the dam plan.

Backers of the estimated \$282.5 million plan hope to fund the project through property taxes and a tax on new development in Douglas and Sarpy Counties. Critics have said the plan is expensive and favors developers.

The City of Gretna is not required to have policies for how it manages water because it is not considered part of an urban area by the Nebraska Department of Environmental Quality.

Because of Gretna's growth, city officials expect the city to be classified as an urban area by the next Census in 2010.

These are good, sound water management practices, Mayor Tim Gilligan said. The plan helps Gretna get a jump on meeting the requirements of the federal Clean Water Act, he said.

Sarpy County and the cities of Omaha, La Vista, Papillion, Boys Town, Ralston and Bellevue have approved the dam plan.

The Douglas County Board and the cities of Elkhorn and Bennington have objected to signing on to the plan.

mans' single greatest use of his NRD cell phone was calling Nichols. About 16 percent of his minutes were used to call her. Those calls added about \$72 to his bill over the roughly two years of phone bills studied. Nichols was a board member for part of that time.

Witek said most of the accounting problems found at the NRD are found in the records of other government agencies.

"It's common, unfortunately," she said. "On a scale of 1 to 10, this was probably on the higher side."

Oltmans, who was fired by the board, had no comment on the audit findings. He now works for the consulting firm Olsson & Associates.

Board Chairman Jim Thompson and Conley characterized Witek's findings as minor, but they said the district has revised its policies to address concerns raised by the audit.

"It was surprising how little the audit revealed," Thompson said. "There was nothing criminal by any means."

Marlin Petermann, assistant general manager, said the NRD has created an IRS Accountable Plan to address the tax concerns raised by the audit. The plan outlines the rules for reimbursement.

Conley said he believes the district did not violate IRS rules. He cited "professional opinions" that he said indicated the district had appropriate rules in place.

Conley would not provide the name of the professional providing the opinion or describe that person's expertise. Nor would be say whether the advice was given formally or informally.

Witek's office found that the NRD, like many other government entities in Nebraska, violated IRS rules by improperly considering certain types of spending as legitimate business expenses.

Because the spending shouldn't have been allowed as a business expense - from an income tax point of view - the money paid to the employees should have been recorded as

taxable income.

Oltmans, for example, expensed meals an average of almost four times a week, according to records reviewed by The World-Herald.

IRS rules govern what type of meal expense constitutes a legitimate business expense. When dining in-town, only certain types of meals qualify, and a number of Oltmans' meals appear to have fallen outside that standard.

Because the NRD didn't include those meal expense reimbursements as taxable income on Oltmans' W-2 form, Oltmans "received personal gain," according to the Auditor's Office. That is a violation of state law, the audit said. The report does not provide a total value for meal reimbursements should have been taxable.

The auditor also noted five instances from June 1, 2001, through Feb. 25, 2006, that it described as "very critical in nature." They were serious - not because they involved a lot of money, but because they "reflect the possibility of fraud," according to the audit report.

In two out of 917 meals, Oltmans was reimbursed for meals that had been paid for with an NRD credit card. The two meals totaled \$58.50.

In three cases, money provided to Oltmans as a travel advance was not deducted or the amount deducted from expenses was incorrect.

Those cases included airline tickets for Oltmans' wife. With those errors, some money was due Oltmans and some money was due the district. The net amount, \$663.30, was owed to the NRD.

Witek's office has no plans to forward the report to prosecutors, which it would be obligated to do had it found criminal wrongdoing.

In terms of Nichols' expense records, the auditor found that she appeared to be owed \$146.54 in expenses for which she was not properly paid.

The audit did not examine the expense reports of other board or staff members.

Errors, not crimes

onclusions drawn recently after the special audit of the Papio-Missouri River Natural Resources District's expense records didn't surprise many close observers of the agency. The State Auditor's Office found errors, not crimes, in the NRD's books.

The organization's procedures were definitely lax, audit officials said. Expense records were incomplete, and taxable-expense-income rules set down by the IRS were violated. The NRD, State Auditor Kate Witek said, was not unique among government agencies in suffering from such accounting problems.

The investigation was instigated by NRD board members after the district's former executive director, Steve Oltmans, was found to be having an affair with former board member Barb Nichols. Questions were raised about his expense accounts. Oltmans was fired.

Board Chairman Jim Thompson rightly characterized the audit find-

ings as minor, though the board already has wisely revised its policies to prevent similar problems in the future.

Perhaps board members can now begin to put this distasteful episode behind them. The whole incident has tarnished the NRD's image and dented its credibility. For many years, its reputation was outstanding.

The implications for the board's most important projects, among them a controversial proposal for up to 29 dams in the Papio Creek watershed to prevent downstream flooding, are uncertain. Opponents of the dam project are likely to seize on the accounting errors as a reason to distrust the board's decisions and question its word.

The NRD is facing a critical time as it tries to initiate plans for the future of flood control in the Omaha metropolitan area. For the good of the community, it should work hard to overcome the mistakes of the past.
