<u>Review of FY 2011 Budget – Draft 2:</u> General Manager Winkler reviewed the summary of the draft 2011 budget and schedule. He responded to questions from the Board and public.

- It was moved by Director Thompson and seconded by Director Tesar that the FY 2011 budget, as presented, be forwarded for review at the August 12, 2010, Budget Hearing with the provision that the General Manager be authorized to make necessary adjustments once final figures are available and necessary adjustments to achieve compliance of state statutes regarding the lid.

<u>Purchase of UPRR Abandoned Right of Way</u>: Gerry Bowen presented for consideration a proposal from Union Pacific Railroad that the District purchase recently abandoned rail line for future expansion of the West Papio Trail. The right of way is 100 feet wide and follows the West Branch Papillion Creek on the east side and encompasses approximately 33 acres. There was discussion.

• It was moved by Director Kolowski and seconded by Director Lanphier that the General Manager of the District be authorized to execute for and on behalf of the District an agreement with the Union Pacific Railroad providing for the District's purchase, for the amount of \$1.5 million, payable in three equal annual installments of \$500,000, such railroad's right-of-way between Q Street and Giles Road for the District's recreational trail program, with such other provisions deemed necessary by the General Manager and approved as to form by District Legal Counsel.

<u>King Lake Floodway Purchase Program Acquisitions</u>: Lori Laster reported that the District had received grant funding to purchase 14 properties in the floodway in the King Lake area and reported on the following two proposed acquisitions.

- a. <u>Georgian Property</u>: Ms Laster noted that this property was located at 5708 N. 242nd St. and is in a Zone AE floodway of the Elkhorn River. There was discussion.
 - It was moved by Director Thompson and seconded by Director Kolowski that the General Manager be authorized to execute for and on behalf of the District a Purchase Agreement in the form as presented to this meeting providing for the purchase by the District from Lisa Georgian, of 0.23 acres of floodway land in the King Lake Addition for the purchase price of \$27,000, subject to changes deemed necessary by the General Manager and approved as to form by District Legal Counsel.

- b. <u>Lunn Property</u>: Ms. Laster noted that this property was located at 24221 Vernon Avenue and was in a Zone AE floodway of the Elkhorn River. There was discussion.
 - It was moved by Director Kolowski and seconded by Director Thompson that the General Manager be authorized to execute for and on behalf of the District a Purchase Agreement in the form as presented to this meeting providing for the purchase by the District from Glenda J. Lunn, etal, of 0.64 acres of floodway land in King Lake Addition for the purchase price of \$21,000, subject to changes deemed necessary by the General Manager and approved as to form by District Legal Counsel.
