TURTLE CREEK WATERSHED STRUCTURE #2 REHABILITATION PROJECT

**BIDS**: Martin Cleveland reviewed with the Subcommittee the six bids received for the referenced project, location of project and rehabilitation project details. He noted that the work would commence and be completed in Fiscal Year 2009.

➤ It was moved by Director Fred Conley and seconded by Director Kolowski, that the Subcommittee recommend to the Board of Directors that the General Manger be authorized to execute a contract with Negus-Sons, Inc., for a total base bid of \$497,186.04 for construction of the Turtle Creek Watershed Structure #2 Rehabilitation Project.

WATERLOO LEVEE IMPROVEMENTS DESIGN AND CERTIFICATION: Paul Woodward reviewed with the Subcommittee the history of the Waterloo Levee, results of recent evaluation study, proposed design/certification contract and proposed District cost share for one half of the levee improvements design fees (50% of \$396,580), which should be completed by March 2009. He noted that the preliminary study concluded that the existing levee doesn't meet the federal requirements to be certified and to be shown on flood maps as providing protection from the 1% chance annual flood. The estimated construction project cost is \$2 million dollars. Stan Benke, Village of Waterloo Board Chairman reported on Village Board approval the of design services contract with JEO Consulting on June 9, 2009 and he requested NRD Board approval of the requested cost share.

➤ It was moved by Director Fred Conley and seconded by Director Kolowski, that the Subcommittee recommend to the Board of Directors that the General Manger be authorized to execute an interlocal agreement with the Village of Waterloo providing for a contribution of up to \$198,290, towards the cost of the design of improvements to such Village's flood control levee.

## COOPERATING TECHNICAL PARTNERS GRANT APPLICATION AND AGREEMENTS FOR FLOODPLAIN MAPPING UPDATE IN WASHINGTON, DOUGLAS AND SARPY COUNTIES:

Paul Woodward briefed the Subcommittee on the proposed CTP grant application for the Douglas and Sarpy Counties Floodplain Remapping and the status of the study effort. He noted that the NRD via FEMA assistance will complete 800 miles of creek remapping at a total cost of

\$3 million dollars. He noted that the Douglas and Sarpy grant funds (\$375,000) will go to FEMA's mapping contractor and not to the NRD.

Amanda Grint briefed the Subcommittee on the proposed CTP grant application for the Washington County Floodplain Remapping and the status of the study. She noted that the grant application to FEMA will be for \$169,100.

> It was moved by Director Fred Conley and seconded by Director Klug, that the Subcommittee recommend to the Board of Directors that the General Manger be authorized to apply to the Federal Emergency Management Agency (FEMA) under the FEMA Cooperating Technical Partners (CTP) Program, for CTP grants in the maximum obtainable amount (presently estimated to be \$169,100 for Washington County and \$375,000 for Douglas/Sarpy County) towards the cost of activities needed to produce digital floodplain maps, and that the General Manager be directed to apply for technical assistance, training, data and other assistance available from FEMA under the CTP Program to support such mapping activities; and, further, that the General Manager of the District be authorized to carry out the Washington County and Douglas/Sarpy County Floodplain Mapping projects and to execute, for and on behalf of the District, Applications for Federal Assistance for such FEMA CTP grants, a CTP Cooperative Agreement with FEMA, CTP Mapping Activity Statements, and such other applications, assurances, certificates, reports and other documents, and amendments thereto, as the General Manager determines necessary to obtain such CTP grants and other mapping activity assistance from FEMA.

NEW DISTRICT PROGRAM 17.41 – STORMWATER BMP PROGRAM: Amanda Grint briefed the Subcommittee on the proposed District Program 17.41 – Stormwater Best Management Practices (BMP) program, which would provide technical and financial assistance to local governmental entities for the installation of innovative best management practices to control stormwater runoff and improve water quality. She noted that there is \$50,000 in the proposed FY 09 budget for this cost share program.

> It was moved by Director Fred Conley and seconded by Director Klug, that the Subcommittee recommend to the Board of Directors that the District adopt District Program 17.41, Stormwater BMP Program, in accordance with the proposed criteria and program guidelines.

MOPAC TRAIL (HWY. 50 TO LIED BRIDGE) ENGINEERING FEES – CONTRACT WITH EHRHART GRIFFIN AND ASSOCIATES: Gerry Bowen briefed the Subcommittee on the history of the MOPAC Trail Project and associated significant design changes required to accommodate landowner concerns about drainage. These changes required more design effort by Ehrhart Griffin and Associates than anticipated in the original proposal. Therefore, it has resulted in a need to increase the contract not to exceed amount from \$238,046.45 to \$323,906.68 (difference of \$85,860.23).

➤ It was moved by Director Fred Conley and seconded by Director Kolowski, that the Subcommittee recommend to the Board of Directors that the General Manger be authorized to amend the professional services contract with Ehrhart Griffin and Associates to increase the "not-to-exceed" amount from \$238,046.45 to \$323,906.68.
