WATER USE REPORT/DELINQUENT ACCOUNTS

Randy Hummel gave the water use report. The water use report for March water was 76.0% with the monthly average at 76.1%. There were 25 customers on the May 12th, certified list.

On the April 7th, Certified list of 28 customers, all made payment or arrangements to make payment. The 25 customers on the May 12th, certified list, one customer was turned off, paid the reconnection fee and was turned back on. All the other customers made payment or arrangements to make payment.

The water use report for April water was 70.9% with the monthly average at 74.8%. On the June 9th certified list of 42 customers, all made payment or arrangements to make payment.

MANAGERS REPORT

Randy Hummel gave the Manager's report. All system meters have been read and adjustments made as needed. Maintenance tasks were noted and will be completed as needed. System water mains have been flushed. Areas around all valves and hydrants have been trimmed to allow an unobstructed view. Only one valve box was damaged over the winter months, which has been repaired. A leak was found and repaired at 200th and G Avenue, (the 6" x4" glue reducer had failed) and a new 6" valve was installed on the 6" main to the east.
