Notes from the NACD Annual Meeting -- Nebraska NRDs had 11 representatives attend the National Association of Conservation Districts Annual Meeting in Los Angles this week. Olin Sims of Wyoming was elected President replacing Bill Wilson of Oklahoma, who has served out his term.

Much of the conference was spent discussing the new farm bill and funding for current programs. The budget for existing programs reflects higher corn prices, which in turn impacted a decision by USDA to announce there would be no general sign-ups in 2007 and 2008 for CRP and CSP. However, budget proposals are laid out to service existing contracts.

Key programs affecting conservation district members and customers, program funding levels as proposed in the president's FY 2008 budget and comparisons to last year include:

- Conservation Operations: \$802 million, up from \$791 million in FY 2007.
- Environmental Quality Incentives Program: \$1 billion, down \$270 million from Farm Bill authorized levels.
- Conservation Security Program: Proposed spending cap of \$316 million, up from \$259 million in FY07.
- Conservation Reserve Program Technical Assistance: \$58 million, down from \$80 million.
- US Forest Service State and Private Forestry: \$202 million, down from \$228 million in FY07.
- Resource Conservation and Development: \$15 million, down from \$51 million last year.
- Watershed Programs: \$6 million, down from \$75 million.

At the NACD annual meeting this week, several Nebraska conservation programs and individuals were recognized as follows:

- The Upper Big Blue NRD was the overall winner of the Association of Equipment Manufacturers /NACD Excellence in Communications Award. The award was given to recognize their outstanding overall communications efforts on water management, in particular the "Fantastic Fun - River Run" exhibit. Scott Snell, Information Director for the UBBNRD, who developed the exhibit, accepted the award on behalf of the district.
- The Nemaha NRD received the District Excellence Award in Water Resources for their work on more than 350 watershed structures in their district.

- The Lower Platte South NRD received the Northern Plains Region Collaborative Conservation Award for their work on the Antelope Valley Project. This award is given to the district that works with other conservation partners on a project.
- Mike Mosel was recognized for his years of service on the NACD Board. Mike goes off the board this year after serving on the NACD Board since the early 1990's. Mike has served as chair of the Agriculture Land Resources and District Operations Committee.

EPA Grant for Environmental Assessments and Nutrient Management Plans at Livestock Operations -- A new Environmental Protection Agency (EPA) program will help livestock operators identify and respond to environmental management challenges. In February 2007, EPA will issue an open solicitation for an \$8 million grant to conduct voluntary comprehensive environmental assessments and to develop and review nutrient management plans for animal feeding operations (AFOs). The goal of this project is to offer confidential no-cost technical assistance to AFO operators nationwide that will help operators prevent water discharges and reduce air emissions by identifying and addressing environmental challenges. Nebraska Unicameral Committee Action

LB 488 – Income Tax Credit for Perpetual Conservation Easement Donations. Glenn Johnson, Manager of the Lower Platte South NRD, testified on behalf of NARD in support of LB 488, which provides an income tax credit for donated conservation easements. The bill targets areas designated as quick response water shortage areas in over appropriated basins and areas subject to interstate compacts, agreements, and decrees and on areas designated as biologically unique landscapes in the Nebraska Natural Legacy plan. Dan Smith, Middle Republican NRD Manager and Marlin Peterman, Papio-Missouri River NRD Assistant Manager, also testified in support of the bill. The committee took no action on the bill.

LB 20 – NRD Projects and Public Access. This bill increases public access to NRD water project properties and private lands. Hearing 2/14 Judiciary Committee, 1:30, Room 1113

Republican River Basin Plans Moving Forward – Representatives of the NRDs, Irrigation Districts, DNR, Attorney General's Office and other interested parties met in Cambridge on Thursday to discuss plans to keep Nebraska in compliance with the Republican River Compact. The group continues to make progress and appears to be on track toward finding a solution on the issue. The following are some conceptual changes that were discussed:

- Dry year leasing of surface water supplies Three surface water irrigation districts would consider leasing their water rather than diverting it from the Republican River. Leasing surface water provides a quicker stream flow improvement than through reductions in groundwater irrigation.
- Model Calculations The DNR staff will review the calculation of the credit Nebraska receives for mound water that seeps from the Platte to the Republican. This may be underestimated and could add about 8,000 acre-feet annually toward compact compliance.
- Additional Groundwater Use Reductions -- Additional reductions could be imposed, depending on the
 remaining shortage after the surface water leasing and other model corrections are calculated. The DNR
 will provide an estimate of additional reductions that may be necessary. In addition, methods would have
 to be developed to assure the gains from groundwater reductions will not be used by surface water users.
- Local Funding -- Other issues addressed were how to fund the local portion of any compliance activities
 in addition to the economic sacrifice already made by the local economies through reduced irrigation in
 the basin. The NRD representatives discussed both per acre fees and property taxes, but did not settle on
 one particular funding source.

Nebraska Unicameral Action

<u>Approved by the Governor</u> – The following bills received final approval from the Nebraska Legislature and have been approved by the Governor.

- LB79 Nebraska Litter Reduction and Recycling Act, Natural Resources Committee. The purpose of this bill is to eliminate obsolete language in the Nebraska Litter Reduction and Recycling Act that pertain to transfer of funds that have already occurred. The bill also eliminates duplicative reporting requirements concerning grant activities.
- LB 80 Safe Drinking Water Act Projects, Natural Resources Committee. Extends and defines the
 ability of NDEQ to use the Administrative Cash Fund of the Safe Drinking Water Revolving Fund for
 drinking water projects involving public water systems operated by political subdivisions up to and
 including 10,000 residents.

Sent to Final Reading

LB 313 - Engineering Requirements under the Livestock Waste Management Act, Natural Resources
Committee. State senators sent LB 313 to Final Reading this week. The bill clarifies that livestock operations

required to obtain a National Pollutant Discharge Elimination System permit and large livestock operations as defined in federal requirements are subject to the requirements of the Engineers and Architects Regulation Act. Small and medium size operations not required to obtain a National Pollutant Discharge Elimination System permit would be exempt from the Engineers and Architects Regulation Act.

Passed over on Select File

• LB 291 – Change membership on the Nebraska Environmental Trust Board — Senators decided to pass over a bill that would change the membership on the Nebraska Environmental Trust Board. The measure would eliminate the representation by congressional district and set districts similar to the boundaries of the Nebraska Game and Parks Commission. Two pending amendments resulted in the action by the bills sponsor, Senator Tom Hansen from North Platte, to pass over the bill rather than drag out debate. One amendment offered would make the agency directors that sit on the trust board ex officio, nonvoting members. The second amendment would strike the enacting clause. State senators and interested parties will try to work out the concerns with the amendments before the bill comes up for Select File debate again.

Committee Action

Recreational Liability Issues -- Glenn Johnson, Manager of the Lower Platte South NRD, testified on behalf of NARD in support of LB 564 & 566, which adds political subdivisions to those who receive recreational liability protection if they do not charge the public for access. The bills are response to a Nebraska Supreme Court decision striking down recreational liability protection for political subdivisions and were supported by communities and recreation interest across the state. The attorney that prevailed in the Supreme Court case and a representative of the Nebraska Trial Attorneys Association testified against the bills.

Members of the Judiciary Committee raised several concerns about providing blanket liability protection and not inspecting property and equipment on a timely basis. An amendment is being discussed to add some protection for recreational property against claims for injuries, death, or property damages from the inherent risk of recreational activities. These activities would be hunting, fishing, swimming, boating, camping, picnicking, hiking, nature study, waterskiing, winter sports, use of playground equipment, biking, roller blading, skate boarding, golfing, athletic contests, visiting, viewing, or enjoying historical, archaeological, scenic or scientific sites and similar leisure activities. No action has been taken by the committee.

LB 20 – NRD Projects and Public Access. Marlin Peterman, Papio-Missouri River NRD Assistant Manager, testified on behalf of NARD in opposition to LB 20, which increases public access to private property when NRD cost share is used. The bill changes the threshold from 20% public funds to 5% of the total cost of a project. Former Senator Curt Bromm testified in support of the bill on behalf of the Papio Valley Preservation Association, a group that opposes flood control projects.

- LB272 NRD Bonding Authority. This bill adds a three cent levy per one-hundred dollars of taxable valuation which is then appropriated by the NRD Board of Directors to issue bonds to pay for flood and reservoir structures Hearing 2/22 Revenue Committee, 1:30, Room 1524
- LB322 Establishment of Water Resources Cash Fund and Other Funds. This bill creates a fun designed to aid natural resource districts that are deemed over-appropriated. Hearing 2/20, Appropriations Committee, 1:30, Room 1524
- LB362 Interlocal Agreements. Removes from budget limit allowable exemptions, restricted funds budgeted under an interlocal cooperative agreement. Makes interlocal agreements subject to tax limits. Hearing 2/22, Revenue Committee, Room 1524
- LB503 Change NRD Board Vacancy Appointments. The bill eliminates the provision that appointments for vacancies of NRD directors fill the unexpired term. Hearing 2/22, Natural Resources Committee, Room 1525

Update on the Republican Basin Meeting -- Representatives of the NRDs, irrigation districts, DNR and the Nebraska Attorney General's Office met in Cambridge on Thursday to further refine plans to bring the Republican River Basin in compliance with the compact. The parties continue to move forward in developing plans and programs for the basin. All targets would be based on a moderate drought scenario and subsequent management changes in place achieve balance between allocation and consumptive use within 5 years. If average or above average moisture in the basin occurs, the districts would be in compliance much faster.

Several items were agreed upon as follows:

- Consensus on short-term funding Extend the current additional levy authority of 3 cents/\$100 valuation for at least 5 years. Also, seek authority for addition levy or fees to provide local matching dollars to fund water programs. If fees are imposed there should be a cap of no more than 1% of the total district valuation collected. Request a 80-20 state match for the next 5 years.
- Engage in water management activities that meet the goals of IMPs, including: 1) Augment water supplies; 2) Reductions of water uses; 3) Managing vegetation in the channel and riparian areas; and 4) Surface water leasing. Further reductions in groundwater allocations in varying amounts depending on how much would be needed after all the benefits of the other management options are considered. Compensation would be considered to those water areas subject to greater regulation.

Republican Basin Flows Increase – The Department of Natural Resources reported that 3,300 AF was added to Harry Strunk Reservoir and 6,300 AF added to Harlan County for a total of 9600 AF this week. The department estimates that these totals may more than double between now and the end of the month. Swanson, Hugh Butler, and Enders have not benefited very much from this recent snowmelt. However, there is some extra inflow going into Lovewell Reservoir. The Department did measure 1,500 cfs at Muddy Creek at Arapahoe on Thursday. ON the USGS web site, it looks like flows were about 1000 cfs at Orleans and about 200 cfs at Sappa Creek near Stamford. There are reports of some small ice jams but it doesn't appear to be much of a problem at this time.

Upper Big Blue NRD Outlines Irrigated Acre Policy - A total of 802,784 acres are included for certification in the Upper Big Blue NRD as of February 22, 2007. This represents approximately 70% of the total irrigated acres shown on the county assessors' records. All groundwater users must report information related to their groundwater uses by March 1, 2007 as a result of the District Average Ground Water Level Reporting Trigger becoming activated. The policy entails:

- A 1978 decision to protect future generations from drought. Officials gathered to determine how to protect the ground water from falling to low. They set up a standard each spring. Once the water level falls 2.48 feet below that standard, then the District begins the allocation process. The Upper Big Blue also has a goal to not let the ground water level fall below what it was in 1978.
- Enforcement actions. In 2004, the Upper Big Blue changed a stipulation in their plan. They now require that once the water level reaches the point of allocation (2.48 feet below set standard), each producer of the water must install flow meters on all existing wells. In addition, all new and replacement wells are required to have flow meters installed.

Nebraska Unicameral Floor Action

• LB 333 - Private Onsite Wastewater System Contractors Certification and System Registration Act, Johnson. This bill makes a number of provisions, including clarification of the requirement of employing a certified professional for the abandonment of an onsite system and the issuance of permits and requirements necessary for operation and maintenance. The bill was sent to Final Reading.

Committee Action

- LB362 Interlocal Agreements. The Nebraska Association of Resources Districts, submitted testimony on behalf of Nebraska's Resources Districts in opposition to LB362, which restrict interlocal agreements to spending and levy limitations. Other political subdivisions also testified or submitted testimony in opposition. Although the bill is designed to limit interlocal agreements, it is not specifically targeted at the NRD's. The main issue brought forth is interlocal agreements between schools and utility suppliers to circumvent levy limits. Senator Ron Raikes of Lincoln sponsors the bill. The committee took no action on the bill.
- LB503 Change NRD board vacancy appointments. Curt Friesen, Chairman of the Upper Big Blue NRD, testified on behalf of the Nebraska Association of Resources Districts in opposition to LB503. This bill proposes to change procedures for filling a NRD Board vacancy. The bill would require any director appointed within the first 19 months of a term file for election for the remaining two years of the term. The bill was brought to the Legislature at the request of Curt Bromm and the Papio Valley Preservation Association. sponsored by Senator Mick Mines of Blair. The committee took no action on the bill.
- LB 272 NRD General Obligation Bond Authority. John Winkler, Papio Missouri NRD Manager, testified in support of LB 272 on behalf of the Nebraska Association of Resources Districts. The bill allows NRDs in a metropolitan area (PMRNRD) to use general obligation bonds to pay for flood control and stormwater projects. An amendment was offered by provided Senator Gail Kopplin of Gretna, the sponsor of the bill, to remove the additional 3 cent levy authority to pay for the bonds. Under the amendment, the district would be authorized to use existing taxing authority to pay for the bonds. Jim Thompson, PMRNRF Board Chairman, also testified in support of the bill. Several residents of Washington County and the Papio Valley Preservation Association.

Nebraska Unicameral Committee Hearings Next Week - All Hearings begin at 1:30 pm.

LB387 – Require Water Meters on New Construction. This bill would require that all new residential construction be equipped with plumbing that separates inside water usage from outside water usage. It is designed to monitor each independently. Hearing 2/27, Urban Affairs Committee, 1:30, Room 1510

LB477 – Change Insurance Requirements. This bill would lower health insurance benefits for state employees. It also expresses that if political subdivisions do not follow suit they may face a reduction in state aid. Hearing 2/28, Government Committee, 1:30, Room 1507

LB701 – Create a Basin-wide Management Authority and Committee. This bill would create a basin management administration for all basins bound by an interstate compact. Water users in the basin would be regulated by this administration. Hearing 2/28, Natural Resources Committee, 1:30, Room 1525

LB493 – Change requirements of the Water Policy Task Force. This bill reduces meeting times of the Water Policy Task Force to one per year. At that meeting it would be required to review research provided by the University of Nebraska. Hearing 3/1, Natural Resources Committee, 1:30, Room 1525

LR 11CA -- Reduce Funding to the NETF and create a new Crime Fund. A constitutional amendment to reduce the distribution of state lottery proceeds to the Nebraska Environmental Trust from 44.5% to 41.5% and transfer the funds to a new Crime Fund. Committee Action this Week

LB458 – Integrated Management Plans and Removing Vegetation from Riparian Areas. Jasper Fanning (Upper Republican NRD Manager), Dan Smith (Middle Republican NRD Manager), Nelson Trambly (Lower Republican NRD Board member) and John Thorburn (Tri-Basin NRD Manager) testified in support of LB 458 this week. Senator Carlson, the sponsor of the bill, offered an amendment to create a Task Force to work with the Department of Agriculture and Department of Natural Resources to develop and finance vegetation removal plans for the Platte and Republican River Basins.

The NRD representatives from the Republican River Basin took the opportunity to outline the latest plans for water management in the basin. Ann Bleed, DNR Director, followed in a neutral capacity, to outline some of the plan. The following are parts of the testimony from the NRDs

- The solution to Nebraska's short- and long-term water problems will take a multi-pronged approach that involves both reducing water use as well as raising the dollars required to make the appropriate changes.
- Shutting off groundwater irrigation alone will not keep Nebraska in compliance with the Republican River settlement. However, allocations on groundwater users will keep the Nebraska in compliance for the long-term.
- The short-term portion of the plan must then allow us to deal with the drought periods and lower allocations under the compact. Thus, we must do the things that will increase our allocation or reduce our use of streamflow in an immediate time frame. Surface water leases or buyouts and vegetation management are two of those components of the plan.
- Extending the 3 cent levy authority passed last year will help raise funds locally. Additional levy authority and or
 fee authority will be necessary to provide additional local finance needs. The State of Nebraska needs to match
 these funds to share the commitment to keep Nebraska in compliance.

The committee took no action on the bill. However, the committee will be working with interested parties to develop statutory changes to address the needs of the NRDs and the State of Nebraska in the Republican River Basin.

LB701 – Creates a Basin-Wide Management Authority & Committee. Several members of Water Claim testified in support of LB 701, a bill drafted by Water Claim to address issues in the Republican Basin. The original copy of the bill would allow for transfers of water from other basins to address the situation in the Republican Basin and set up another layer of government between the State of Nebraska and the NRDs to develop management plans for the Basin. An amendment was offered to the bill to place allocations in statutes rather than allowing local NRDs to set allocations based upon compact compliance needs. The bill was opposed by several agriculture organizations and individuals. Several other interested parties expressed concerns with the bill in a neutral capacity. The committee took no action on the bill.

LB477 – Change insurance requirements. Senator John Wightman presented a bill to the Government Committee this week which would move current state employee health insurance from its current 79% employer, 21% employee contribution breakdown to 75% employer, 25% employee in one-year increments through July 1, 2011. The bill also expresses legislative intent that political subdivisions receiving state aid should contribute in a comparable amount; if not,

the subdivision could face a reduction in state aid. There were no supporters of the bill, but over a dozen opponents. The Government Committee took no action on the bill. Senator Wightman mentioned he may just do an interim study on the issue rather than trying to get the bill advanced this year.

LB 503 -- Change NRD Board Vacancy Appointments. This bill was indefinitely postponed this week by the Natural Resources Committee. The bill would have eliminated the provision that appointments for vacancies of NRD directors fill the unexpired term. The new provisions would require that if a vacancy occurs on or after August 1 in an even-numbered year, the appointee shall serve for the remainder of the unexpired term. If the vacancy were to occur at any other time, the appointee shall serve until the first Tuesday following the first Monday in January following the next regular general election and at the next regular general election a member of the board shall be elected to serve the unexpired term. Senator Mick Mines introduced the bill on behalf of the Papio Valley Preservation Association.

Nebraska Unicameral Floor Action

LB 295 – Irrigation and Water Wells, Natural Resources Committee. The legislature debated and advanced LB 295 to Select File this week. This bill makes a number of changes at the request of the Nebraska Department of Natural Resources, including:

- Adds U.S. Bureau of Reclamation on the list of entities which may have appropriations terminated for nonuse.
- Clarifies that no person shall use a water well for purposes other than its registered purpose until the water well registration has been changed to the intended new use.
- Provides an exception so that a person may use a water well registered for purposes other than its intended purpose for a de minimis use for livestock, monitoring, observation, or any other nonconsumptive use approved by the applicable natural resources district.

LB 313 – Engineering Requirements under the Livestock Waste Management Act, Natural Resources Committee. The bill clarifies that livestock operations required to obtain a National Pollutant Discharge Elimination System permit and large livestock operations as defined in federal requirements are subject to the requirements of the Engineers and Architects Regulation Act. Small and medium size operations not required to obtain a National Pollutant Discharge Elimination System permit would be exempt from the Engineers and Architects Regulation Act. This bill was passed by the legislature and presented to the governor on March 1st.

LB 333 – Private Onsite Wastewater System Contractors Certification and System Registration Act, Johnson. This bill makes a number of provisions, including clarification of the requirement of employing a certified professional for the abandonment of an onsite system and the issuance of permits and requirements necessary for operation and maintenance. This bill was passed by the legislature and presented to the governor on March 1st.

LB568 – Extend Scrap Tire Program. As amended on the floor this week, the bill extends the grant program for recycling tire under the Waste Reduction and Recycling Incentive Fund from June 30, 2007 to June 30, 2009, rather than to 2012. Pending AM210 would allow grant money to support public and private firms to conduct research to determine the amount of litter in various areas. This bill was advanced to Select File on March 1, 2007.

Nebraska Unicameral Committee Hearings Next Week – All Hearings begin at 1:30 pm.

LB493 – Change requirements of the Water Policy Task Force. This bill reduces meeting times of the Water Policy Task Force to one per year and requires the WPTF to review research provided by the University of Nebraska. Rescheduled to 3/8/07, Natural Resources Committee, Room 1525

Fixing levees isn't easy or cheap

Communities have a year to make repairs; first they need to find money

Communities responsible for maintaining levees publicly identified as substandard by the federal government are racing to fix problems caused by years of neglect.

One obstacle might prove more formidable than the levees themselves: money.

The Army Corps of Engineers identified 122 levees on Thursday that it said posed an unac-ceptable risk of failing in a flood. Although a few of the levees protect major cities such as Albuquerque and Sacramento, many guard sparsely populated areas and have been overgrown with trees and brush that could weaken them.

The levees were identified by a corps inspection program that intensified after Hurricane Katrina overwhelmed Gulf Coast levees in August 2005.


The corps has given the communities a year to make repairs. That deadline has left levee owners — primarily local governments for whom the corps built the levees - scrambling for the money to get the job done. For some, the challenge is significant.

Cost is large, but time short

In tiny Lincoln, N.H., floodwaters dug gaps between some of a levee's granite blocks in 1995. "It's not like it's going to all down tomorrow," town nanager Ted Sutton said. Even io, he estimated repairs will ost \$500,000 to \$1 million.

Sutton said he's frustrated by he corps' deadline. The town has three months to produce a epair plan and one year to fix he levee, which protects about 30 homes and businesses. The evee is currently covered by now and ice. "They're denanding we give them a plan in he middle of winter. I don't hink so," he said. "It's frozen ind under snow."


South of Sacramento: A levee under repair in October, California voters have approved borrowing money for flood control, but other places with substandard levees are scrambling to fund the work

also will prove financially difficult, he said. "It took us 10 years to save enough money to build a new town hall, and that only cost between \$250,000 to \$300,000," he said. "We have no way of paying for something like that. It's just impossible."

Maj. Gen. Don Riley, director of civil works for the corps, acknowledged that many communities face a challenge to find the money for repairs.

"Some communities have more challenges than others when it comes to the funding," he said. Communities will have to "look within their own local community, then look to the state, then possibly look to their congressional delegation" for fi-nancial assistance. "It will be a

community responsibility to seek the proper funding source for any help they need.

Operators acknowledge that many of the problems stem from lax maintenance.

In Brownstown Township. Mich., south of Detroit, "there hasn't been any ongoing maintenance program" for levees protecting two islands in Lake Erie, public works director Mark Gahry said. Fixing them will cost about \$60,000, he said.

In Macon, Ga., a mile-long levee that protects a water treatment plant was considered substandard by the corps because of trees and brush that have sprouted from it for years. Corps spokesman Billy Birdwell said the flora could weaken the levee. "Many of these items are considered routine maintenance," he said.

Macon's mayor, C. Jack Ellis. ordered city employees who operate the levee not to discuss it—or the cost of fixing it, said his spokesman, Ron Wildman.

All 37 levees around Sacramento were included on the corps' list. Last year, California voters approved a plan to bor-row \$5 billion for flood-control improvements, which would pay for levee repairs. Jay Punia, the general manager of California's State Reclamation Board, said many local managers don't

have enough money to keep up with repairs.

Also on the list are two earthen dikes along the Rio Grande in Albuquerque. The concerns there are vegetation and maintenance of drains, not structural problems, said Dennis Domrzalski of the Middle Rio Grande Conservation District, which manages the levees.

"They're talking about maintenance things like rodents digging holes in them, vegetation, roots from trees getting in, and whether there's enough space between the levee and the bosque," the riverside forest where cottonwoods and other trees grow, he said:

Replacing the berms, which are 12-14 feet high and 16 feet wide, would cost "\$50 million and above," he said. He said he doesn't believe the levee ever will fail. That's because it would take a volume of water five times greater than any the city has seen in more than 25 years. he said.

Complicated problems

Even when the problems are small, fixing them can be frustratingly complex.

In Erie Township, Mich., outside Detroit, a quarter-mile levee built after Lake Erie flooded in the 1970s is overgrown with brush and has been undermined by groundhogs.

Township officials say they wanted to fix the dike, which protects about six homes, but couldn't because it's inside the security fence around a nuclear power plant, and they don't

have access to it. The plant agreed to let workers in after the corps threatened to decertify the levee, town su-pervisor William Frey said. They've started trimming the brush and plan to lure out the groundhogs and fill their tunnels with cement, he said.

In other places, environmental rules have complicated efforts to clear brush, especially in places where vegetation has grown for a long time, Riley said: "There are some trees that are (being) found to house endangered species. So it's not a simple matter of just removing the tree."

Some areas lack funds for repairs

WASHINGTON — Bowing to demands from news organizations, the Army Corps of Engineers revealed the locations Thursday of 122 levees nationwide that are so poorly maintained they could fail in a major flood.

Some of the substandard levees protect densely populated areas, such as Springfield, Mass., Albu-querque and Sacramento. Many others are in rural areas, where they shield valuable farmland but relatively few people.

Maj. Gen. Don Riley, director of civil works for the corps, said he does not know how many people live near the levees or what the required repairs might cost. He said communities have one year to fix the problems.

If a levee's deficiencies are not corrected, people living nearby might have to buy flood insurance.

Some local officials said they need more time to find ways to pay for the repairs, which typically cost millions of dollars.

'A year may be too short for folks to respond and to have the re-sources to respond," said Susan Gilson, who heads the National Association of Flood & Stormwater Management Agencies, which represents local levee operators.

In many cases, the levees were built by the corps and turned over to local communities, which are responsible for maintenance. In those cases; Gilson said, "there should be a commitment at the federal level to share costs.'

Some local officials first learned of the problems this week, after

USA TODAY reported Monday that the corps had found 146 levees with problems so severe that floods could overwhelm them. The corps, which inspects about 2,000 levees nationally, refused at that time to list the specific levees.
USA TODAY and the Associated

Press then requested the list under the Freedom of Information Act.

Riley said the corps wanted to wait to release the list until it finished notifying all communities responsible for maintaining those lev-ees. He noted that 24 levees were dropped from the earlier count because some communities have corrected the problems. He said that the corps "will likely find more (levees) that are deficient" when additional inspections and reviews are done in the coming months.

Most of the levee problems found by the corps stemmed from tree and brush growth, animal bur-rows and erosion, Riley said. "What we're doing at this point is

making sure the maintenance requirements are met and having meetings with the levee owners to make sure they understand what they need to do," Riley said.

If the levees aren't fixed:

▶ The corps could remove the levees from its inspection and rehabilitation program. That means the communities that own the levees would be ineligible for federal assistance to repair any damage the levees might suffer in a major flood.

► The Federal Emergency Management Agency could decide not to consider the levees adequate flood controls. Properties behind those levees would then be deemed high risks for flooding, and owners could be required to buy flood insurance policies costing hundreds of dollars a year or more. 2/2/2) USA TORE,

Flooding was 'government-designed disaster'

I was thrilled to read USA TODAY's article "146 U.S. levees may fail in flood." So many Americans have Katrina fatigue and blame the victims for their predicament when the flooding was a government-designed disaster (News, Monday).

Maintenance of our levees was but one problem. There were underlying structural problems that led to the failure, not maintenance — and that should be more frightening to anyone living within reach of a levee system the U.S. Army Corps of Engineers designed.

The corps ignored its own studies that predicted failure of the levees in New Orleans. One study found the rate of subsidence to be greater than that used in designing the levees, so the levees were built lower than they should have been.

The second study found in some places the sediment on which the levees were built would slip when saturated. The corps admitted these and other flaws in a 6,000 page report.

Their negligence has cost us lives, homes, livelihoods and perhaps a culture; and it can happen to you, far from the Gulf

Ice concerns rise on Platte River

Thickening ice on the Platte River has officials keeping a wary eye on the situation.

Marlin Petermann, assistant general manager of the Papio-Missouri River Natural Resources District, said the ice near Valley ranged from 10 inches to 15.5 inches thick and averaged 13.3 inches when it was measured Tuesday.

Snow cover feeds water to the river when melting occurs, and the low temperatures will lead to thicker ice.

The key concern is rapid warming, Petermann said. If the ice breaks up in large chunks instead of melting gradually, the chunks can back up and cause water to spill out into the valley.

Battle to control Niobrara

Irrigators fight water agencies over call to suspend permits

VALENTINE, Neb. - Irrigation farming threatens to sap the Nio-brara River, the state's premier canoeing stream, say state and federal agencies.

The National Park Service and the Nebraska Game and Parks Commission are asking local and state water managers to temporarily stop issuing permits for new irrigation across hundreds of miles of northern Ne-

"We perceive a rush to grab water," said Tyler Cole, a Park Service hydrologist in O'Neill.

Some irrigators in this region of cowboys and canoes, however, are skeptical of the need for an irrigation timeout and suspicious of the agencies' motives.

"They want control of this river," saidrancher Jack Bond of Kilgore. The Park Service manages a

71-mile stretch of the Niebrara east Valentine as a national scenic river and is charged with protecting its natural wonders.

The area is the biological cross-roads of the continent. Feeding the river are hundreds of waterfalls and thousands of springs seeping water from the Sand Hills.

The Niobrara attracts about 60,000 visitors a year and is credited with

supporting more than 100 local jobs.

Canoe outfitters are concerned about falling flows in the Niobrara. Rocks and sandbars that weren't exposed until July in past years are now

revealed in May and June, said

Twyla Graham of Valentine.
"We realize there's a drought," she said, "but irrigation's got to be part of the cause."

Graham said falling levels of upderground water and river water could harm the valley's unique ecosystem.

Cole said a cursory examination of Niobrara hydrology records shows a downward trend in river flows and an upward trend in farm applications See Niobrara: Page 2

to take water from the river. State records show 629 ac-

tive or pending diversions of Niobrara water in Nebraska, nearly all for agricultural purposes. More permits have been issued to divert Niobrara water so far this decade than during all of the 1990s, Colesaid.

Bond has active or pending permits to draw 32 cubic feet per second—or 14,362 gallons per minute—from the river. That's the equivalent of 9 percent of last-year's season-low flow on July 31.

The state and federal agencies have pitched their plan to the Middle and Lower Niobrara Natural Resources Districts, along the river's central and eastern stretches. A meeting with the Upper Niobrara-White NRD in northwestern Nebraska is scheduled next month.

Ann Bleed, director of the Nebraska Natural Resources Department, plans to meet next month with the three NRDs to begin talks on their visions of the river's future.

The goal is to help prevent further declines in the Niobrara until the Nebraska Game and Parks Commission applies for a right to protect a certain amount of the stream flow for recreation, fish and wildlife. The commission wants time to study how much water it would ask to preserve.

Under the plan, the Middle and Lower Niobrara NRDs would impose temporary moratoriums on new groundwater irrigation wells. The Upper Niobrara-White NRD already has a moratorium.

The bans would let the Department of Natural Resources impose a similar halt on farm permits to pump water from the Niobrara.

Cole said warnings of what could happen to the Niobrara can be seen in the trickling flows and dry summer streambeds of the Platte and Republican Rivers.

"It is naive to believe that water resources in this basin are any less threatened," he told the Lower Niobrara NRD board last week.

Larry Hutchinson of Lincoln, water resources manager for the Nebraska Game and Parks Commission, said state officials are worried that farmers frustrated with water limitations and drought in other areas of the state will start buying land in the water-rich Niobrara basin to develop irrigation.

Bond, whose operation spans the Njobrara southwest of Valentine, moved from the Republican River basin in the mid-1990s.

"It is naive to believe that water resources



in this basin are any less threatened (than the Platte and Republican

River basins).

He has state-issued permits to take water from the Niobrara upstream from the scenic river stretch of the stream. Bond pumps water to center-pivot sprinklers on the tableland above the rugged river valley to irrigate rye and millet to feed his cattle herd during winter.

A moratorium isn't necessary, Bond said, because farmers have already developed land near the river, the most suitable for irrigating. Canyons and hills rimming the river prevent wide use of irrigation.

"The terrain here dictates how much water you'll take out of the river," he said. "It governs itself."

Hutchinson said the concern isn't only how much water any individual irrigator diverts from the Niobrara upstream from its federally protected stretch.

"It's cumulative. Nine percent of the flow isn't a small amount. If that doubles, all of a sudden it could be critical," he said

Tom Higgins of Newport, a member of the Lower Niobrara NRD board, said he doesn't disagree with the stewardship message behind the agencies' proposal but he doesn't like the idea of preventing irrigation.

Higgins also said the agencies used sketchy data to make educated guesses.

"You don't need a moratorium on the whole river while you make your guess," he said.

Rancher Jerry Adamson of Valentine, a Cherry County commissioner, said the Niobrara basin shouldn't be compared with the troubled Platte and Republican Rivers.


Hutchinson said Nebraskans have an opportunity to protect the Niobrara in ways not possible for the Platte or Republican.

"We never had a chance on the Republican before it was fully allocated for irrigation, and then groundwater (irrigation) development affected flows," he said, "and the Platte was pretty well appropriated long ago.

"The Niobrara is still a viable river."

Protections sought for rural areas

■ Developers would face stricter land-use regulations in a Douglas County proposal.

Nature would be treated with a gentler hand when some of the remaining rural areas of Douglas County are developed, under policies up for approval by the county.

The county is proposing to require that developers minimize disturbance of the natural contours of the land and protect unique features, a practice known as conservation design.

Additionally, the county would require more natural dissipation of storm water through greater use of filtration and less reliance on storm sewers.

The Douglas County Planning Commission last week recommended that the County Board approve the regulations. A public hearing will be held at the Feb. 27 County Board meeting, and the board could vote on the policies that day.

Kent Holm, director of Douglas County Environmental Services, said the changes create the opportunity for "some unique living environments."

Natural prairies, wetlands, hillsides and wooded areas would more likely be preserved under

these new rules, he said.

And though it is difficult to generalize, Holm said, homes typically would be clustered together, with less space between houses and potentially smaller front yards.

But neighborhoods would have more green space held in common. Open areas would be consolidated and could be used as parkland or buffers alongside creeks.

The regulations will require that at least 30 percent of a development be set aside as green space, he said.

Property values should benefit, said Amy Haase, a planner with RDG Planning and Design, the Omaha-based consulting group that helped the county develop the regulations.

"Studies have shown that conservation-designed subdivisions sell better and appreciate at a better rate," Haase said.

The proposed rules would apply to the approximately 20 percent of Douglas County that is subject to county authority.

Holm said developers, utilities and governments should see de-

creased costs in the affected area, because clustered development results in fewer miles of sewers, natural gas pipes and water mains.

Jerry Slusky, a real estate attorney, said the changes will mean additional but acceptable design hoops for developers.

"It makes all the sense in the world," Slusky said. "Instead of just doing a grading plan that's best for developers, you balance out what is best for the environment, and that's a good test."

The City of Omaha also clusters developments in rural areas,

but one of the ways in which Douglas County takes its policies further is requiring that companion open space remain permanently open, Holm said

An underlying goal of the regulations is to reduce storm-water runoff and water pollution.

The regulations require developers to find the best way possible to reduce runoff from a site. Urban runoff is one of the final major sources of water pollution that the federal government has been pushing metropolitan areas to control.

As a result, the regulations may spur more use of such things

as rain barrels, rain gardens and rooftop gardens.

"Had these practices been in place years ago, we would not have near as many problems with storm water that we do today," said Clare Duda, a board member.

He said the county continues to meet with Washington County officials to come up with additional storm water policies that provide an alternative to the plan being pushed by the Papio-Missouri River Natural Resources District and area cities. That NRD-led plan relies heavily on dams to catch storm runoff.

Ice, rainy forecast raise flooding fears near Elkhorn, Platte Rivers

Predicted heavy rain and thunderstorms could make for a long weekend of watching and waiting along some Nebraska

The National Weather Service issued flood warnings in Platte and Buffalo Counties earlier this week.

In Sarpy County, emergency management personnel and County Board members are meeting today to discuss plans in the event of flooding along the Elkhorn and Platte Rivers.

"We hope nothing is going to happen, but we want to be ready," said Lt. Russ Zeeb of the Sarpy County Sheriff's Office. "We are going to make a flyover

to get the freshest information possible before the meeting."

Tim Hofbauer, the emergency management director for Platte County, said ice jams along the Loup River upstream from Columbus have caused some lowland flooding.

Darrin Lewis, the emergency management director for Buffalo County, said ice jams on the Platte River don't seem to be causing any problems near Kearney - yet.

Rain Saturday could turn to snow Sunday, with temperatures dropping from the high 30s early in the day Sunday to low 30s later in the day, said Tony Zartman of AccuWeather, The World-Herald's weather consultant.

A mix of snow and rain is

likely just north and west of Omaha, And southeastern Nebraska and southwestern Iowa could see thunderstorms Friday night and Saturday.

Joyce Schram, whose family farms along the Platte River in Sarpy County, said she remembers the wide-spread flooding that occurred in 1966, 1978 and 1993.

"From my perspective, the worst scenario would be thunderstorms bringing an inch or two of rain before the ice (on the Platte) gets a chance to break up," she said. "If it rains and there's still a lot of ice, that's like raining on cement. It will just run off into the valley.'
