As approved by the Board in February, the District re-advertised the Mopac Equestrian Trail Project with the bid opening on March 2, 2007. The scope of the project was reduced to include the trailhead parking lot, bridge approach railings, extension of one culvert, and fencing north of Buffalo Road.

Five contractors, plus three fencing contractors, obtained plans for the project (see attached list), of which two attended a site showing on February 23, 2007 (Camden and ASW). Only one bid was received from Camden Excavating from Blair, Nebraska in the amount of \$49,392.48. The engineers estimate is \$41,531.

Based on this bid, the breakdown of costs, including in-kind contributions for clearing, is as follows:

Game and Parks Commission	\$39,514
Mopac Horse Council	6,939 (Cash and in-kind)
NRD	<u>6,939</u> (Cash and in-kind)
	\$53,392

Management has reviewed the bid with the Mopac Horse Council and received their verbal approval. It is recommended that the bid be accepted.

- **It is recommended that the Subcommittee recommend to the board that the General Manager be authorized to execute a construction contract in the amount of \$49,392.48 with Camden Excavating for the Mopac Equestrian Trail Project, subject to approval by the Nebraska Game and Parks Commission.**
